### 3. Why did Batu so long for the "last sea"?



Let's start with the latest news:

The Tatar-Mongol yoke will disappear from the new history textbook.

On the website of the "**Russian Historical Society**" (RHS), a document has appeared that can seriously change the teaching of history in schools. The project of a single history textbook, for all its political correctness, caused a storm of politically incorrect emotions.

The so-called historical and cultural standard, on the basis of which a new unified textbook of the country's history will be written, is on display for everyone. According to the plan, it should tell about the most significant events — from ancient Russia to the present day.

**They suggest forgetting about the Tatar-Mongol yoke.** In the new unified history textbook, most likely, there will be no such term. Instead, a longer one will appear — "**the system of dependence of Russian lands on the Khans Horde**". Historians of Tatarstan and personally Vice-President of the Academy of Sciences Raphael Khakimov strongly suggested abandoning the usual "Tatar-Mongol yoke". He said that in Kazan "**the Golden Horde is considered an empire, and Genghis Khan is not a conqueror, but a reformer**", and this must be somehow considered.

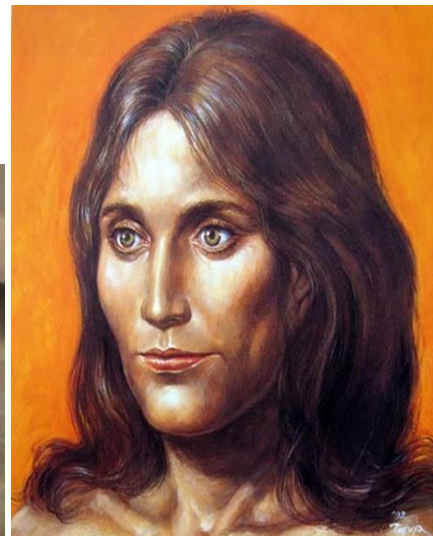
The situation was taken into account. Henceforth it is not a yoke, but "**a system of dependence of Russian lands on the Khans Horde**".

Which really **looks velvety and politically correct**, although many 13th-century Russians would probably be astonished and abusively disagree.

Would Rafael Khakimov and other academic scholars have had time to consult specific sources?

**The name "Golden Horde,"** as Wikipedia and other sources indicate, **"was first used in Russia in 1566<sup>[1]</sup> in the historical-publicist work Kazan History, when the state itself no longer existed. Until that time, all Russian sources used the word "Horde" without the adjective "golden". Since the 19th century the term has become firmly established in historiography and is used to refer to the ulus Dzhuchi as a whole, or (depending on the context) to its western part with its capital in Sarai<sup>[2]</sup>.**

Strange as it turns out: **the name of a huge state is denoted retrospectively for several centuries!** But everything rises clearly into place if you turn to the Slavic-Aryan sources, according to which the hordes of the Dzungars (**yellow** horde from the areas of northwestern China) invaded Siberia and the southern Urals, destroyed the ancient capital of the Slavic-Aryan Empire **Asgard-Irian in 1530** and advanced significantly westward, right up to the Volga.



It is no coincidence that Miller in his works mentions white Kalmyks and yellow Kalmyks (who originated just from Dzungars). And then this **"yellow"** horde was renamed "golden" because of the **yellow-golden** tents. It was only after that, in 1566, that the name **"Golden Horde"** was first used. And now try to answer the question: **what does Batyi (Batu), who was the head of the ulus Dzhuchi (and he allegedly is the "Golden Horde", let alone Genghis Khan) have to do with "Golden Horde" 300 years later?**

And yet he does, but in a different sense, related to the attempt to vilify him.

Let's pay attention to the Face of the grandson of Khan Temir, the blue-eyed, light-bearded Kirghiz, Turk, Mongol and ethnic Rusich White Tsar Batu:

Kirghiz - as belonging to the Slavic-Aryan military class of cattle breeders; Turk - as a mountaineer; Mongal - as a descendant of immigrants from the Mongal skete on Tartarus; and a white man by blood. Tsar Batu minted his coins with the Sign of the Trident-the heraldry of the Mongolian Family of Temir, as well as the Sign of the Rurik Family, as well as the coat of arms of Ukraine today.

The dates 1227-1502 mark the period of the Horde's existence, which ended with the Sefid Semites seizing power in Persia. So, the Horde, to which Batu was related, existed until **1502**. And the "Golden Horde", the foundation of which they try to attribute to Batu in the sources, **appears only in 1566**.

What conclusions do we draw?

The appearance of the new history of the "Golden Horde" at the forefront is the beginning **of a project for energy-informational transmission** within the framework of the Pyramid of Knowledge (the same 500 year – old One-after 1502 and 1530, when Asgard-Irian was destroyed) **to distort the Vedic worldview**, which was constantly generated from the

swampy regions of Siberia and the Far East (the same hidden intervention of the CPS).

The worldview of the "Golden Horde" was already based on Islam, Christianity and paganism (shamanism). Batu Khan, as the alleged "founder" of this "empire", and then his sons, began to be portrayed as "godless", rushing between these three cults. Although Vedic education already provided for respect for other people's faith.

In this regard, it is very interesting whether the Russian Historical Society will finally show **velvety and political correctness** to the interpretation of the personality of Batu himself, made by M. V. Lomonosov himself. Here is a small document called "Plan of Russian history" (1751) Mikhail Lomonosov, which I took from the collection "Notes on Russian History", published in 2011 for his 300th anniversary (I did not specifically remove the brackets in the text, as it is given in the text) :

**So, Batu is mentioned here by Lomonosov as one of the iconic rulers (autocrats) of Russia**, and there is no mention of the Tatar-Mongol yoke, nor of the "Golden Horde", which was allegedly founded by Batu. I can imagine how many **connoisseurs will appear after this, ready to comment on what exactly Lomonosov meant in this regard**. Here, in the Notes to the "Plan of the Russian History" on p. 406, the authors of the collection, with reference to Bilyarsky, have attempted to edit this document somewhat, based on the fact that when Lomonosov submitted the manuscript to the office of the Academy of Sciences in 1763 he allegedly made changes to the periodization of parts 3 and 4. But, first, what prevented the authors of the collection from bringing these corrections to the documents. And secondly, 1763 is the reign of Catherine II, who started "ordering" historians in which direction to move. And the work of Lomonosov "Ancient Russian History" saw the light only after his death (1765), when Miller "corrected" it accordingly and put it into print in 1766.

**And here are the results of the research of the remarkable scientist Valery Alekseevich Chudinov, Doctor of Philosophy, Professor, chairman of the RAS Commission on the Culture of Ancient and Medieval Russia, director of the Institute of Ancient Slavic Writing and Ancient European Civilization, which he posted on his website in the article ["Was Batu Khan Prince Yaroslav?"](#):**

However, all three images speak of one thing: **Yaroslav Vsevolodovich was Batey, or Batu, Emir of Russia, Muscovite, Suzdal and Vladimir.** In other words, the assumption of NH, expressed by them from the analysis of the texts, was **confirmed epigraphically** according to the strictest criteria. I note that I did not feel any sympathy for NH at the verification stage, and I tried to refute this assumption rather than confirm it.

At the same time, our statement, which was made when analyzing the miniatures from the Radziwill Chronicle, was confirmed: medieval images, unlike texts, were not edited, and therefore retained a number of important explanations for us. It is this property of engravings, miniatures, illustrations and icons that allows for an epigraphic examination independent of the texts. In this case, it was important for us to find the signatures of the character as Yaroslav and Batu ON the SAME IMAGE[3].

So where did the story about the "Tatar-Mongol yoke" come from, the beginning of which was inextricably linked with the personality of Batu. For quite a long time, it was no secret that this was invented in order to hide the consequences of the **violent "baptism" of Kievan Rus**, in the process of which three-quarters of the population was destroyed. Here is the most famous link:

**In the process of "baptism," in 12 years of violent Christianization, virtually the entire adult population of Kievan Rus' was destroyed, with few exceptions.** Because to impose such a "doctrine" was possible only on unwise children, who, because of their youth, could not yet understand that such a religion turned them into slaves in the physical and spiritual sense of the word. Anyone who refused to accept the new "faith" –

were killed. This is confirmed by the facts that have come down to us. If before the "baptism" there were 300 cities and 12 million people in Kievan Rus, then after the "baptism" **there were only 30 cities and 3 million people! 270 cities were destroyed! 9 million people were killed!**

(Diy Vladimir, "Orthodox Russia before the adoption of Christianity and after").

Two notes to make after this quote:

Christianity, as a formalized religion with this name, Nikolai Levashov noted, appeared only at the beginning of the 12th century, **and before that there was the so-called Greek faith associated with the cult of Dionysius**. Therefore, Kievan Rus was baptized at that time with the Greek faith.

And **Nikolai Morozov** in his book "**Christ**" generally noted that **Christians**, in fact, **existed even before "Jesus Christ"**:

"Christ (χριστός) means simply: anointed, initiated, and in a special ancient sense: initiated into the mysteries of occult knowledge.

**Not only the "Palestinian teacher", but all the people who were initiated into the mysteries of the sciences of that time after a special introductory rite of anointing them with the sacred oil, were called "Christ" both then and in the preceding centuries.**

**Hence it follows quite naturally that Christian (i.e., in the Russian translation, all manner of consecrated, or priestly) sects also certainly existed in the centuries preceding the evangelical "savior," as is evident from the Hebrew Bible."**

That is, in the case of the **Christianization of Kievan Rus**, we can talk about the **translation of the Greek version of occult knowledge.**

By the way, **the Greek-Cephalic Orthodox Church (now the ROC) began to be called Orthodox only in 1945**<sup>[4]</sup>.

Before that, there were attempts at other similar variants of transfers from religious sects, for example, long before that, **Arianism**, which did not take root among the Vedic worldview in the Slavic-Aryan Empire.

Therefore, despite the fact that almost the entire adult population of Kievan Rus was destroyed by the "holy" baptists, the Vedic tradition did not disappear. In the lands of Kievan Rus, the so-called dual faith was established. Most of the population only formally recognized the imposed religion of slaves, and she continued to live according to the Vedic tradition, however, without exposing it. And this phenomenon was observed not only among the masses of the people, but also among a part of the ruling elite.

But the Vedic Slavic-Aryan Empire could not calmly look at the machinations of its enemies, who destroyed three-quarters of the population of Kievan Rus. Only the response of the Slavic-Aryan Empire was not immediate, due to the fact that the army of the Slavic-Aryan Empire was busy with conflicts on its Far Eastern borders. The Far East has long been the "hot spot" of the Vedic empire. Very rarely, specific supporting facts are given to support these judgments about the events in the Far East. But here is one of them, taken from the **BOOK OF BATTLES** by Mikhail Averin, presented below. I deliberately did not undertake to interpret these events and left everything as it is with the author, so that the reader himself will perceive the material to the best of his preparation and ability to move away from the ossified illusions of academic works.

### **Spring 1211 – Battle of Yehulin Ridge**

In the 12th century, the Jurchen Jin Empire emerged in northern China. Jurchen in the Chinese dialect means "subject to the zhurs, under the rule of the zhurs". Zhurs are a Russian family of Cranes. Russian clans united the neighboring tribal formations, restoring a part of the Russian Empire on the subject lands, creating the Jurchen Empire.



However, soon the Zhur rulers fell under the influence of the enemies of Russia, who controlled the Chinese, and began to promote the strengthening of Chinese culture on their territory as opposed to their own, began to genetically dissolve the subject Russ among foreign Chinese tribes.

This was largely due to the fact that the Russ themselves in comparison with the neighboring peoples were few and the situation quickly became critical. Most of them have left the apostate state. The reborn empire began to threaten Siberian Russia.

To prevent the Western aggression, the return of the alienated lands and the revival of the Vedic worldview on them, as opposed to the religions of the "West," the Russian Volhvs mentored a man from among the Scythian clans who was given a monumental task. This man was the one known to many as Genghis Khan (Timchak)\*. After striking the Tanguts and forcing them to make peace, Timchak turns his armies against the retreating Jin Empire. After the loss of the fortress known as Wu-sha, as well as a number of northern fortress cities, Jin, in response to the advance of the Rus, concentrates the main forces at the Yehulin Ridge near the Great Wall, covering the passage inland and preparing to fight back. Huge forces were gathered from all parts of the empire, and the diverse Jurchen army numbered up to 300 thousand warriors, among whom the majority were Chinese and Koreans.

The 100,000-strong Russian army under Timchak, destined to reclaim vast lands, overcame the Great Wall and descended upon the enemy army. The Russian cavalry swept away the ranks of the Jin, whose warriors were mostly infantrymen. Resisting, the huge enemy army eventually could not withstand the onslaught and turned to flight, which turned into a disaster. Russian cavalry pursued the fleeing soldiers. "There was such an extermination that the bones cracked like dry twigs," as it is written in the chronicles.

All the traitorous nobles involved in the battle were killed, the warriors were either exterminated or scattered. The 300,000-strong Jin army ceased to exist. The areas surrounding the battle site became free, the road to the middle capital of the empire was opened, the Khitan Russ rebelled and went over to the side of the blood brothers. The losses of Timchak's troops were insignificant[5].

Our academic science continues to gloss over this battle, and most likely, for a reason. Even in Wikipedia, there is almost nothing about it. In 2009, the book "The Great Battles of the East" (ed. Svetlov R. V.). So there is only one paragraph of 400 pages of text devoted to this largest battle of the Middle Ages. **In general, in our academic science, it is customary to keep silent about the largest battles of the Middle Ages, including on the territory of our country,** as it happens, for example, with **the Battle of Molodinsky (1572)**[6].

It remains only to **thoroughly** train our **hisTORians**, who **forget to include in their textbooks the most grandiose and large-scale things about our past!**

And then, instead of history, our **YOUTHFUL** past and **FUTURE** will appear.

So, let's remember, were there battles of such a scale on the territory of Europe and Asia up to the 1st World War, so that **400 thousand people** participated in them, and perhaps half a million (according to some sources, the Jin army was up to 400 thousand)? Even the battles of Borodino and Waterloo, which are 500 years closer to our time, barely reach Yekhulinsky in terms of the total number of participants. This is just a strong confirmation that the events on the Far Eastern borders were much larger than in the west and drew off significant forces of the Slavic-Aryan Empire. But in addition to the Jurchen front, there were two other fronts. Here's how Lev Gumilev wrote about it:

**The second most important was the southwestern front, where in 1219 the Mongols waged war with the Muslims.** There they kept a standing corps of 30 to 60 thousand horsemen against the Seljuk Turkmens. The northwestern (eastern European) front was in third place, and the main object of the Mongols' fury was not the Russians, but the Polovtsians, allied with the Russian princes. Besides, the Mongols had to make separate campaigns now and then to Tibet, then to Siberia, then against the Kama Bulgarians, then on Mordva. The Mongols could not have a numerical advantage and a technological advantage because they did not have their own iron production" (L.N.Gumilev, "Ancient Russia and the Great Steppe").

And so the retaliatory actions on the western borders were postponed for a while, but they followed. These responses of the Vedic Empire to the machinations of social parasites have entered into the modern interpretation of events in a distorted form under the name of the Mongol-Tatar invasion of the hordes of Batu Khan in Kievan Rus. **Here is how Nikolai Levashov commented on these events:**

But in a "strange" way, the information was omitted that **EIGHTY PERCENT** of these hordes were Russian Cossacks, who were the main professional military force of the Vedic Slavic-Aryan Empire. Thus, only by the summer of 6732 from S.M.Z.H. (1223) the armies of the Vedic empire appeared on the Kalka River. And the combined army of the Polovtsians and the Russian princes was completely defeated. So we were hammered in history classes, and no one could explain clearly, why the Russian princes fought with the "enemies" so sluggishly, and many of them even went over to the side of the "Mongols" (the word MOGOL has a Greek root and means the GREAT).

All this is explained by the disunity of Russian princes, by the fact that they weakened the Russian land by internecine strife! Seems to be all logical, but... strangely enough it turns out, Prince Svetoslav with only his cohorts practically put Romea (the Byzantine Empire) on its knees, and only because of the subtle diplomatic game, in which he was not strong, did not bring the matter to an end. And here many princes had no less numerous and no less experienced squads, but, nevertheless, ingloriously defeated in the first battle. And although the main hostilities would begin only fourteen years later, the situation has not changed. (RKZ, Part 2, p.12)

**BUT!** It would be wrong to consider the reign of Batu only in the context of retaliation for the forced "baptism" of Kievan Rus'. A broader context is necessary. It is known that Batu Khan (the Ruler of Russia according to Lomonosov) had an external task: **to return the Western European provinces-states under the wing of the Vedic Empire (to reach the last sea!)** And this task had not just a territorial, but already a geopolitical, in the modern language, coloring. At the root of this task are problems of a spiritual nature. In my opinion, it is necessary to consider them from the point of view of the correlation between the philosophical categories of "**Faith**" and "**Knowledge**", which the remarkable Russian scientist **Nikolai Morozov**<sup>[7]</sup> singled out about a hundred years ago into a unified system of dialectics.

And you need to start with the materials that Nikolai Morozov analyzed in his **book "Christ"**. Namely, from an exceptionally talented scientist, who was, like all scientists of that remote period, both an astrologer, an alchemist, a doctor, and a magician, i.e., **possessed all the secrets of the occult sciences of that time. His name was Yeshua (in Russian, Jesus),** which in translation from the Ancient Syriac language means — the savior. (In the book of Revelation, Svetlana Levashova also mentions the life **of the Jewish prophet Joshua.**) The time of his life has not yet been determined accurately enough. He preached ideas that gained him many enemies among the scientists of the old generation and several ardent supporters, of whom one, the youngest and most gifted spiritually, was called John or Jonah, and the other, the eldest, was called Simon in Hebrew, and in Greek, as if Peter. The first, who apparently came from an intelligent family, later became a very educated person, as he wrote a highly artistic Apocalypse for that time. The second was less gifted spiritually, but very energetic and later became an outstanding practical organizer. The ideological enemies of the "rescuer" were distinguished, like all the frozen and petrified **routiners** in the once-learned concepts, by intolerance and hatred for everything that did not fall within the narrow framework of their understanding, and pronounced a death sentence on him. Nikolai Morozov, based on the Greek version of the Gospel, proved that the execution was carried out through a pillar (simply put on a stake with the support of the hands on a horizontal crossbar, so that the sliding of the body on the stake was as slow as possible), and presented astronomical calculations, according to which **this execution of the evangelical "savior" was on 2 March, 368**, the removal from the pillar after the lunar eclipse was a day later, on the morning of 21 March, and **the "resurrection" was before dawn on 22 March, 368**. Morozov also further explains **that this date was even after the well-known Council of Nicaea, in 325, where two Christian sects, Arians and Nicolaitans, had already actively begun to confront each other (including, as is known, with a beating in the face).** And the first Byzantine emperor, Constantine the Great, who made Nicolaitanism a state teaching, and for this reason was canonized by the Orthodox churches to the list of their saints. Once again, we note that, according to Morozov, **Christians existed even before "Jesus Christ", since "Christ" meant in a special ancient sense: initiated into the secrets of occult knowledge.**

And here again, it is **very appropriate to recall that the official date of Jesus' execution, 33 A.D., is not even closely confirmed by any astronomical calculations, just as his birth date was artificially adjusted to 0 A.D.**



In fact, as it is constantly noted in the materials of the Research Institute "TSUS", since the **year 0 (May 09!) AD**, the program popularly known as **"Christ"** (translation to the religious-confessional methodology for providing control states in the sphere of power, i.e. religion has acquired the main control load) was introduced, and frequencies were introduced to ensure the process of **reincarnation** (the spent matrix is not thrown away, but is transferred to the next shirt. **Hence-the symbolism of a mother with a baby**)[8].

In addition, since that time, the process of introducing a specific state of management in the organization of people's existence – **"the power of money"**, as a finally formed **management program** (ritually symbolized by the crucifixion of Jesus Christ).



But we will continue our consideration of this burning topic with the most important materials about **the true origin of the existing form of Christianity**, which humanity learned thanks to Svetlana Levashova from her wonderful book "Revelation": **The Truth about RADOMIR-Christ, crucified in 1086, in Constantinople, about his wife MAGDALENE, who was killed in 1094, the truth about the Cathars of Occitania-followers of the teachings of Radomir.** And here is the life story of the prophet **Joshua** (the scientist-occultist **Yeshua** according to Morozov), cunningly "intertwined" with the **life story** of Radomir, destroying the real biographies and putting fake ones, so that naive human minds would believe in such a "story". After the death of Radomir and Magdalene, their whole bright and sad life was entwined with shameless lies, transferring this lie also to the descendants of this amazing, courageous family... They were "**clothed**" with **SOMEONE ELSE'S FAITH**. Their pure images **surrounded the lives of STRANGERS** who had not lived for a long time... **WORDS were put** into their mouths that they **HAD NEVER UTTERED...** They were **MADE RESPONSIBLE FOR THE CRIMES COMMITTED AND PERPETRATED BY SOMEONE ELSE'S FAITH**, the most deceitful and criminal that ever existed on Earth... Here is how Nikolai Levashov described this whole context:

***"Before the appearance on the historical arena of Radomir (Jesus Christ) - the bearer of Vedic traditions - the CULT OF DIONYSIUS reigning at that time in Europe from the time of Constantine I the Great had completely DISCREDITED itself! Jesus Christ stirred up all of Europe at that time with his deeds, and the fathers of Greek religion (as it was still called in the 10th century A.D.) and the Jewish high priests behind them decided that Jesus Christ would be a good candidate for the role of the new messiah. And ... a little sleight of hand, and so a "new" religion appeared in the world, covered, literally and figuratively, by the bright and pure name of a man who had fought all his conscious life against the social parasites who used Judaism and its varieties to enslave peoples, and whose first victims were the Jews - the sheep of the House of Israel! And very quickly the so-called Greek religion became Christianity!***

***Clearly, this happened at the beginning of the 12th century AD! And here comes the problem! And a BIG PROBLEM! In the south of France there is the real teaching of Jesus Christ, preserved and saved from the lie by his beloved wife, the mother of his children - Mary Magdalene! And what is what, is known not only in the upper classes of society at the time, but also among the people, and which (the teaching) is spreading faster and faster! So what does Pope Innocent III do? He sends an army on a crusade against the TRUE doctrine of JESUS CHRIST!***

So, the success in the "baptism" of the Greek faith of Kievan Rus (including the extermination of all the discontented) "inspired" Rome and their vassals of the Crusaders to forcibly "Christianize" in Western Europe, again with millions of victims. Even before the start of the Albigensian Crusade, in 1199, Pope Innocent III "graciously" declared: **"Anyone who professes a faith in God that does not coincide with the church's dogma should be burned without the slightest regret."** The crusade against Qatar was called **"For the Cause of Peace and Faith"**! (Negotium Pacis et Fidei).

And now let's briefly follow the chronology. The time of the beginning of the "holy Inquisition" is **1208**. Already in 1209 there is a complete extermination of the population of the aforementioned **Albi**. Further atrocities of "true Christians" and crusaders against **Qatar** are described in detail by Svetlana Levashova in "Revelation". **BUT! The last refuge of Catar-Montsegur fell only in 1244.** They held out for a very long time, ten long months, freezing and starving, infuriating the army of the Holy Pope and his Majesty, the King of France. There were only a **hundred** real warrior knights and four hundred other people, including women and children, and more than two hundred Perfect Ones.

And the attackers were **several thousand** professional knights-warriors, real murderers, who received the go-ahead to destroy the disobedient "heretics"... to the merciless murder of all the innocent and unarmed... in the name of Christ. And in the name of the "holy", "forgiving" church.

And now let us return to Batu, who was so eager for the "last sea" and who was given the task: to **return the Western European provinces-states under the wing of the Vedic empire**. Summer 6749 (in 1241) in the month of April (according to some sources in 1242), two significant battles take place (again, I use the material of the **BOOK OF BATTLES** without interpretation):

### ***Battle of Legnica***

*Having dealt with the Christian Russian principalities, the troops of Siberian Russia simultaneously invaded Poland with the invasion of Hungary. The cities of Poland are falling one by one under their onslaught. The "West", trying to rectify the situation, pulled together to help the Polish prince the main forces of the chivalry of Europe, which was planned after the liquidation of the Roman Empire to seize the lands of the Christian princes during their feuds and to convert the population to Catholicism, turning their lands into a continuation of the Catholic world of Europe. The hierophants decided to stop the Russian offensive on the territory of Poland and give a decisive battle. German, Austrian, French, Italian, and even Spanish knights arrived to help the Polish knights. Under the leadership of Prince Henry II of Poland, a 60-thousand-strong combined Polish army with European mercenaries and European chivalry, including Teutons, Templars and Hospitallers, acted. To help Henry, the Czech king Wenceslaus went with an army of about 50 thousand soldiers under the Czech knights. The European army was opposed by a 25 thousand Russian army under the command of Baydar.*

Without going into the details of the battle, the result:

*The European host was destroyed. Losses amounted to about 40 thousand soldiers killed, noble knights were killed, Prince Henry was killed. The purposeful pogrom of chivalry was great – carriers of animal blood were destroyed, not one century "numbing" the conquered Russ of Europe. The enemy leader was identified only by his six-toed foot. After learning of the crushing defeat of the Latin army, Wenceslaus turned his army around and left without resistance. Poland fell completely, all European chivalry was reduced by more than half, the Pope, fearing a Russian invasion of Italy, fled to France. Russian losses in the battle amounted to less than 4 thousand people.*

### **Battle of Chaillot**

*Simultaneously with the invasion of Poland, the troops of Siberian Russia, led by Batu, moved through Catholic Hungary. King Bela IV of Hungary, together with the Croatian Duke Koloman, assembled a 60,000-strong Hungarian-Croatian army, which included European mercenaries, Serbian and Wallachian detachments, Hungarian knights, small detachments of Teutons and Templars, and was concentrated near Pest. In early April, the advanced Tumen Rusov approached Pest and, faced with the enemy army, began a tactical withdrawal. The Hungarian king began to pursue the retreating troops and in the course of the pursuit camped at the river Chaillot, where the main Russian forces of about 30 thousand people, led by Batu, approached.*

**Bottom line** (again, I apologize to the author for shortening the test):

*The flight of the Catholic host turned into a catastrophe. The fleeing army was subjected to a complete extermination, which lasted up to six days, with the aim of completely destroying the hiding scattered enemy units. We will add to this picture of the complete defeat of the military forces of **Europe and again the April "Ice Battle" of 1242 under the leadership of Alexander Nevsky. The whole of Eastern Europe is already under the control of Batu**, despite the comparative smallness of his hordes (troops). To the south of France, where Qatar is being exterminated, is already "close at hand"! Before the death of the last stronghold of Qatar-**Montsegur**, there were still **2 whole years** left!

And here immediately arises a version: whether it was **not to the aid of the Cathars in such a hurry Batu Khan!** After all, the direct route to the north of Italy and to the south of France is open. And this southern front is headed by Batu himself personally. And what would have happened in the end?

The Qataris would have received not just military aid, which reduced the number of victims, but a kind of ideology of resistance to evil with violence and justice. Recall that among them there were quite a lot of Perfect Ones who surrendered to allegedly save the lives of thousands of people (the deceptive strategy of the church worked), and there were not enough knights-warriors for defense. But almost every one of the Perfect (Magicians), as Svetlana Levashova noted, **could destroy an entire army with just one movement!** But they **did not want to fight by FORCE**, preferring to fight by **WORD** to force. That's what they were destroyed for. Dozens and hundreds of them were burned at the stake. And for them, the **Templars** (the society of battle magicians created by Magdalene) died, who, even knowing that they would lose, could not calmly watch the old men, women and children die... How the best ones burn...

And in the hands of Batu most likely would have been **the real "Revelations" of Christ and the diaries of John**, which at all costs tried to find and destroy the Roman Church. In this case, **the history of the Catholic Church would have been utterly defeated.**



As a result, almost the entire territory **from the Atlantic to the Pacific** Ocean would be dominated by the Vedic worldview, and in fact, **a new "World Order"** would be established.

Don't worry! I can already hear those voices that, encouraged by the so-called "academic" science, will try to remind me of the existence of the phraseological unit: **"History does not tolerate the subjunctive mood."** This has become such a programmed platitude. Now even sports commentators, trying to show their education, are happy to savor this phraseology when our national teams are defeated. Is it not clear to **"educated experts"** that this phraseology is the tool of one of the zombie programs that the old parasitic control system broadcast, and which historians like to use it so much?

Such programs teach people to think, analyze, draw conclusions, predict, and generally develop through future meaningful actions. As a result of such a peaceful process, people forget their past, suddenly turning out to be God's servants, who are inexplicably ruled by God's chosen children! Here is how this is eloquently stated in the "Revelation" by Svetlana Levashov in the words of the main negative character Karaffa:

to **subdue them peacefully**, I use a very simple and reliable method – **I destroy their past...** For without a past, a person is vulnerable... He loses his **ancestral roots** if he has no past. And just then, confused and unprotected, it becomes a "blank canvas" on which I can write **any story!**.. And would you believe it, dear Isidora, people are only too happy about it... because, I repeat, **they can't live without the past** (even if they don't want to admit it to themselves). And when there is no such thing, they accept anything, just not to "hang" in the unknown, which for them is much more terrible than any other, **fictional "story"**.

So the Pope's servants strove vigorously to find out where the damned Cathars were hiding their most dangerous treasure. But no matter how hard the church's bloodhounds tried, no luck came to them... Nothing could be found, except a few manuscripts of eyewitnesses. That is why the only way the church could somehow save its reputation in the case of the Cathars was to pervert their faith and teaching so much so that no one in the world could distinguish the truth from a lie... As they easily did with the lives of Radomir and Magdalene.

So why did Batu stop the conquest of Europe in 1242 and did not have time to help the Cathars? Historians will have a very simple answer: Because at this time, the son of Genghis Khan, Khan Ogedei, died, and **Batu** was forced to return to Mongolia to take part in the struggle for power between his relatives and associates. They can also add about the lack of resources and the mood of the troops who were trying to return to their native steppes, or about the new tasks of the empire in Central Asia and the Far East.

But the essence of the question is in a completely different plane – what kind of management systems determine all the processes and phenomena that occur in society and nature. The control systems of the interventional parasitic control system constantly monitored all unnecessary deviations from the ongoing programs and experiments.



Thus, the further advance of Batu into Europe and the establishment of communication with the Qatars would lead to the **threat of disruption of the program** associated with the introduction of **a fundamentally new basic basis of spiritual values – religion, which was supposed to acquire the main administrative burden**. Moreover, the plans of the interventionists and social parasites did not include any deviations in the construction of the future World Order. Also at this time, more and more deviations and problems were observed in the implementation of experiments under the program "Energy-informational dialectics of the development of brain genotypes". Thus, due to the increasing complexity of control processes through the **brain genotype 42 (CC Caucasus)**, the possibilities associated with the development and long-term adaptation of brain functions were coming to an end. And the Batu invasion exacerbated this problem on the basis of their comparison with the adaptive parameters of the **brain genotype 384**. Therefore, even then, apparently, preparatory work began for the deployment of **the Alps 1 Control Complex on the territory of Western Europe**. And less than 200 years later, **in 1433, the first version of the brain genotype 441 was obtained**, i.e., **the foundation for the formation of the so-called "Golden Billion"** was laid.

Therefore, with a fairly high degree of confidence, it can be noted that if Ogedei Khan had not died, there would have been some other death or even a cataclysm that would still have stopped the further advance of Batu's troops to the west "to the last sea". **Let's restore the key events of the heroic past of Russia 2:** In connection with the material presented above concerning the participation of the Slavic-Aryan troops (Mogul hordes) in individual battles in Asia and Europe (outside the territory of present-day Russia), it is interesting to analyze their indicators by analogy with the materials of the article "**Let's restore the key events of the heroic past of Russia: The Battle of Molodei – 441**"[\[11\]](#).

It is very noticeable that despite all the existing laws of war, when inferior to the defending forces of the enemy in number by 2-4 times, our soldiers, attacking, managed to inflict crushing losses to the enemy up to a complete defeat. At the same time, they themselves suffered minimal losses in manpower.

To the north of the H'Aryan Sea (Lake Baikal), 7,516 years ago (as of 2007), peace was created in the Star Temple (a peace treaty was concluded), between the Great Dragon (Ancient China) and the Great Race. For the Slavic-Aryans, these places were sacred and had been much earlier. Six days later, the knights that were sent reached the ruined and burned ancient sanctuary. Seven circles — 112 Knights gave chase. Someone, perhaps, will be surprised by such a small number of knights-warriors that were sent. But do not rush to draw conclusions about the insignificance of the enemy raid.

The Knight caste **HAD THE POWER**. The Knights were professional warriors, drawn only from the ranks of the Varangians who possessed **PARANORMAL ABILITIES**, in other words, could **DRAW POWER** and **DIRECT IT** through themselves. At the same time, they became almost **INVULNERABLE** and **INDEFATIGABLE**.

The ancient Secret Knowledge of controlling the Force in general and in combat in particular, our ancestors called Alive. It was alive not only by the system of combat techniques, with the use of Force, but also by the philosophical and moral system of ideas about the universe. Not every professional warrior was allowed to train in and learn Alive, only those who had high moral standards and obeyed the Code of Honor not in words, but in deeds.

The use of the Force was a powerful weapon, and it was given into the hands of only the most worthy of the worthy. The Knights had a perfect command of the GAME and several knights could withstand entire armies with many thousands of soldiers. Therefore, 112 Knights is not a few, but **A LOT**. In addition, too large an army could not go on a predatory raid on someone else's territory. A large army, willy-nilly, would have a large supply train and, therefore, a sudden attack on the Sanctuaries was out of the question[12].

This example is not given by chance, as these same 112 knights destroyed those enemies who, after the defeat of the Sanctuary, went in search of the exit of the Source of Life, which we have so often mentioned in previous materials. In the SAV in the Third message, the approximate location of the exit of this Source to the surface (very powerful, most likely) is indicated - in a valley lying southeast of Lake Baikal and the northern slopes of the Apple Tree Ridge. It is possible that there were many such outcrops, but the power of the Source of Power manifested itself in them in different ways. It is possible that in the times described in the Third message there was one exit of the Source of the Force on the surface of Midgard-Earth.

It should be understood that the heirs of the ancient military traditions of these same KNIGHTS: Genghis Khan (Timchak, Temir, Temujin), Batu, Burundai, Baidar and other significant generals of the "Mongols", along with their best warriors, were actually natives of those Slavic-Aryan families, which are officially called Scythians and Sarmatians, allegedly disappeared by that time. The territory of these clans stretched from the Black Sea to the Far East. The Magi-priests who instructed Genghis Khan, and then Batu, set before them and their generals the task of returning the lost vast lands and restoring the Vedic worldview on them against the Abrahamic religions fabricated by the hierophants on the former lands of the Slavic-Aryan Empire, while organizing a real genocide.

Of this Great folk tartarekh mongaileh the King of Batu - the sons of Tarkh, the grandson of Perun, seeing himself having a great host, began to breathe fire-breathing rage against the sects of the Jewish-Christian, who want to destroy them, and free the countries of them, and destroy the Semitic seed, and return their Old Belief.

After the restoration of the borders by Genghis Khan and Batu, the huge **Slavic-Aryan Empire** was called "**Great Tartary**"[13] on numerous medieval maps.

On the Internet, you can find dozens and even hundreds (a collection of 320 maps[14]) of medieval maps from various publishers and countries, which show both Great Tartary and the provinces that are part of it.

This topic is explored in more detail in a series of articles on the website "Sedition"[15] and on the website "Food-Ra"[16]. To these studies and maps, we can add the materials of the **3rd volume of Nicolaas Witsen's Northern and Eastern Tartary**[17], which essentially examines the entire **Great Tartary until the time of Peter the Great** (Witsen called him a friend, but this "friend" at one time bought the entire first edition of his book for obvious reasons – in order to prevent its mass distribution - the Romanovs needed a different story). The materials of this 3-volume collection, which are in single copies in regional libraries (usually in special departments), are still hushed up from the general reader, and specialists and historians are basically ignored. Initially, the word Tartary sounded like "Tarkhtaria" and consisted of the names of the children of the hierarch of Perun: Tarkh and Tara. The lands east of the **Khari Sea (Lake Baikal)** was under the protection of Tarkh Perunovich (Dazhbog), and the lands to the west of it were under the protection of the goddess Tara. According to the same principle, Genghis Khan initially divided his state: to the east of the Khari Sea were the lands of the "Blue Horde", and to the west were the lands of the "White Horde". And then the "historians" began to link the location of the "Blue Horde" to other territories.

Accordingly, Batu belonged to the White Horde, and not to the "Golden Horde", as historians try to impose on us, and as we found out above. That is, the principle of division of territories with respect to **Lake Baikal** remained the same. By the way, it is no coincidence that it is in this area that one of the key complexes of the reviving CPS – "**ALTAI**" – is located.
