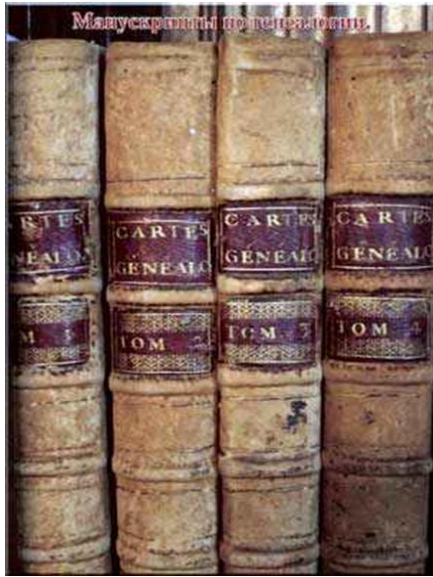

### 4. Some touches from the prehistory of the doctrine of the world Order

After the seizure of power by Catherine II in 1773-75, a civil war was launched (in the history of the "Pugachev Uprising", the materials of which are still not fully declassified) against the rulers of the Great Tartary – the old dynasty, which was also called the "Horde dynasty". As you know from numerous maps of the 16th and 18th centuries, the Great Tartary included not only a huge part of Asia, but also the territories of Europe and even North America. Below is a fragment of North America on a map from the British Encyclopedia of 1771, where you can see that the entire Northwestern part of the North American continent is a huge "white spot" that opens into the ocean, where not even the coastline is marked!

And here is a map of North America that dates from 1600-1685.



That is, in almost 100 years, there have been no geographical territorial acquisitions. And now compare the extent to which the geography has expanded over the same period, for example, in Asia beyond the Urals, when the Cossacks almost freely crossed all of Siberia and the Far East. One conclusion suggests itself: the American colonialists were simply not allowed to approach the possessions of Tartary.

Nikolai Levashov made a reference to a unique handwritten book of genealogies of the Regal and Royal families of Europe. There were also the rulers of Tartary. Peter was at the head at that time, and therefore Romanov historians played on this, giving Emelyan Pugachev as an impostor of Peter III. As a result of the war of 1773-75, the old "Horde dynasty" was defeated, fled to the East to Chinese Tartary (on maps it continued to exist for a long time), and then it captured and completely subdued China.

After the victory, Romanov historians with even greater zeal continued to clean out the archives, burn huge volumes of documents and chronicles. The beginning of this process was laid under Alexey Mikhailovich and, especially, under Peter I.

The Romanov dynasty for the first time received full access (not only economic and representative, as before) to Siberia. It was only after this that the Americans gained access to the Western part of the North American continent for the first time and began to quickly capture it, both by land and by sea. Therefore, it was only in 1776 that Captain Cook, and then Clark were able to start an expedition to the North Pacific and rushed to urgently rename geographical points and attach them to the possessions of the British crown. But the Romanovs were also awake. At first, they managed to capture Alaska. However, they could not hold it in the end. As a result of the victory over Great Tartary, the United States appeared on the ruins of the Horde Empire in America in 1776. The final division of the Empire ended in the 19th century. This feast of winners and "founders" of the "New World Order" was wiped clean from the history books.

**New World Order** ([Eng.](#) New World Order, [Lat.](#) Novus ordo mundi) - the designation used in politics for various phenomena in the present and forecasts for the future of the world order. It has no generally accepted meaning.

The motto "Novus ordo seclorum" [from 1776](#) contains the [Great Seal of the United States](#) at the base of the image of the pyramid.



Thus, 1775 was the turning point in the formation of a new World Order and the entire history, in the literal and figurative sense of the word. It is the history, not the chronology, if we talk about the Greek version, not the events of the past, if we talk about the Russian version.

It was after 1775 that all the events of the past, and of Russia, and of all other countries of the world were rewritten and the way it's presented to all schools and other educational institutions, books, religions, movies and so on...



All these events occurred during the final stage of the controlled state of development of the 441 brain genotype. According to OFCH, with the introduction of the 442 brain genotypes in 1841-1990, already as a stage of the hegemony of the blood genotype, the formation of a special group of performers, framed in the structure of the "Golden Billion", began. In this regard, new and more sophisticated forms and management programs of social violence and military-power pressure, "oppressive benefits" of the Anglo-American-European parasitic system "Market of Complex Violence", **which are described in sufficient detail in the " Fundamentals of the Formation of Humanity" and other sources.**

## 5. SvetL programs during the transition to the new doctrine of the World Order and the destruction of the doctrine of "social violence"

To more clearly imagine the role of "**SvetL**" Technologies in our lives during the transition period, we need to turn to the essence of the mission that their Creator Nikolai Levashov performed on Earth (and Svetlana, who voluntarily followed him from completely different spaces). This is how he himself formulated **the main purpose of staying on Earth**:

The goal of my mission **was to find a key to solving the problem of parasitic systems** that originated everywhere and twice had caused the Big Universe, in which there were many "layered pies" from matrix spaces, to perish because the activity of these parasites led to the fact that twice the "fabric" of the Big Universe itself became unstable, and each time it perished, or rather, another **configuration** of the Big Universe perished.



Thus, the key to solving the problems of parasitic systems in the Big Universe should be found on Earth. And the second key (or the same one) was to open the door, behind which there is a solution for correcting the configuration of the Big Universe. Remember, it was precisely the problems of this kind, concerning the Significance of the Earth for the Universe, which Nikolai Levashov revealed when he considered the topic of the **Source of Life**, which naturally had special configurations. I hope that together we understand the configuration not only from a geometric and spatial point of view, but also more broadly: from the frequency-radiation (based on octave energies), as well as from the point of view of Control Systems. To protect against unauthorized access to this configuration of the Source of Life during the period of Earth intervention, a **Blocking Generator** appeared.

Thus, on the one hand, Nikolai Levashov acted as a **KEEPER** of a high level of **Knowledge** (including the Daarii past) and their **Distributor**, i.e., **tried to convey the most complex knowledge "from the cell to the Universe"** to people in the simplest and most accessible language. But to an even greater extent, according to the terminology of Svetlana Levashov, he was the **Best, at developing and implementing strategies** for the exit of Mankind (and even the Great Universes!) from the **web of parasitism** (including developing new **configurations** of matrix spaces).

One of these "methods" in a certain range of octaves of energy is the **SvetL Technology (Software)**, which he paid special attention to over the last 20 years of his life, developing and implementing such innovative solutions and configurations that were able to operate autonomously under the **guardianship of trusted Persons** (who, like him, became participants in **the last ORGANIZATION** that he, N. Levashov, Revived in 2011 in Russia and which many already know as the "**Russian Scientific and Technical Society**" ("**RNTO**") **without his participation at the level of inertial energies.**

So, since the main goal of Nikolai Levashov, his mission on Earth was to **find the key to solving the problem of parasitic systems**, then the **SvetL Technologies (Programs)**, in this Transitional Period to the New World Order primarily represent the most valuable "**Programs to free people from consequences of the effects of the parasitic intervention forces.**" This is manifested through a systematic and consistent elimination of the consequences of the impact on the Human body of violent parasitic technologies associated with environmental disruption and enhanced chemicalization, the use of GMO technologies, vaccination, the spread of viruses and the dominance of drugs that suppress the immune protective properties of the body...and all that in the works of Nikolai Levashov referred to the means of **genocide of peoples.**

Moreover, some parasitic programs already affect our daily life at full capacity. Please note how critically Boris Makov assesses the situation, for example, with the use of GMOs:

***On the territory of Russia, there is no non-poisoned food at all. All that agriculture provides as food is no longer the food of nature. Russia is crushed by the imported seed fund, which has already been destroyed. Natural nature is destroyed through GMOs. Since 1954 the task - to eliminate, starve and suffocate with diseases was born in the bowels of the United States, England and Israel. This is a program. It took so many decades for it to work on a large scale across the entire territory of the Russian space. This was a separate topic for them.***

(Answers of B. V. Makov to questions received from participants of the 1st Moscow seminar on the basics of New Knowledge)[1].



It has been noted many times that the prototype for the "design" of "SvetLa" was the so-called "**Source of Life**" ("Source of Power"), which was mentioned in the **Slavic-Aryan Vedas** (SAV) and analyzed in detail in the works of **Nikolai Levashov**. But to consider its action in isolation, in my opinion, would be wrong, especially since you are unlikely to find information in open sources about the ever-observed outputs of the "Source of Life". Moreover, no one has written about the Blocking Generator except Nikolai Levashov. However, it is precisely his work that influences the fact that only three, at most five percent of the total number of neurons in the brain of a normal person are active, and the remaining **ninety-five to ninety-seven percent of the neurons "sleep"**. And, most annoying of all, **they "sleep" throughout a person's life**. Thanks to this, modern science has not been able to reach the level of primary ("dark") matter and non-inertial energies, being held captive by the Pyramid of Knowledge, which was inspired by the intervention parasitic system. So, we can state from indirect signs and consequences that both Generators have a significant impact on everything that happens on Earth, but no one can detect them. There are two main reasons for this. On the one hand, as noted in section 2, both sources operate in the opposite phase, ensuring the secrecy of each other's work. On the other hand, the octave spectra of both Generators were at levels that were particularly difficult or even inaccessible to interventional control systems.

The blocking generator operates in the spectrum of octaves corresponding to *the acquisition by a person of six material bodies of the entity (to the existing physical one)*, which corresponds to the range of **66-128 octaves**. In this range of octaves, it is adapted and systemically **integrated with the SOURCE of LIFE** (up to 128 octaves), and has higher, unthinkable levels for our understanding (up to 512-1024) octaves. It is possible that the Source of Life is a kind of CPS Generator (512), but 1024 octave is already an exit to the CPS of the Civilizational Cluster to ensure the second stage of civilizational development as part of the Sirius Civilization group.

As noted in section 2, in the Transition period to the New World Order, the key will be the **128-octave boundary**, which, among other things, corresponds to the maximum value of the octaves of the Old Interventional system.

This is where the overall configuration emerges, in which a special role is assigned to the "**Light/SvetL**" ("Light/SvetL" Programs), which was created in the image and likeness of the "Source of Life" and works with it in the **same cluster system**, but only in a narrower range of **66-126 octaves** (relative to the Person). This allows it to create those resonant "bursts" in this range that allow it to mute the action of the Blocking generator in certain octave spectra, thus opening the so-called information spaces. **In the materials of the Research Institute "TsUS" and "RNT0"** - the characteristics of one of the information spaces on Earth (of which there are only 18):



*This is a space constructed, as in the case of an Autonomous proton field, on the basis of a proton atom. But its density is insignificant and does not exceed the density of the information space. The octaves associated with this space are 71.625625, 73.625625, 77.625625, and 79.625625. The information contained in this space is of particular value, since it contains all the data on the structures of atoms and their energy characteristics. In addition, there is information about the current state of the program and its purpose.*

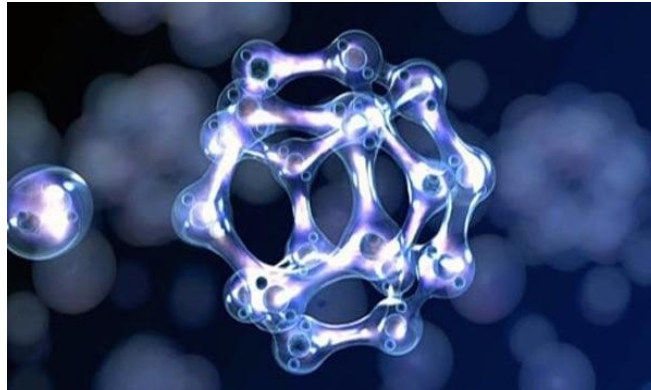
We should not forget that **any living organism can exist only in the information field**; outside of the field the organism consumes irrevocably the reserves of proton space potentials. The end of reserves leads to the separation of spaces, and the ionic structure turns a normal inertial mass, into sand. **Each Life Support System forms its own information space. The SvetL programs**, in the variants of their application and use, also form THEIR **own INFORMATION SPACES**. As on Earth, there are **18 such spaces in the SvetL Complex**, and all of them are **designed to perform their own Programs**.

It is possible that **Nikolai Levashov**, in cases with the so-called transformation of the human Brain, **worked in tune and resonant with the Source of Life**, muting the action of the Blocking generator in certain information spaces. It is not for nothing that in such cases, he warned about the flow of information of a completely different kind, which you need to be prepared for. But when a person incorrectly perceived this information of a different kind, was not ready for it and new States of his brain (which could manifest itself in his thoughts and in his actions); the qualitative resonant characteristics were violated. **Then the Blocking generator automatically closed** this option of Brain transformation according to the program **"ENDOWMENT of PEOPLE ACCORDING to their THOUGHTS"**. In this case, the control by Nikolai Levashov was not even necessary; the Blocking generator has shown its reliability for millennia in this direction.

This in turn made it possible to build a system with reliable control functions and feedback: **"The Source of Life is the Complex Light/SvetL-Blocking generator"**, where the program **"ENDOWMENT of PEOPLE ACCORDING to their THOUGHTS"** was triggered not only at the exit, but also at the entrance. From the thoughts of a person, there could be a consonance with the "Source of Life" and the degree of overcoming the influence of the generator blocking the development depended on it.



And the "**Svetl Complex**", performing the function of energy-informational support of the human Essence, is engaged in increasing the density of the information space in order to increase the chance of obtaining a resonant state with the Source of Life and, if necessary, in a fairly short time to start implementing the program with a new goal.

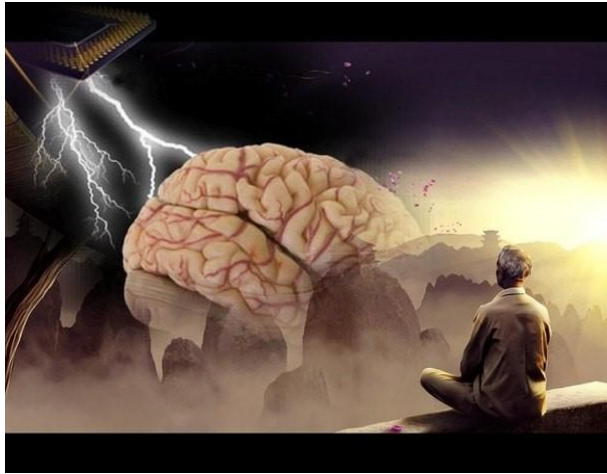


**And one more important remark:** the difference between the upper limit of 126 octaves of SvetL (relative to Man) and the upper limit of 128 octaves for the maximum value of octaves of the Old Interventional System and simultaneously the Blocking generator. This ratio once again shows that in order to overcome the key milestone of the 128th octave, the last decisive step (certainly in the good interests of other people) has to be taken by **Man anyway - by himself!** And here everything will depend **not on the energy-informational support of "SvetL", but on those personal concrete deeds and actions of a person that make it possible to overcome the Planetary level of development..**

Nevertheless, **in favor of "SvetLa"** I would like to add two more comparisons.

The ability of **SvetLa** to increase the chance of obtaining a resonance state with **the Life Source** for some octave spectra, due to an increase in the density of the information space, leads to the appearance of something similar to the **so-called "SvetLa" workplace. "Places of power"** (but not on the basis of existing electromagnetic and gravitational gratings, but on the basis of peculiar cluster tubes).

And you can also try to answer the question that Nikolai Levashov asked: *Who will be the "prince" who will wake the "sleeping beauty" in the Human Brain and with what "kiss" he can awaken the brain's passive neurons from this lethargic dream?* **SvetL** is not a prince, but it is a **kind of alarm clock, which part of the Brain neurons** (with the right actions and human development) **is able to wake up (prepare) for the transition from a passive state to an active one**, on the whole increasing the potential of the whole brain.



And another important area of work of "SvetLa" is relevant to consider. **Nikolai Levashov** placed a special emphasis on the fact that "Dark Matter" ("primary matter" and, accordingly, non-inertial energies) **are HOMOGENEOUS in their QUALITATIVE COMPOSITION!**<sup>[2]</sup> At the same time, he noted that from 70 to 90% of their flows **are not QUALITATIVELY CONSISTENT with the person and his structure of ESSENCE!** And this means one thing — if a Person independently without appropriate accompaniment meditates long enough and intensely and enters the ASC (altered States of consciousness), all his structures are clogged with slag and more or less destroyed! So, instead of an evolutionary leap, Man gets the opposite - the loss of their evolutionary achievements of past lives. At the same time, People who have lost their energy and protective properties often become so-called food for astral parasites, further losing their evolutionary potential. "SvetL" has an effect on a person in the opposite direction described above. After all, the **Complex "Light/SvetL" is the same generator of "dark matter", which can QUALITATIVELY AGREE WITH THE MAN AND HIS ENTITY STRUCTURE THAT THE DARK MATTER OR PRIMORDIAL MATTER OR NON-INERT ENERGY BY THE NUMBER OF OCTAVES THAT ARE AVAILABLE TO HIM IN THIS INCARNATION OR IN ATOMIC ENERGY MANIFESTATION.** Therefore, there is no need to practice risky meditations and unusual ASC, which are often conducted by untrained "teachers", newly-minted "gurus" and obsessed "preachers" with practitioners unprepared for all this. Numerous adepts, as a rule, are ready to connect everyone to their practices and not for nothing. It is clear that no one will take the right to fit everyone and everything into one comb, because few people have all the information about possible generations of energy-informational states and the level of development of individual Entities, and even more so, about the reaction to all of this reviving CPS. **"SvetL" Technologies (Programs)**, as experience shows, can lead a person to the so-called states of **internal** "insight" that are not inferior to ISS, which are artificially pushed from the **outside** by teachers, gurus and preachers, for which they create their own "force" field. Moreover, through **"SvetL"** this internal insight comes when a person has solved the basic problems with his health, the formation of his energy and protective properties, when he is, as it were, on the way from the stage of HEALTH (healing, cure) to the stage of DEVELOPMENT; then the horizons of approaches to the information spaces of the CPS at the levels of other octave energy spectra open up for him.

And when the **configuration of the Brain** (even in a small part of it with the help of "**Light/SvetL**") changes, however slightly, to a **higher octave** level, a higher state than illumination occurs – when **the BRAIN BEGINS to KNOW ITSELF**.

Here is how this process is described by Boris Makov:

"How can the Brain know itself? It can know itself, but only if part of its **design** functions (smaller or larger – does not play a role) are changed to the **level of a higher octave**. This is not a state of insight or a forerunner to the state of any scientific discovery; it is a much more **perfect state by many orders of magnitude**, like the forerunner to changes in the **octave level of the brain as a whole**. This has yet to be done by people who are directly integrated into the future."

### **(B. Makov "Main functions of atmospheric layers")**

At the same time, **SvetL Technologies**, including in the system of psi-fields and the Essence of Man, works sequentially and methodically, step by step and gradually, on the basis of its own system of primary and current control scanning, leading to an increase in the potential of human life energy. Also, the **SvetLa** configuration provides for the **gentle effect of psi-generators** (primary materials, non-inertial energies) on users who, moreover, can themselves regulate the load. Therefore, one of the additional features of **SvetLa** is that it begins to act as a kind of **training complex for the gradual perception by the user of new psi-generations**. And, it is quite possible that after such "training" some part of passive neurons, for example, transforms into active ones. **But this is already an area of research of the future science of the new World Order, but there is no doubt that we will already learn a lot in the Transitional Period.**

Although, as it turned out, among the balanced processes against the background of SvetLa's work, there are unexpected surges, **or rather qualitative leaps**, associated with changes in the program settings of a person's essence and the intensity of the flow of incoming information.

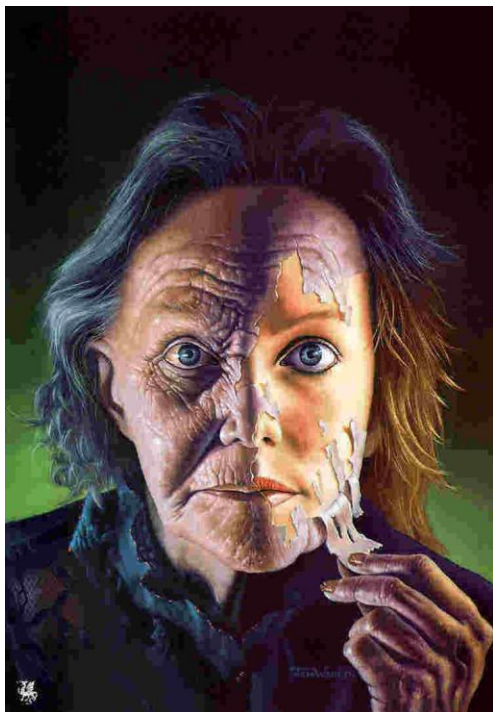
### **Example**

*A 40-year-old woman who had been engaged in one of the "Eastern practices" for several years had reached the level of the original healing practice. At this point, she became a Participant in the "SvetL" Programs. Just before the first inclusion of her personal "SvetLa" she came into "contact" with it, especially when she picked it up (at the same time other SvetL complexes were in the room). Immediately after the initial inclusion, there were the following impressions: "it's as if a whole layer of information was erased in my head, there was some sort of reset, and there is some pressure on my head." After installing the modes and programs, the level of 100% load could not be tolerated and had to be reduced to 10%. (The load level subsequently increased gradually and reached 80% in 2 months).*

*This is an exceptional case in itself, and this is probably recognized by the majority of participants in the "Light/SvetL" Programs, who, as usual, very easily withstand 100% of the load. What really happened? **There was not only a reset, but a change in the life Program. If you want, the "Target Vector" of the Essence has changed**, it has reached a different level of the octave spectrum of energies, corresponding to other spaces and information fields of the CPS, where qualities and properties of a different order are acquired, and the levels of load on the Brain are completely different, respectively. This was constantly **mentioned by Nikolai Levashov when he spoke about the transformation of the Brain**. And again, it can be noted that SvetL allows you to gradually move to a new level of load on the brain, performing both a training and educational function and energy information support.*

And here is how these processes are described by Boris Makov in his work "**What is the essence of "The Perfect Mind of Man"**":

*The true and effective meaning of this process, which results from its execution already under the control of the new System, is to "clean" the information blocks of the Brain (both at the level of its antineutrinal state and the states of matter of the magnetic energy of the Brain neurons) from the elements of past information, on the basis of which people's Consciousness and all their subsequent general current worldview were formed, including on issues of "their everyday arrangement".*



*The process of such general cleaning of the "information blocks" of the Brain is carried out by information substitution through a new energy-informational broadcast from one of the true Control Complexes, using the technical capabilities of the former Main Intervention Complex Chekhov, as the final control translator for this period of ongoing transformations.*

*The very "technology" of performing such "information substitution" is inherently surprisingly simple, but the initiation of people by their technical capabilities at the current level of development is **limited** (limited mainly only by the level of observation of changes in the states of neurons, etc.). **This is due to changes in the states of matter, magnetic and electrical energy of brain cells** (individual functional areas), and the program of "active state of interaction" of Brain neurons (neurophysiology has found some fragments of connecting neurons in some unknown scheme like a biocomputer), lymph, and much more.*

Thus, it is already possible to note the first noticeable manifestations of the impact of **"SvetL" Programs in such technology of "information substitution" and energy-informational translation from the native CPS**. It is quite possible that in the given example we have what is described in the **materials of the Research Institute "TsUS" and "RNTO" as "GIFT GIVEN" - the ability of the restored structure of the Human brain** to receive, decrypt and then apply higher-level cognitive information by **increasing the level of brain octaves**. At the same time, we can expect **changes for the better in the States of Consciousness and Mind** (as a form of matter of energy information), which should strive for harmony with The Earth's Mind in the entire range of octaves at this and all subsequent stages of development in the **Transition period to a new World Order**.

In addition, it is interesting to consider the dialectic of energy-informational support of "SvetL" from the point of view of analyzing some cause-and-effect relationships.

**Data from the RNTO** show that the use of "SvetL" Technologies can on average increase the life expectancy of a person today by at least 20 years. Moreover, the increase in life expectancy is not just a quantitative, passive, "retirement", but **an active state of continuing human development through increased Brain activity**. But, in turn, an increase in the life span gives a chance to reach a higher level of development of the entity, which will correspond to a higher spectrum of octaves of energy, and this, once again, will lead to an additional increase in the life span. For example, at low octaves of the brain of modern people (maximum **63 octaves**), biological extension of life for **more than 125 years** is impossible. By only raising the level to **82 octaves** will allow you to **extend your biological life to 250 years**. **"Fantastic!" – the reader will say, and I, as an Admirer, will say - "NO!" – THIS IS THE REALITY OF THE NEAR FUTURE!**

"The duration limit will ultimately depend on the speed of adaptation of the Brain functions to the new control programs for CPS.

**This is a kind of blow to the system of "reincarnation" (which started in 0 AD), which essentially led the development of the human essence to the state of "Inferno"**. And more and more people are exposed to this condition, not only in retirement age, but also of young people.

"SvetL" Technologies not only carry out health improvement (treatment, healing) of a Person, but also provide, first of all, activation of the Brain, changing the vector of a person's goals to a positive life-affirming basis, thereby diverting the Essence of a person from the edge of the inferno state. A Person has new interests and meaning in life (remember how **Nikolai Levashov** during his speeches with a special positive emphasis mentioned the letters to him from young people who finally have goals and meaning in life, pride in **the silent present past of our Motherland**). Due to the energy-informational **support of the "SvetL" programs**, a person develops and expands the potential for self-development, as well as self-realization of creative abilities. **Thus, the technical problem of increasing human lifespan through the support of "SvetL" Technology, reveals to man the possibility of a different order related to self-development and self-realization**, gives an additional chance to overcome the original quality of the barriers (according to N. V. Levashov) of "A Reasonable Person", and then "Highly developed man". And since the **development of a person at these two stages, mainly ACTIVE, OCCURS THROUGH ACTION**, in such cases, the karmic problems of a person are resolved, which in turn **were inextricably linked with reincarnation**[4].

And here it is important to understand that through the so-called esoteric Eastern teachings over the past 100 years, we have artificially tried to bring into the subconscious the individual character of karma (and its corresponding reincarnations) for each person. This reinforced the "guilty" state of each individual (the algorithm, in fact, is the same as that of religions) and solely his personal responsibility for his current incarnation. Of course, information about the violent management of the processes of reincarnation, associated in turn with the brain (and this is important!), interventionist system and its complexes were completely hidden and is now strongly suppressed.

**About the infernal and violent meaning of reincarnation, introduced since 0 AD**, by the Ebrov System as a new type of management, you can also read in more detail in the article "From Inferno-Fascism to the Doctrine of the New World Order".

We emphasize that since 2013.01.07 the previous format of the **"Reincarnation Program"**, associated with the manifestation of violence against Soul Essence, **has been eliminated and replaced by the TRUE ONE**, replacing the **"Apparent Ritualistic" Program** associated with mandatory merit of the previous phase of the development of the Mind (being of the Mind with the physical flesh to death)[5].

An important emphasis here is that this is not just a simplified change of one ideology to another within the framework of previously existing consumer perceptions of the world Order. This is the acquisition of a higher level of knowledge of the truth about the "Arranged World" by increasing the octaves of the Brain with the energy and information support of the native CPS, which allows a person to radically change the state of their Consciousness and find more perfect levels of development of the Mind.

As a result, based on the above material, it can be noted that the positive gerontological (healing, health-improving) consequences and energy-informational support of **SvetL Technologies** together create a **synergy effect (1 + 1 > 2)** and provide an opportunity for additional development of the **Essence and Mind/Reason** at the existing stage of being within the framework of the recreated **"Apparent Rite of Life" Program**.

At the same time, it is important to note that it is within the framework of this **"non-violent" program of the native CPS** that the **personal responsibility of each individual for choosing their own path of development (the vector of personal goals) in the Transition period** will be really important. And personal responsibility is based **on the energy and information support** that was **imposed forcibly or deliberately chosen**. This will determine your ability to integrate into the future. The recreated CPS programs provide for the integration into the future of each individual, **taking into account the achieved** (and not forcibly imputed) **level of brain octaves** during life, with the help of his **conscious self-control** in all matters of worldly and spiritual harmonious existence, awareness of his individual and associated functional endowment, **as a Man/Person of the Earth**. Here is how the principle of operation of the **"Manifest Rite" Program** for a person is described by **Boris Makov** in the work **"Is there a natural (without violence) way to replace "Violent civilization"?:**

***Before you are pure, you will also be pure in your Spiritual Essence. The present true Control System observes with increasing attention changes in the effectiveness and perfection of Consciousness, both individual and social. Any counteraction to the embodied Vector of the Goals of phenomena, actions and events through committed vices of an individual or group nature have a destructive effect on Consciousness, and after this, the "participating" individuals manifest various deviations in the functions of their brain to control and accompany the existence of the flesh cell (various essential diseases).***

***Each of these individuals liquidates itself, and some of them are forever deprived of the possibility of a Manifest Rite of passage, since such an unfit Soul Essence will be dispersed. Privacy on Islands or in bunkers will not save you from this! The fate of your present and possible future Revealed rite of Passage to the new physical plane - in the essence of the true creative pure works of the Creator, at this hour! (provisions from the "Laws of Life");***

***...The more detached from the objectivity of the truth of being, the less likely it is to demand the current and subsequent Manifested Rites in the physical plane (a provision from the "Laws of Life"[6])***

So, taking into account all the previous material of the article, it can be stated that under the previously existing Doctrine of Social Violence, the Main object of violence in the person himself, **was first of all, his BRAIN!** But since **2011.04.24**, the conceptual basis of violence is absent due to the fact that the change of "System Power" has been accomplished on the basis of the reviving true Earth Management System, which needs some time to organize the configurations of the spaces involved and to gain energy and information potentials at full capacity. On the other hand, the energy and information transmission from the former interventionist system, although it remains without conceptual support, is often carried out in a more violent form (the aggravation of all manifestations of Inferno-fascism). Therefore, in the materials of the Research Institute of the Central Control and Monitoring Center and the RNTO, the emphasis is made on the fact that without trustee support from the new Management System it will be fundamentally impossible to change individual and, especially, public Consciousness, in practice of the Transitional Period.

As B. Makov notes, one of the deepest secrets for a person in the **Transitional period** is the awareness of the fact of the occurrence of a physical process, in which a **harmony is formed** of the internal states of the functioning brain and the **external states** of its control, which is, like a basic foundation, for gaining a miraculous mystery - stage-by-stage filled perfection of the **states of Consciousness and Mind**. SvetL technologies are precisely designed to contribute to the formation of such harmonies (primarily at the corresponding octave levels) between internal needs for improving the individual's brain (states of Consciousness and Mind) and external energy information broadcasts of control from a resurgent native CPS (Source of Life).

Therefore, the significant role of SvetL technologies (associated with the work of the brain) in our lives is also determined by the complexity of **the Transition period to the New World Order**, which at this time cannot be realized by the majority, but must certainly be taken into account by a group of individuals who actually let go to realize this for a number of reasons independent of them! More accessible technologies for people in the broad sense of the word are the new carriers of the SvetL Programs - “bracelets” made of 925 silver and made of alloy steel with a “silicone” strap.
