

The main functions of the atmosphere

BASIC FUNCTIONS OF THE ATMOSPHERIC LAYERS,

as part of the System for Managing the Performing Activities of People and the Formation of Their Consciousness

To this day, many scientists in the world continue to be in a state of searching for answers to a very important question in people's lives – how is consciousness formed, both separately for each individual, and public consciousness in the environment of a certain community of them? What is consciousness in general, as such, whether the process of its formation is natural, as it was previously understood, or controlled from the outside, but not in the sense of active administrative and technical influential participation of a certain political propaganda in any form of its manifestation.

The generally accepted hierarchy of qualifications for types and types of consciousness, saturated with "professional" definitions from representatives of social and medical Sciences, psychologists and other specialists, ultimately did not allow people to clarify, to their full understanding of what consciousness is. Moreover, the question of how the mental and thought processes are carried out, what is the brain and how it is actually structurally arranged and functionally multi-faceted, remains very problematic to this day. If people's brains are almost all the same (from the point of view of medicine), why are they all so different in their judgments and actions?

Many advanced scientists, thanks to the acquisition of modern technical means of observing and recording various induced reactions and changes that occur with the human brain when exposed to influencing factors of a diverse nature, are convinced that some patterns, from the number of reactions recorded by them regarding its factorial physical state, do manifest themselves and this not in dispute. But the experimental material obtained so far does not allow us to come to a consensus of opinion, and, first of all, in the environment of different areas of science.

Oddly enough, theologians and founders of judgments about this, based on the basis of religious dogmas, were closer to the truth about the essence of consciousness itself. They, though with apophatic vagueness, but without guile, declare that consciousness is given by the most high, and people are "Only his mouth and everything created by them, is the Creation of God." In this there is a much greater approximation to the truth than any other judgment, and for the most part through no fault of the people themselves. Many modern scientists more and more often express the modest idea that the "Creator of the Created World" himself is far from indifferent to people's acquisition of their rational state.

The consistency and impeccable timeliness of the level of knowledge about the things people do and events in certain areas of their controlled existence throughout the previous history, is simply striking for its pre-emptive event accuracy in time.

We do not need to make any attempt, even a superficial overview or coverage of the traditionally recognized essence of all the formed definitions in relation to consciousness, as well as to recall some recognized list of functional abilities of the brain, put forward by current scientists from the field of medical, social and other sciences, because they are definitely available to everyone interested in this. In the framework of our research, such an annotated excursion is of little interest.

Closed studies conducted by specialists of certain scientific fields practicing in many countries of the world, with the aim of gaining various options for actively influencing people with the intention of imputing to them forms of control over them through hidden violence against consciousness, would partially be of interest. But such experiments have not yet given a general true picture of the states of the human brain, although factual material is indeed available on the manifestation of the features of a certain temporarily controlled behavior of the experimental subjects. Unfortunately, these studies also failed to form the basis for a deep new understanding of the truth within the framework of questions about the hidden constructive structure of the brain, its full potential for functioning, the complexity and consistency of its states in the formation of knowledge and consciousness, registration and induced objectivity in the process of forming different or unified conclusions about the world around us, etc. Such experiments convinced the initiators of only one thing – no one has yet managed to be forcibly smart, and it turned out to be easier and more profitable to breed performers of a certain unreasonable forceful nature for the subsequent limited use of experimental subjects with the use of other simpler methods of influence, using only human vices and personal interests as the basis.

The most important thing in a deep understanding of this question is the following, namely, are people independent in their rational functioning in the organization of their being and its corresponding gradual development, or are they dependent on various forms of some external control outside of them? To this day, in the sphere of secular and scientific judgments, such an apophatic problem still remains unknown.

To this day, in the sphere of secular and scientific judgments, such an apophatic problem still remains unknown.

Orientations of judgments and research in this particular way can bring us closer to mastering some systemic deep secrets about the real structure of the brain, its true state of the “reasonableness” granted to it and through it, which determines the current level of knowledge and the degree of its civilizational development, including awareness of the fact about the

functional purpose of the Man of the future within the framework of the ongoing changes on Earth, not limiting the depth of his judgments to the past framework of the “philosopher's stone”. Future thinkers will have the opportunity to overcome the now stagnant limitations in judgments on the essence of spatial coverage in the knowledge of the world, dictated by current philosophical laws.

First of all, it is for this reason that we were allowed to understand how the old interventional System previously managed all the people's existence and their level of knowledge from outside through their brain, which was structurally arranged for this purpose by it (the System), with what forms of influence it was possible to activate various functions of the brain, how it was improved by stages of development of the general and event chronoprocess? This will make it possible in the future to learn at a different level and much more, bearing a lesser-scale private character, including the knowledge of what consciousness is, how it was formed and how it changed at the stages of historical development and so on.

In this regard, we will be greatly helped by the results of research on the issue related to the true Construction of the Atmosphere and the control functions assigned to it, which were given to its lattices by the old Control System, including in the processes of formation of consciousness and public consciousness.

The main functions of the Atmospheric layers imputed by the interventional System

In the scientific community, the former selfless confidence in the unshakable firmness of the supposedly “natural basis” in the whole essence of the existence of the world around us, including the natural self-development of nature and the same natural outcome of the process of harmonious improvement of Civilization, including people, remains less and less. And much more.

Finally, science has begun to think about the problematic questions – who or what, over whom or over what, is exercising some mysterious control that is beyond the reach of our consciousness, and is the very fact of its existence? If there is such an apophatic control of people's consciousness over them, and if there is such a control, then how does this happen in the physical plane of the process itself, as such? How is the harmonious development of all the diversity around us in the material world and non-material States of energy achieved in a systematic way? Perhaps, instead of asserting nonsense about the need for the existence of natural “food chains” throughout the biological environment, there are some more serious reasons for the existence of such a vast variety of entities of biological species? This is just a small part of the variety of issues related to unknown management for us. Is there any way to correct the specified state of comprehensive management? If so, what place is assigned by fate in this current correction of States to people in the future, what will happen to them and what is permissible or necessary for them to take now to save their lives and be claimed on this planet, and not at the level of the current consumer prolific “animal husbandry” for their own good?

How did it happen that over the long period of existence of life on Earth involving people, understanding the essence of the physical processes taking place, allegedly of some kind of “self-development”, is shielded by a dense curtain from people's in-depth knowledge of why the “surrounding nature” turned out to be so apophatic for “thinking people”, because they have already won everything in "Nature" to an irreparable state? Why and who isolates them from such knowledge?

It looks like this: the deeper the World is "known", the more questions arise about the physical nature of the process of its existence. Most of the old basic constants and dogmas, both scientific and religious positioning, crumble to dust, and the "new" are not always presented intelligently and meaningfully, often taking inquisitive minds into esoteric worldviews, demonism, cosmopolitanism, and so on, forming an even greater inaccessibility to the truth, bringing such unstable knowledge to a state of complete apophaticity relative to it.

We can also define such facts as the destruction of previously stable States of knowledge as the supposedly natural outcome of the general process of development, but is this true about the true essence of everything that happens around us? Only one informational circumstance justifies the active formation of an infinite number of questions in most thinkers. This is also a judgment, though only of a staged nature.

There is only one way for us – finding the truth about the "Created World", which will allow us to dispel the apophaticity of knowledge about people, at least, as some intelligent beings from the entire variety of entities of the biological world, and will push to develop the general level of the former stagnant state of knowledge about the world around us in general. Is it possible at the current level of the brain octave, the state of its functions and the corresponding consciousness of people, if it is possible, what people themselves can do for this?

As part of our research on the narrow topic of problems of [forming individual and social consciousness](#) of people, the nature of its current state, in connection with the ongoing systemic processes of cardinal changes, we will limit ourselves to considering only a separate part of knowledge about the "Created World", namely, the construction of the [lattice Structure of the Earth's Atmosphere](#). Rather, we deliberately restrict ourselves to only some of her dowry basic management functions, to ensure the existence of human life, imputed to the Atmospheric grids as an important element of the overall "alien" Control System of development processes of Civilization on Earth, brought by Interventionists.

All the true layers of the Atmosphere, as a complex harmonious Structure from a strictly identified set of its energy grids, were formed during the model creation of the Earth, i.e., the formation of a certain part of the non-created "Created World", as a whole. This true layer-by-layer structure of the Atmosphere provided, first of all, the very existence and management of software (gifted) "[living Conditions and Managed environment](#)", which in turn basically founded the very fact of "origin" and existence of the true Life itself, with its orientation on a "reasonable basis".

Moreover, one of the mandatory conditions should have been - only such a specific construction of the Atmosphere and, at the same time, an important closing link in the formation of the mandatory conditions for ensuring the gradual development of the [Earth's Mind](#) and its unconditionally, very important hypostasis, the [Human Mind](#). There could be no other harmony in the process of development of a true Civilization on Earth, and everything else is impractical, i.e., harmful for intelligent life. This is its true programmatic essence and its embodied civilizational essence.

For the Earth, as a specifically identified model complex-a planet that is located by its functional endowment in the General Hierarchy of planets programmatically oriented towards the development of Civilizations of "Reasonable Orientation", the following is provided (enclosed). The whole embodiment of the most difficult path in the development of its Civilizations, should be carried out in eight consecutive stages of an increasing level of perfection with a certain measure of event time during a phased program chronological process, achieving on each of them the full perfection of a harmonious "being of energies" within the strictly defined limits of the octaves of these energies for each specific stage.

Such a complex development process, in the harmonious existence of energies, provides both its own programmatic capabilities for managing the entire chronological process using its Earth Control System, as well as the possibility of "external" assistance and control under conditions of limited outside interference in the management process under guardianship. More in-depth details on the above issue at the moment of narrowly thematic judgments are not fundamental.

By the time of the interventionist's takeover of Earth (elements 1-4 "fundamentals of the Formation of Mankind"), it was only in its first stage of development of civilization, providing the margin of attaining its perfection at "the entire spectrum of the arrangement of life" from octave energies equal to from 12 to 512 octaves. Our Earth is imperfectly young by the standards of a different kind of time. It is within these limits of energy octaves that the entire true "Created World" was formed for the planet Earth, as it begins its long path of perfect development, having a "gift given", a unique state of life – [a step-by-step controlled aspiration to "Intelligent orientation"](#). This "natural" state of the developing energies of the being, corresponded to the construction of its harmonious and strictly identified Structure of energy lattices (identified dodecahedral structure, i.e., Di – structure). The process of development was under the unified control of the Earth's own Control System, programmatically focused on achieving perfect harmony of the "energies of the being" of the entire planet in their material and non-material States.

An important feature should be noted. The origin of the very process of Civilization development for planets that have specific life on each of them and are located in the General Hierarchy of planets of "Intelligent orientation", must have some imputed mandatory condition for them. As such, a mandatory condition, connected primarily with the fact of recognizing the achieved level of their perfection in their development and transition from stage to stage, is the mandatory achievement of the necessary level of perfection of the [Mind](#) of such a planet.

Achieving only one harmony of the energies of being in their material and non-material States, is far from sufficient to recognize the corresponding level of development of Civilization on the planets that have life. Lives are many, but Minds are few!

Other planets that do not have "living conditions" are programmatically predetermined for a limited process of their perfect development or lack of it at all. They are functionally applied as: "warehouses" for accumulation and storage of any forms and types of energy in their different States; as producing generators of something under someone's control, including information of various kinds; or performing various types of protective, utilization-generating, experimental functions, etc. They are accordingly equipped with their constructive form and content in a completely different way, in contrast to the planets that have living conditions, but harmoniously their identified function. Each planetary, galactic, intergalactic, and other cluster systems, requires its own specific component elements from the planets, and their diversity and composition depend on the functional purpose of this cluster level.

For the Earth in particular, the development of the planet's Mind without its fragmentary hypostasis, i.e., without a harmoniously developed human Mind – as the very fact of recognizing the perfection of the level of development of Civilization, cannot exist. Consequently, there can also be no transition to the second stage of development, which provides for the rise of the upper permissible level of energy octaves from 512 to 1,024 octaves, etc., by increasing discreteness, i.e., there is no movement in its development. For this reason, the recreated Man is important precisely because his associated Mind is an integral hypostasis of the planet's Mind, without which the latter is not complete. However, the Human Mind is not independent, because it can only develop in the process and through the development of the planet's Mind, and it is mandatory when the indicated process is accompanied by the true Earth Control System.

In this regard, any legends about the development of an alleged fourth Civilization on Earth are not true and are provided, i.e., embedded intent (on the part of the interventionist's Eber System), since there is no true basis for such judgments at all. They have not yet completed their first "native" system and brought it to perfection and harmony, since 18,000 years ago such development was suspended by the intervention of an alien System!

This complex process is the true essence of integrated development of Earth Civilization (yet in the range of 12-512 energy octaves), has now begun to recover in all its true states and directions, both when accompanied by the native Earth Control System, and with external guardianship assistance from outside by more developed Governing States and Civilizations. At the same time, all consequences of former interventionist's constructive and managerial interventions, are being actively eliminated.

The final change of the System Power has already been completed, since 2011.04.24. This is the physical meaning of the beginning of the current processes of all changes on Earth.

We were allowed to give some information about the gradual detailing of future changes, along with the conceptual essence of the "Goal Vector of future phenomena, actions and events" (Providence #5 of 2012.10.01) for the entire complex of corrections for the states and spheres of energy existence, including the changing organized existence of people. The current speculative effects of changes occurring, from the cataclysms on our planet to the observed changes on the planets and satellites of the planets around us – are still only a minor, but rapid start of the beginning of all upcoming corrections. The process itself will be very short, relative to the states of the event tact (time) of the material world.

The most complex true Construction of the entire layered structure of the Atmosphere before the intervention, contained a complex of energy lattices, in which each layer was supplied its own complex set ("recipe") of energy frequencies from 12 to 224 octaves in the main and even individual elements up to 512 octaves (only from the Di – structure). Such a layered energy Structure of the Atmosphere lattices ensured the formation and retention in a given program harmony of all the different, but at the same time and specifically necessary variety of progressively developing harmonious existence of energies in their immaterial and material states. At the same time, gradually and strictly relative to the set time of event and the framework of the general chronoprocess, the process of improving the existence of energies as a whole and in harmony with it, – the development of the Mind of the planet Earth and the Mind of Man.

The Mind itself is not something undefined and formless, i.e., an unconstructive, unmanageable and unsystematic existence of energies. Mind is also a Complex of a special functionally differentiated being from all possible limits suitable for controlling octaves and states of energy over the energies of other octaves and their states, in relation to each specific stage of the development of Civilization. Template-machine, i.e., some kind of mechanical "software-computer" or limited system-mathematical approach to methodological forms of awareness and attempts to judge the Mind, is not acceptable in this case.

It (i.e., the Mind), in its development acquires the same step-by-step improvement of such program functions and abilities to manage all the processes of development of Civilization in general, which were imputed to it even during the model formation of the planet Earth. It has the properties of control and self-control; functional management abilities; states of various forms of contact, including with individuals, objects and complexes of Control and Support; transmission, reception, decoding and storage of information and essential conditions for a completely different level of definition of "Life", as a form of being and state of the complex from the entire "set of energies", as a program true essence, which plays the role of leading orientation and control over the "correct" development of Civilization as a whole. This is not a spontaneous process at all, but a specific objective and pre-oriented target process of developing methods and forms of management, which are only improving with each stage. And most importantly, the Mind is material, because part of the Mind structure of our planet is represented by "matter of magnetic energy" within certain limits of energy octaves!

Moreover, this matter has the ability to move and at the same time has no obstacles in its movement, the speed of such movement is many orders of magnitude higher than we understand and compare with the speed of light (photons).

How can the lower know the higher? A question that would seem impossible to answer, ever. Not quite so, since the lower can only know everything with the help of information support, management and control from the higher state. It is also necessary to answer the previously unanswered question: how can the brain know itself? It can also know itself, but only if part of its constructive functions (smaller or larger – does not play a role) is changed to the level of a higher octave. This is not a state of insight or a forerunner to the state of any scientific discovery; it is a much more perfect state by many orders of magnitude, like the forerunner to changes in the octave level of the brain as a whole. This has yet to be passed by people who are directly integrated into the future. But this is as some useful deviation in judgment.

But we will make judgments about this only in the form of a superficial touch, and only in part and in relation to the topic of our research. It is enough to ask yourself questions of an unusual sound for science - what kind of Intelligence could the interventionists bring to our planet, how and with what constructive and functional orientation did they develop it, what kind of Intelligence were imputed to people and with what subsequent program goals, why did they need people in general and precisely with such a state of Mind, which was presented and imputed?

We will try to answer these questions for the first time, if possible (with restrictions), but first of all, we need information about the Constructive interventionist's construction of the Atmosphere, which played an important role, in this regard, in their "Created World", providing mainly living conditions on Earth that are acceptable for "interventionists".

This part of the "Created World", as well as in religious and scientific dogmas, is more commonly defined as a kind of apophatic Heaven, which really has a huge set of not only a certain mixture of supposedly necessary gases for life and the miracles that occur in them, but true majestic mysteries that are still unknown. It is enough to list such, hitherto not known, the manifestations and effects of physical processes in the Heavens, not playing a leading role in their own "Heaven" at all, as thunder and lightning, northern lights, the origin of systemic and non-systemic air flow, rainbows, precipitation, a sounding and terrifying rumble that has now appeared in certain regions of the planet and so on. But at the moment, the presentation of the essence is not up to scientific or religious lyrics.

Therefore, let us return to the consideration of the arrangement of the true Structure and the relatively incomplete set of all previously established functions for the layers of the Atmosphere. The fact is that this issue is a very narrow specialization in the management of life on Earth as a whole, which significantly affects the essence of transformations in the near future.

It is not subject to public judgment in the conditions of residual aggression, as a complex interconnected state of the imputed brain functions of individuals with a certain brain genotype, automatically forming the previous level of consciousness of some people of the present time, who carry the "scars" of imputed vices and violence.

The current, i.e., limited judgment about the construction of the Atmosphere – is only a superficial component of the general knowledge of the uncreated "Created World", limited by the scope of the declared topic.

After the capture of the Earth, the Designs of energy grids of all layers of the Atmosphere were thoroughly changed by the interventionists, by imputing the "imported" basic energy octaves and their installation forms according to the structural arrangement of the energy grids, but only in the range of 15 to 128 octaves. The fact is that in the general escort of the interventionists, three moons arrived. But during the self-destruction of the planet Phaethon, the most perfect two were eliminated. For this reason, the limit of "delivered" octaves of basic imported energies is limited. Within the specified limits of the octaves of energies, all true (child-born) structural filling of energy lattices in the Di-structure were completely destroyed in layers and replaced with a cubic, i.e., k-structure. But, from 129 to 224 octaves, the true native base energy frequencies across all layers of the Atmosphere remained in the same structural state (Di-structures), as a fact of inaccessibility in its element design, due to the limited technological destructive capabilities of the interventionists. However, for all this time (i.e., for 18,000 years), the potentials (potential density) of frequencies in these true energy octaves (129-224 octaves), without being in a supported state of energy "recharge", were approaching zero and by December 2012 should have disappeared (destroyed according to the plans of the interventionist's program). And the structure of the Atmosphere after this fact of destruction should contain only imputed k-structures up to the level of 128 octaves. This would be an irreversible final captive state of the Structure of the Atmosphere, in the case of which the Earth would actually carry out its self-destruction in general.

All information about the fantastic "horror of Hollywood scenarios", symbolizing a certain "Apocalypse", really through different representatives (mainly individuals of 423 and 441 brain genotypes), was transmitted earlier by the interventionist System over the past few centuries, as a kind of providence of various Armageddons (taking into account the confessional-ethnic and geographical differences). But this process of managed maintenance has also been eliminated now, i.e., after the change of the system authority. The automotive efforts of the media, focused on Hollywood scenarios of the "end of the world", are futile. And the very process of eliminating the consequences of intervention in terms of a new arrangement for recreating the Atmospheric energy grids and bringing it to its former, i.e., "virgin" state, occurs without their intervention and not by their will and efforts, but according to the true scenario, that will be even more stringent than the framework of the fantasies of their crafty "filmmakers". Therefore, the Apocalypse has not only begun, but is proceeding successfully at an increasing pace. The non-essential part of its manifestation, that is, the outflow of energy octaves in material states is observed and will continue to be observed by people during the entire Transition period.

The thicknesses of the Atmospheric layers were also changed for all the basic parameters adjusted by the interventionist System to suit the design of k-structures with the imputation of only their own communication frequencies, which could provide, among other things, a stable and controlled information contact with their satellites, the Moon and the Sun, i.e., with their entire interventionist fleet of planets. In addition, the entire technical development of the intervention system was accompanied by the introduction of such established new frequencies into those layers of the Atmosphere in which only their "technical system transmission" of energy-information support of all their controlled and organized energies of being would work, as an imitating process of the development of a supposedly Earth Civilization, as a whole.

Moreover, in the former (native) true layers of the Atmosphere, additional special design changes were imputed. For example, with their help, all conditions were created for receiving tritium from the satellites of planets (as from transported "warehouses"), so necessary for the functioning of their objects and complexes, as the only acceptable form of energy consumed by them. In addition to the fact of receiving such a form of energy as tritium, it was still necessary to transform it, store it in acceptable energy states, suitable for use and, dosed, distribute it, both for objects (conditionally called UFOs) and for biostructures, and precisely those that they managed to materialize for their plans only and for their subsequent program needs. In addition, it should be noted that it was through the use of such accepted necessary and converted tritium, that the general process of reincarnation of the entire structure of the energy-informational arrangement and the state of all types of differentiated water on the planet was also imputed. And through their changed complex state of water followed the most important changes in the formation, maintenance and management of all complex conditions, without which the existence of all life on Earth would be impossible, including the implementation of the imputed program of "Synthesis", both for the entire biological sphere and flora.

And this is not all that has been affected by the modified design of the Atmosphere's grids in all its layers. All together – it was no longer the true "Created World", which of course, changed and distorted everything on our planet. Despite such major structural changes with the planet Earth, It has maintained its position in The General Hierarchy of Planets of Reasonable Orientation, but in reality it has been undergoing a process of "imitation" of the development of its Civilization over the past 18,000 years.

It is also necessary to note an additional, but very important point. The changed design of the Atmosphere would also have to be such an environment in which various mobile devices of ground and sea placement (so-called UFOs) brought in by Objects, could move safely (i.e., accompanied by energy) and without hindrance, performing part of the control function of the interventionist System over all the processes and states of energy, including in the material world, and including the entire biological environment. Such various types of UFOs could only use tritium for "fuel", placed in the same environment during their ascent, and could only move in the Atmospheric lattices (in the environment), which must necessarily be built on the basis of k-structures. In another construction of the lattices they can't move.

The main storage facilities for imported tritium were located in large bodies of fresh water (mainly in lakes) and were dosed into the atmosphere, guaranteeing the level of its required state. Tritium, which is in an unbound state in seawater (the Hydrophone layer of the Atmosphere), played a completely different role, it was used for sea-based UFOs. Sea water tritium in large quantities was used in particular by the Control Complex located along the East Coast of the United States and Canada (The Bermuda Complex, the interventionist System). Its delivery was carried out using a controlled ocean stream (current), which is called by oceanologists as the Gulf Stream. The specified ocean current was finally liquidated in 2011 in order to localize the actions of the Bermuda Complex with its further liquidation.

In addition to the above, the planet Earth, with all its energy potential, was also a unique power and versatile generating source. It was "forced" to provide its energy capabilities of generating complex states, providing the transfer of energy of individual octaves for the operation of various interventionist's Complexes on the Moon, the Sun, and partly on imported satellites of planets. To transmit a large volume of such generated energy and organize communication with its "violent consumers", a special design of the Atmosphere was also required, which could make the Earth generate energy, accumulate it, "transfer" it in a timely manner on command, take its return part back in a modified structural state and distribute it to interventionist Complexes and Objects located on Earth. For example, the functioning of the "Corona of the Sun", as the Atmosphere of this planet, was largely carried out due to the transferred energy from the Earth (in the 54th octave). And partially returned energy from the Sun (in the octave 54.25-54.35 + mantissa, as the radiation octave), provides, among other things, "illumination" of our planet, again with the help of the Design of grids of the changed Atmosphere. This is not a complete list of imputed functions that were performed with the help of the introduced Atmospheric Design. By the way, the Northern Lights are a phenomenon from the field of physical process, which is associated with the above-mentioned flow of the transfer of energy. More precisely, this is the process of afterburning "excess energy", previously accumulated annually for eight months, but left after the completion of the process of sending to "consumers" (management through the Ural Complex). It was impossible to store such volumes and in such states of energy in the Atmospheric lattices for longer periods, and it was not provided for by the interventionist System, so they were forced to "burn", as unsent surpluses. Thus the energy generating capabilities of the Earth were poorly applied. This is the true essence of the physical annual phenomenon (in the past), mesmerizing the eye – "Northern Lights"! This is not the only example of wasteful "management" on the part of interventionists on the application of the Earth's energy capabilities, related to the features of the imputed Design of the Atmospheric grids.

In general, this complex process of replacing the entire Structure of the energy grids of the atmosphere with an alien (imputed) one instead of its true state, was of fundamental importance for the Eber System. Because it was through such changes that other living conditions were arranged, which were necessary and suitable, first of all, for themselves, and subsequently for all those whom they managed to adapt to materialize, including the people they needed during the period after the almost complete elimination of all life on the planet Earth.

It is very sad and indecent for all of us (people) living in the "present past" to realize, but it should be noted that they (the interventionist System) needed people in the exposed form of their unique flesh and surprisingly perfect brain construction, from which it would be possible to create exactly what was suitable and acceptable for themselves (the interventionist Eber System) and their further program goals.

Moreover, created in their own design feature, the Brain of the Control System, as a necessary set of control for their imported Complexes, Objects, built on-site Systems, arranged communications between them, located in the layer: -4400 to -2200 m. - all this allowed them to serve and accompany only such a state of control of their organized existence of energies, which the interventionists assigned to their program goals and intent.

This condition and the state of the entire Control System, especially in terms of controlling the processes of energy being, including the development of the entire biological environment, predetermined the imputed state of their material application to people's performing actions. This state of material use of people gave the entire process of development of their Mind a strictly limited and isolated, from the truth level and direction, dosing the information process of knowledge relative only to the interventionist's general programs: "energy-Informational development of brain genotypes and the Development of energy biogenesis of the flesh." This is how the outflow of all program processes for the development of the imputed interventional Civilization was arranged and implemented, dividing it into certain stages of event time, as a single chronoprocess.

All communications with the entire control system for external contact (planetary satellites, the Moon, the Sun) were carried out on a model scale of the planet Earth, but only for the purpose of functioning of its interventionist system and only for its programmatic development. Through force they did not allow any other development process, and everything was strictly controlled. Not only from such an important starting point as the created interventionist structure of the Atmosphere, but everything else was formed only for their own habitation, existence, management and development of its own, imputed to the Earth civilization, and not such a one that should have resulted as a program truth under the original model creation of the planet Earth.
