

On the Question of Democracy or the Theatre of the Absurd Continues

Democracy... democracy – how much meanness and lies are hidden in this word!!! My definition of the essence of democracy will probably surprise a lot of people! But after learning why I gave such a definition of democracy; the reader will be even more surprised! I'll start with the very concept of **DEMOCRACY!** Democracy appeared in a slave-owning state when slaveholders came together to develop a single set of rules and laws in order to better manage slaves! Yes, they came together in order to create a unified code of laws and regulations in order to better manage their slaves, and so that there would be no differences in this matter among individual slave owners.

It is probably not worth explaining what and whose interests these laws reflected in a "free" and "democratic" slave-owning state. And although they will immediately try to explain to you that the word **DEMOCRACY** originated from the Greek word **DEMOS**, which means **PEOPLE!** But, at the same time, as is often the case with sufferers of memory loss in the right places, they will forget to add that only free people, the vast majority of whom were **SLAVE OWNERS**, were considered **DEMOS** or people in this state! And they will forget to inform you that the main population was made up of **SLAVES**, who were not considered people either! Isn't it true that little has changed since then?!

But that was a long time ago, a lot has changed since then, some will argue. Has it changed, that's the question?! If anything has changed, it's only for the worse. In those ancient and not very ancient times, slaves wore collars with the names of their masters around their necks. Hooray, no one has a slave collar around their neck today! You can now be happy. But don't rush to celebrate freedom. Is it just the collar? Whether there is a collar around your neck or not, little changes, except that there are excellent conditions for cheating slaves! And these are not just words! In the most "democratic" country in the World – the USA, 90% of the population lives in debt, and 70% of this population will never be able to pay off their debts! Isn't that **SLAVERY?!** Moreover, a working person, if he or she does not lose his or her job, will have to pay several times more money than they get. That's if he doesn't lose his job. Losing your job means losing everything. In such a situation, a person will do everything to keep his job. To be more precise, he will not do anything that could lead to the loss of this very job.

And who gets all these multiple payments from a working person? Modern slave owners are **A FINANCIAL MAFIA!!!** Modern parasites that fatten on society! And again, this is a relatively small group of people, only a few hundred thousand, in relation to more than seven billion people in the world! And the United States itself is a **PARASITIC STATE!** And again, people are being fooled like the most brazen scammers, declaring to the whole world that the United States produces as much as **20%** of the **WORLD'S PRODUCT!!!** Which is actually a lot for one country, if not for one small "BUT"...

This very country **CONSUMES ON AVERAGE 45%** of the same global product, **AND IN SOME TYPES – UP TO 90%!!!** And every time there were crisis situations with such a parasitic organization of production, the financial elite of the United States, or rather, the World government, which is really behind all this, unleashed World wars. It was they who unleashed the First World War of the 20th century, and were behind the revolution in the Russian Empire in 1917, after the robbery of which their insatiable belly was stuffed to the brim for a while! They were behind the Second World War for the same reasons. And it is they who are trying to unleash World War III for the same reasons. I described all the nuances of the formation of this Global parasitic system in my book "**Russia Viewed Curved Mirrors**", which social parasites hastened to declare as extremist! But I will return to this a little later, when I touch on the "freedom" of speech in "democratic" states.

Before continuing my story, I will remind those who have already forgotten and explain to those who did not know anything about the basic foundation of the economy, that there are only two types of economies, or rather three, but the third one has always been "for some reason" hushed up. So, **THERE are TWO TYPES** of economies that you can read about in any economics textbook. This is an economy with **SIMPLE REPRODUCTION**, when society produces as much as it consumes. And an economy with **EXPANDED REPRODUCTION**, when a society produces more than it consumes and the excess is used to exchange with other societies for goods that this society does not produce. It is with expanded reproduction that commodity-money relations arise. And the **THIRD TYPE OF ECONOMY**, which cannot be read about in any economics textbook, is a **PARASITIC TYPE OF ECONOMY!**

So, the **THIRD, PARASITIC TYPE OF ECONOMY** is the UNITED STATES. And this became very clear to the whole World in August 2011. **THE OFFICIAL DEBT OF the UNITED STATES** (and there is also an unofficial one) had reached a **SUPERCritical STATE!** The government of this country is not only unable to pay off the external debt or part of it, it is not even able to pay interest on this official foreign debt!!! And the whole World was waiting with a shudder... waiting for what the US Congress would do. As the days passed, the tension grew, and the global stock exchanges began to shake with fever. Everyone was waiting with fear for the US ship with a huge hole below the waterline to go to the bottom and drag many away with it. And so, on one of these August days, a truly "Solomonic" decision was made, literally and figuratively! The US Congress had decided **TO INCREASE THE EXTERNAL DEBT BY ANOTHER TWO TRILLION DOLLARS!!!**

And everyone immediately calmed down, the stock market fever evaporated, everyone breathed "freely". The US ship is afloat again! But after all, this decision only worsened the state of affairs, and those who made such a decision understood this perfectly well. They just needed to buy time in order to unleash the Third World War, which would save them, or, even better, with the help of well-practiced and tried-and-tested orange revolutions around the world, completely and definitively enslave Russia and turn indigenous peoples into completely disenfranchised slaves, physically destroying most of the Rus.

And this issue of parasites has been worked out and tested on the indigenous inhabitants of North America. When Christopher Columbus "discovered" America, there were **2,200 TRIBES AND PEOPLES** living in North America, and its population was about **TWENTY MILLION PEOPLE**, about the same as the inhabitants of Europe. By 1997, **1,700 TRIBES AND PEOPLES** had completely **DISAPPEARED** in the United States, and many of the tribes and nations that had been driven onto reservations had only a few hundred, and sometimes a few dozen people left, and the entire indigenous population of the United States numbered only about **EIGHT HUNDRED THOUSAND PEOPLE** in 1997!!! Moreover, American Indians are driven into reservations with the worst lands, into deserts and semi-deserts. And if mineral deposits are discovered in these poor lands, they are driven even further...

Approximately the same is prepared for the indigenous peoples of Russia, not only the Rus. And if any of the representatives of the small peoples of Russia fell for the bait of Western propaganda and thinks that they will only touch the Russians they hate, then they are very much mistaken! Over the millennia, social parasites have worked out very well the methods and ways of the collapse of countries and their enslavement. Why go far: when wars raged in the Caucasus in the 19th century, which were financed from England through Turkey, after the failure of this provocation, the leader of the rebels Shamil took with him **ONE HUNDRED THOUSAND FAMILIES of MOUNTAINEERS** to Turkey. That's over a million people! But in the land of co-religionists and allies, the highlanders turned out to be useless to anyone. They were given the worst lands to live in, which no one needed even for free, where most of

the highlanders died out quietly, and the rest were forced to assimilate, forgetting their native language and culture! But apparently, few people have learned such lessons, if we see that even today social parasites skillfully incite small indigenous peoples against the Russians, allowing representatives of these peoples, who sold their souls to them, to do all sorts of insensitivity towards the Russians when, under the patronage of the authorities, Russians are killed, girls and women are raped. But as soon as the Russians fight back against such criminality, the Russians are immediately accused of chauvinism and extremism, with all the ensuing consequences...

But the authorities of modern Russia do not pay attention to what they do to the so-called Russian population in the former Soviet republics, although in the "fraternal" republics of the former Soviet Union, Russians and Slavs are generally cut out, raped, mocked openly, and when the Rus, robbed in the most direct sense of the word, ask for Russian citizenship, then in the best case they have to wait for this citizenship for years. But those who robbed them and who mocked the Russians received this citizenship quickly, paying whom they needed. And so the citizens of Azerbaijan and other republics of the former Soviet Union became citizens of Russia overnight. And this is also a "democracy"! Only "democracy" is already in Russia!!!

There are practically no ethnic Russians left in the so-called Republic of Chechnya, only Cossack villages are still holding out, although there are few real Cossacks left, but they were able to organize self-defense, and Chechens do not risk meddling in Cossack villages. And in Grozny (by the way, a city built by Russians, not Chechens) there are practically no Russians left. Those who were not slaughtered by the Chechens, having abandoned everything, fled to Greater Russia, but the immigration authorities stubbornly returned the refugees to Chechnya so that they would still be slaughtered by the Chechens. And the authorities of the Russian Federation turn a blind eye to such lawlessness, just as the "irreconcilable" fighters for human rights in the European Union turn a blind eye to the gross violations of human rights in the Baltic republics, especially in Estonia and Latvia! Russians in these republics are deprived of almost all rights, but no one notices this! It can be seen that for human rights activists, Slavs and Russians in particular no longer exist, they died out like dinosaurs and turned into ghosts! But they were obviously in a hurry to write us off! There will still be a couple of hundred million Slavs and about a hundred million Russians, and we are not ghosts and will never become them, no matter how much some people would like it....

And all this is "democracy"!!! Only this "democracy" acts very selectively. As soon as a Rus declares his love for his Homeland – he is a chauvinist and an extremist! It is only necessary for Rus to declare the great past of our people, the real past, numbering hundreds of thousands of years – he is again a Nazi and an extremist! It is only necessary for Rus to declare the genocide of Rus and other indigenous peoples of Russia carried out in the past and present – he is again a chauvinist, extremist and instigator of ethnic hatred. But about a **HUNDRED MILLION PEOPLE** who were exterminated in the XX century in Russia are real figures, and no one in the whole world has said a single word about this! And most of those **ONE HUNDRED MILLION DESTROYED** were **RUSSIANS!!!**

At the same time, the Jews trumpet to the whole world about the "Holocaust", about the **SIX MILLION JEWS DESTROYED DURING WORLD WAR II!** For some reason, they do not incite ethnic hatred, they are not chauvinists or extremists! Although **SIX MILLION DESTROYED JEWS IS A BRAND-NEW LIE, PROVEN IN COURT!!!** During World War II, only **TWO HUNDRED FIFTY THOUSAND JEWS** died in concentration camps!!! And even then, **ONE HUNDRED FIFTY THOUSAND** died of starvation in the last months of the war, after American and English aircraft destroyed all of Germany's food warehouses, "by complete coincidence" leaving the Krupp military factories and other military magnates untouched.

By the way, not only Jews, but also all other prisoners, most of whom were Russian prisoners of war, swelled and died from hunger in the last months of the war in concentration camps! By the way, the Germans themselves, women, children, and the elderly swelled and died of hunger, as there is plenty of evidence. But is it worth paying attention to the death of millions of Goyim?! According to the "sacred" Jewish books, the Torah, in particular, **GOYIM ARE GENERALLY INFERIOR TO PETS!** But this "for some reason" is not Nazism, it is considered in the order of things! This is **TRUE "DEMOCRACY"!!!**

And that's right – it's not Nazism, it's much worse – it's **ZIONISM**, when **NAZISM IS ELEVATED TO THE RANK OF A NATIONAL RELIGION**, the essence of which is reflected in the **TORAH!**

2. For behold, DARKNESS WILL COVER THE EARTH and MIST THE NATIONS, THE LIGHT OF GOD WILL SHINE UPON YOU, and his glory

3. AND THE NATIONS WILL WALK IN YOUR LIGHT, and THE KINGS IN THE SPLENDOR OF YOUR RADIANCE.

4. Lift up your eyes, look around you, and see: all of them ARE GATHERED FROM THE LANDS OF EXILE, AND ARE COMING TO YOU; YOUR SONS ARE COMING FROM Afar, AND YOUR DAUGHTERS SHALL BE RAISED UP WITH KINGS.

5. Then you will see, and you will shine, and you will be overwhelmed with joy, and your heart will be filled with gratitude, for ALL THE ABUNDANCE OF THE COUNTRIES OF THE WEST WILL BECOME YOURS, THE WEALTH OF THE PEOPLES WILL PASS TO YOU.

9. For the inhabitants of the islands will flock to me, and ships from Tarshin ahead, to bring YOUR SONS from afar, THEIR SILVER and THEIR GOLD with them: in the name of God, your almighty God and the holy God of Israel, for he adorns you with splendor.

10. And the sons of foreign nations will build your walls, and their kings will serve you, for in my anger I struck you a blow, but I willingly took pity on you.

11. And your gates will always be open, they will not be closed day or night, so that THEY may BRING YOU THE WEALTH OF THE NATIONS, and THEIR KINGS will be brought as SLAVES.

12. For THOSE NATIONS AND THOSE KINGDOMS THAT WILL NOT SERVE YOU WILL PERISH, AND THESE NATIONS WILL BE DESTROYED.

13. The glorious trees of Lebanon shall be delivered to you - the cypress, the elm and the beech together to decorate the place of my sanctuary, and I will honor my footstool, the Temple.

14. And the sons of your tormentors will come to you bent over, and all those who mocked you will worship at the soles of your feet, and they will call you the city of God, Zion, the city of the holy God of Israel.

15. In place of your existence, when you were abandoned and hated, and no one passed through you, I will make you a ruler until the end of time, filled with joy forever and ever.

16. And you will drink milk, TAKE ALL THE BEST FROM THE NATIONS, drink milk from the royal breasts, and you will know that I am God, your Savior and Deliverer, the Lord of Jacob.

(The Pentateuch and the Haftarat. The book "Dvarim", Yeshayagu LX, 2-5, 9-16, 1286-1288 p.).

These lines from the Torah reflect the essence of Zionism, the religion of the Jews, and, as follows from these lines, **ANY PEOPLE** who do not obey the will of the **GOD of the JEWS, YAHWEH, MUST BE PHYSICALLY EXTERMINATED!!!** And although the Russ were deceived by the Jews in the twentieth century, they were not conquered. This is the reason for the destruction of the Rus and other indigenous peoples of Russia in the last century, which is why their destruction continues now, in the most sophisticated ways – through genetically modified food, vaccinations, through the destruction of traditions, morality, family destruction, etc. And this is also a "democracy"!

Consider the notorious "freedom" of speech! In the stronghold of "democracy" – the United States in 1995, CNN journalists aired a story about Vietnam veterans who were in the Vietnamese jungle when Agent Orange was sprayed over them. Not only the veterans themselves suffered from this poison, but they had children and grandchildren with genetic pathologies and serious diseases. As soon as the material aired, Henry Kissinger called Ted Turner and demanded an immediate retraction of the material and the dismissal of journalists with a black mark! Which was immediately executed.

And if we recall August 2008, then in those tense days, the "freedom" of speech of the Western world showed itself in full glory! All the media in the world shouted that Big Russia had attacked small, defenseless Georgia. And the most interesting thing about this is that everyone knew perfectly well who really attacked whom, and first of all the United States and Israel, who were directly involved in preparing Georgia's attack on South Ossetia! Various kinds of sanctions were already being prepared against Russia, anti-Russian sentiments were being whipped up all over the world... I think there is no need to continue. And at the same time, the "free" mass media were demonstrating their "freedom" to the whole world.

The most revealing story in this regard was broadcast live by FOX News, when eyewitnesses of the events in South Ossetia – a girl and her aunt began to talk about who actually attacked their Homeland! They were immediately rudely cut off, and soon a life-saving advertisement appeared! There is no need to comment on this event, anyway, the information war against Russia then suffered a complete fiasco. But what kind of freedom of speech can the West talk about if, for example, Mark Twain's books are banned in the United States for the simple reason that in his books a Negro is called a Negro, and not an African American!

Russia has not yet reached such an absurdity, but it is moving in this direction with leaps and bounds. And again, censorship in Russia is very selective. Any literature is published that distorts the past of Russia, humiliates the honor and dignity of the Rus and other indigenous peoples! In all this, no one finds any crime, extremism, incitement to ethnic hatred and humiliation of dignity on ethnic grounds. But all the books that talk about the greatness of our Homeland, about its great past, which is hundreds of thousands of years old, culture, language, which has become the proto-language for all peoples, the so-called "Indo-European group" of languages, etc. - are immediately declared extremist and are held according to the notorious article 282. As it happened, in particular, with my book "**Russia viewed through curved mirrors**".

This book scared people and frightened them very much. After reading it, people began to be proud of their Homeland, who they were and what country they lived in. It became clear to people why and what was happening and is happening in the World, and what forces are behind the troubles that have been falling in an almost continuous stream and continue to fall on our long-suffering Homeland. This is a scientific work, which provides facts and irrefutable evidence about the activities of social

parasites, among other things. No one anywhere even tried to refute the content of the book itself... it was simply declared extremist! The civil trial of the book was an outright farce. The first expert examination of the book was illegal, but, nevertheless, the judge did not want to hear anything about it. The judge categorically refused the legal demand of the defense to call experts to the court hearing as witnesses for the prosecution. It follows from the text of the examination itself that the "experts" did not find any direct appeals, insults, humiliations, but only "indirect" signs, although they did not cite any of these "indirect" signs. All this reminds me of a joke about a Russian spy in France. I will cite only part of it, but this is enough to understand the essence of both the joke and what I am writing about: "...waiter: *What else will you order, Mr. Russian spy!?* - *What makes you think that I am a Russian spy!?* - *waiter: You are looking at the edge of the cup as if there should be a spoon there...*". So, the "indirect" signs of the "experts" reminded me of this anecdote. But seriously, then...

Firstly, the "indirect signs" of extremism, if they exist, must be clearly and precisely defined by law! But there are none in the law, it only says that the statement of a particular historical fact **IS NOT A SIGN OF EXTREMISM!** My book provides irrefutable facts, and that's what infuriated the social parasites so much.

Secondly, if indirect signs exist, then they should be indicated in the text of the examination, which is not observed at all by experts. "Experts", generally in their "expertise", talk about some ephemeral indirect signs, but in their **CONCLUSIONS**, they do not have indirect signs, but "full-fledged extremism", incitement of ethnic hatred, interreligious strife and humiliation of the dignity of Jews, since a goy dared to read the Torah and such a goy should be destroyed, according to the same Torah.

In "**Russia viewed through curved mirrors**" I show how and under what circumstances social parasites seized power in the World, and how all this affected Russia. Strangely, my book was read by people of almost all nationalities of Russia, and not only her, and almost everyone who read it, regardless of nationality, [wrote to me that](#) they had a sense of life, that they were proud of who they are, proud of the Great Past of their Homeland! And the vast majority of readers are young people! Which personally makes me very happy! Most people have not only read the book, they have changed themselves. They changed their way of life, began to feel free, the slave "collar" disappeared, and they were reborn free, as our ancestors always were!

Only representatives of one nation attacked my book with hatred! But in my book, I write about social parasites, their essence, about the methods and ways of their seizure of power, both financial and political. This reaction of the Jews suggests that they **THEMSELVES RECOGNIZE THEMSELVES AS SOCIAL PARASITES!** No one else reacted like that, it's not for nothing that the proverb says that "a thief's hat is on fire"!!!

Anyway, the judge annulled the results of the first examination and appointed a new examination, while again violating all imaginable and unimaginable laws. According to the law, the defendant's side has the right to provide its experts or choose from among those proposed by the judge. In my case, the judge appointed the experts **HERSELF**, ignoring the protests from the defense. The new "examination" was not much different from the old one, nothing concrete, all the same mythical indirect signs, with already familiar conclusions. Only the second examination had gross violations – the experts in the text of the examination drew legal conclusions that it was illegal, and such an examination should have been immediately annulled by the judge.

But the judge did not do this and decided to recognize the book "**Russia viewed through curved mirrors**" as **EXTREMIST!** Needless to mention, both the initiator of the trial over the book, and the prosecutor of Obninsk Narusov, and Judge Fedorova, and the prosecutor in the court, "absolutely"

accidentally turned out to be representatives of the small people! The fight for the book is not over yet, the trials continue, each time going to a higher court, and so far, the same picture is everywhere – no one wants to listen to any arguments and facts. The decision has long been dropped from the Prosecutor General's Office, which, by the way, exerting pressure on investigators, **TRIED FIVE TIMES TO OPEN A CRIMINAL CASE** against me! And we must pay tribute – all investigators in both Obninsk and Moscow **REFUSED TO INITIATE CRIMINAL PROCEEDINGS, DUE to THE LACK OF CORPUS DELICTI**, despite pressure from the Prosecutor General's Office! But among these investigators there were people of different nationalities and different faiths. The fight for the book continues and will continue until the decision of the Obninsk City Court is completely annulled.

This is about freedom of speech in modern Russia. This happens not only with my book, but also with books by [other authors](#) who bring people the truth about the Great Past of our people. But "democracy" in Russia extends not only to freedom of speech...

In November of this year, an initiative group of voters proposed to nominate my candidacy for the post of President of the Russian Federation. I have received similar proposals many times before, but this time I have given my consent to run for president of Russia. I considered it necessary to do everything in my power to prevent the collapse of the country and the destruction of the indigenous population of Russia, its culture and traditions, so that later there would be no remorse about the fact that I did not do everything I could, because I could not calmly look at how mine, everything that is dear to my heart, is being destroyed before our eyes. And so, from the moment I agreed to be nominated as a candidate for the post of president of Russia, manifestations of "democracy" began!

After the publication on 25 November of the resolution of the Federation Council on the appointment of the presidential elections of the Russian Federation for 4 March, 2012, the initiative group began to look for a hall for the event. It was decided to combine the holding of the constituent congress of the association of free trade unions of the Russian Federation with a meeting of voters to nominate me as a candidate for the presidency. Sabotage began to manifest itself already at the stage of searching for a hall for the event. Most simply refused to provide a hall for the event, some said they would give their answer later, which was clearly not suitable. Anyway, an agreement was signed with the Izmailovo Concert Hall on the provision of premises for the event. After that, pressure began to be applied on the director of this hall to terminate the contract. The calls came from "competent" authorities.

Friday, 2 December, was not the most successful day for the event, since many working people were not given leave without pay, and considering that people from Kamchatka, the Far East, and the Kaliningrad Region, from the Far North and Altai came and flew to the congress, they needed more than one day of vacation without pay. Nevertheless, people from 45 regions of Russia came to the congress. And then the most interesting thing began. Many people were met on the way to the concert hall and were advised not to go to the event, as there may be terrorist attacks, bomb explosions, etc. But people didn't buy it.

Registration of delegates and voters began at 7 a.m. on 2 December, there were **MORE THAN SEVEN HUNDRED PEOPLE**, most of whom were young people under 35 years old, which in itself is indicative. The registration was conducted by one notary, and there was a queue for hours, but all the people were highly disciplined, although many had to stand for 6-8 hours to register! More than 100 people, having stood in line for about 8 hours, were not registered, since after the start of the meeting of voters, after the end of the constituent congress of trade unions, voter registration was prohibited.

THREE REPRESENTATIVES of the CEC observed the course of the event! But even they were amazed by the discipline and organization of the event. Already during the founding congress, a major of the Ministry of Emergency Situations appeared with a ready-made document on the suspension of the congress due to the fact that the hall did not meet fire safety requirements. When he was offered to personally check fire safety, he, unable to find fault with anything, began to call those who gave him this order. But a call to a person from the "competent" services did not save the situation either. The major angrily tore up his report and left.

So, at the stage of holding a meeting of voters, it was not possible to disrupt what the social parasites had started. I would like to thank once again all the people who came from different parts of our homeland, not for money, not for the sake of "cookies", but at the call of their hearts, with the confidence that together we can make our country Great again! By the way, people came to the event at their own expense, and for many it was a considerable expense. So, not everyone in our country is corrupt and not everyone "gives a damn" about it all!

After the meeting of voters on 2 December, the preparation of documents for submission to the CEC began. This is quite a lot of work, and the first part of it is the preparation of documents by a notary, which took several days. Anyway, the documents were ready, and at 2 p.m. on 12 December, the reception of documents at the Central Election Commission was scheduled.

The initiative group and I arrived on time, and after a period of time a representative of the CEC appeared and asked us to wait. After a while, a young guy appeared and asked us to follow him. He led us to the back entrance of the CEC building, where we waited for another 10-15 minutes until the gates opened and we were invited into the courtyard of the CEC. It can be seen that the central entrance to the CEC building was "mined" or a tsunami swept through it, destroyed by a powerful earthquake or some other natural disaster. Anyway, the main entrance of the CEC turned out to be **IMPASSABLE** for us! Or maybe there's a big traffic jam of presidential candidates... Anyway, we found ourselves in a roundabout way in the hall where the admissions committee was waiting for us. And the reception of documents began, which lasted almost **FIVE HOURS!** The members of the commission checked every letter on each document, and in case of typos or descriptions, they demanded corrections, which was done during the inspection itself, and ... at 19:00, the act of accepting documents was officially signed by the chairman of the commission, B.S. Ebzeev, and handed to me.

On Thursday evening, I received a call from the CEC notifying me that on 16 December my question would be considered for the fourth time. The fourth issue of the CEC meeting was the refusal of a group of voters to nominate Levashov N.V. as a presidential candidate. From 12 December to the 16th, the CEC did not have any questions, and they did not ask for any explanations or comments, everything was clear to them! For five days, they checked my information, sent requests to the Consulate General of the Russian Federation in San Francisco, and so on. Although my stay in the United States was openly indicated in the documents adopted by the commission on 12 December.

For comparison, I will cite the billionaire Prokhorov, who also decided to become an independent candidate. He gathered a group of voters for his self-nomination as early as the evening of 15 December. He had no problems with the hall, the premises were free for the meeting. There is no information about how this meeting took place, the media did not cover this "planetary event" in any way. So, in a very short time, the necessary number of voters were registered by notaries for his self-nomination, most likely several notaries worked with their assistants, otherwise it would simply be impossible for one notary to register all voters. Although, strangely, according to the requirements of the CEC, there should be one voter protocol for self-nomination, and not several if several notaries worked.

But we will leave this on the conscience of Mr. Prokhorov and the Central Election Commission. Then an even more interesting carousel begins!

In some 2-3 hours, all the necessary documents for submission to the CEC were fully ready, and, most interestingly, the CEC commission was waiting for Prokhorov's initiative group until 23:35 on 15 December. And accepted documents within a few minutes, since at 24.00 the reception of documents officially stops. And before midnight, they handed over to Mr. Prokhorov the act of accepting documents! Well, just Stakhanov's methods of accepting documents! At the same time, during these 10-15 minutes, they managed to check all the data, completely ignoring such trifles as an open criminal case against Mr. Prokhorov in the mountains. Irkutsk, in connection with the non-payment of taxes to the state in the amount of only **TWO BILLION RUBLES!!!** Is it worth paying attention to such and other little things from Mr. Prokhorov?

In fact, only "miracles" happen to Mr. Prokhorov! On 15 December, at 23:35, he just submitted documents to the CEC, and on 18 December, on Sunday, the Central Television program of the REN-TV channel program aired a story about him as a candidate for President of the Russian Federation! But the story still needed to be filmed and edited, and Mr. Prokhorov had to allocate his precious time for this. Apparently, the TV journalists already knew that Mr. Prokhorov would be approved by the Central Election Commission as a candidate for President, since they released a story about him so quickly. Since the same channel (as well as several others) urgently filmed material for the same Central Television program about me, and they were in a hurry to edit the material by Sunday, 11 December, but... the story never aired on 11 December, or the 18th, or any subsequent Sundays! Apparently, the journalists already **KNEW** that the CEC would refuse to register me as a presidential candidate. Otherwise, how can I explain the fact that, at their repeated requests on 5 and 6 December, I agreed on an interview about the mushroom production where my generator is installed. The interview was scheduled for 9 December, but... the program producer called the production representatives back and, citing urgent trips of the film crew to "hot spots", asked to reschedule the interview, about the time of which she would additionally call. It's still "ringing." Just as several other channels are "calling" for additional material from me, which they literally asked me about the day before.

In fact, television, as it turned out, knows better than the CEC itself about who it will allow and who it will not allow to participate in the presidential elections. The only material that was aired about me, in principle, had practically nothing to do with me. Most of the material was about Anatoly Kashpirovsky, Marianna Maksimovskaya in her program made a particularly strong emphasis on his mass hypnosis sessions, during which people ate grass on the stadium field and the like. If she really wanted to show my activities in many ways, she could have taken video materials from my website about my seminars and speeches in both 1991 and 2010, but... at my seminars and speeches people did not eat grass and in general nothing of this kind happened, which anyone can personally verify by watching these speeches, which are openly located on my website. But for some reason they did not interest Mrs. Maksimovskaya from the NTV channel, apparently, they did not have the "spiciness" she needed so much, so she had to borrow this spiciness from Anatoly Kashpirovsky! In fact, almost all official mass media, after the initial excitement around my person, maintained a friendly silence. Only one channel, after the Central Election Commission accepted my documents on 12 December, reported about it in the news within a few seconds, without even showing my photo! **LONG LIVE THE "FREE" AND "INDEPENDENT" MASS MEDIA OF RUSSIA!**

So, on 16 December, 2011, my representatives attended a meeting of the CEC, the fourth issue on the agenda of which was: ***"On the refusal to register a group of voters created to support the self-***

nomination of Nikolai Viktorovich Levashov as a candidate for the post of President of the Russian Federation, and its authorized representatives." The reason for the refusal of my registration was announced as follows: "*Since Nikolai Viktorovich Levashov lived in the United States during the specified period, he cannot be recognized as a person permanently residing in the Russian Federation for at least 10 years. Accordingly, in accordance with the requirements of the Constitution of the Russian Federation, Nikolai Viktorovich Levashov cannot be elected President of the Russian Federation,*" said Boris Safarovich Ebzeev, a member of the CEC of Russia.

The most curious thing about this is that the same Boris Safarovich Ebzeev was the chairman of the commission that accepted my documents on 12 December and in my documents, in which literally every letter was checked, it was written in black and white that I was in the USA from 31 December, 1991 to 18 August, 2006! I have never hidden this, but then the chairman had no questions about it, all the documents were accepted with this information. Why do a fact check that has been openly provided? The CEC presented everything as if it had been discovered by them during the inspection, which was done very hastily and in the very response to the CEC's request, many blunders were made, but this is not the main thing now. Well, the CEC commission went crazy and accepted the documents, despite the fact that the documents were checked very meticulously. Having issued such a conclusion, B.S. Ebzeev himself noted that my documents submitted to the CEC were prepared like none of the other presidential candidates. The documents were prepared flawlessly, apart from minor details that were quickly eliminated on the spot.

And here... it is necessary to find a reason to refuse, and thus the notorious verification of those facts that were provided from the very beginning appeared! Someone really didn't want me to get the mandate of a candidate for president of the Russian Federation. And it was necessary to find the reason and so... salvation for the CEC, the reason has been found! To all the objections of my representatives, B.S. Ebzeev stressed that **I HAD NOT LIVED IN THE TERRITORY OF THE RUSSIAN FEDERATION FOR THE LAST TEN YEARS!**

Actually, reading the Constitution of the Russian Federation, you can find several interesting points regarding the election of the President of Russia. Firstly, the Constitution does not say a word that a candidate, and even more so the president of the country, **MUST BE BORN ON THE TERRITORY OF THE RUSSIAN FEDERATION!** Russia is not a country of immigrants, but in the most famous country of immigrants – the USA, **ONLY A PERSON BORN IN THE USA CAN BECOME PRESIDENT!** Curious, isn't it? In a country of immigrants, only a person born in the United States can be president of the country, and in Russia this is completely optional, since the Constitution says that: "*A citizen of the Russian Federation not younger than 35 years old, who has been permanently residing in the Russian Federation for at least 10 years can be elected President of the Russian Federation.*" This is exactly what the second part of Article 81 of the Constitution of the Russian Federation says!

According to this article, a person over **35 YEARS OLD and PERMANENTLY RESIDING IN THE RUSSIAN FEDERATION FOR AT LEAST 10 YEARS**, can become president of the country! There is not a word about being born on the territory of the Russian Federation, but only that in order to become president of the country, a person must be at least 35 years old and at least ten years out of these **35 must permanently reside in the Russian Federation! And this means that out of these 35 years, a person CAN LIVE ANYWHERE for 25 YEARS OF HIS LIFE**, they only have to **LIVE IN RUSSIA FOR TEN YEARS!** And the most interesting thing **IS THAT THIS ARTICLE OF THE CONSTITUTION DOES NOT SPECIFY THAT THESE TEN YEARS SHOULD BE THE LAST!!!**

Thus, according to the Constitution of the Russian Federation, the president of the country can be a native of any country in the World, who, for example, became a citizen of the Russian Federation at the age of 25 and lived in the country for at least ten years! Or even during his 35 years, he can either refuse or accept Russian citizenship, the main thing is that at the time of the election he lived in Russia and the total "experience" of citizenship was at least ten years! Such curious moments follow from Article 81 of the Constitution of the Russian Federation!

The most curious thing about all this is that I was not only born on the territory of the Russian Federation (then it was called the RSFSR), but also lived in total on the territory of the USSR and the Russian Federation for 37 years of my life. I was born in the city of Kislovodsk, Stavropol Territory, in 1967 our family moved to the city of Mineralnye Vody, where my father received an apartment for work. He studied at school there, after graduating from which he worked at the Civil Aviation plant No. 411 before entering the Kharkiv University in 1979. Maxim Gorky, to the Radio-physics Faculty. After graduating from the university in 1984, he was drafted into the army as an officer for 2 years. After retiring from the reserve in 1986, he returned to Kharkov and worked as an engineer until July 1988, and then as a junior researcher at the institute, which was called VNIITE. And from July 1988 to 30 December, 1991, he lived and worked independently in Moscow. It just so happened that in my life I have come into contact and been a part of different social strata of society and I know the realities of life not theoretically, but practically.

Since childhood, I had to help my father a lot, who often worked part-time on his weekends and during vacations, as they said then, sabbath. It just so happened, he knew the needs and interests of the village well. In my life, I had to lay bricks, work on carpentry and locksmithing machines, mow, lay floors, paint walls, and unload wagons. Everything I've ever had to do in my life., whatever I did, I tried to always do it to the maximum of my abilities. And I was always happy when something was created in my hands, whether it was a simple stool or brickwork. And even if it wasn't the best stool in the world or the perfect brickwork! But... the very process of creation has always brought me joy. And I was pleased that when I laid out the walls in half a brick for the first time in my life, a professional bricklayer who saw my work then asked my father how many years I have been working as a bricklayer? This recognition of my work was very pleasant to me, especially considering that I worked as a bricklayer for only a couple of days, and no one taught me this. I just saw how others did it, and everything was clear to me. Of course, I did not become an extra-class specialist during these two days of working as a bricklayer, but ... my desire to do everything as best as possible was crowned with success.

I am writing about all this to emphasize that in order to become a candidate for president of the Russian Federation, a person must not only live for at least ten years in the country, but also know people very well, know and understand what they breathe, and what motivates them, their needs and needs at all social levels of the cross-section societies. And everything that I described above, a person will not be able to accumulate in ten years, even with a strong desire. To do this, it is necessary for a person to be born, raised and fully formed in the social environment of the Russian Federation, and not any other country. Even if a person was born in our country, and his formation as a person took place in another social environment, such a person can no longer be the president of the Russian Federation, since he was not formed in the cultural and social environment of Russia. But ... all this is strangely ignored by the current Constitution of the Russian Federation.

And there is another point of obvious, deliberate distortion of information in order to deny the initiative group of voter's registration of me as a candidate for president of the Russian Federation. The Constitution of the Russian Federation, in article 3, paragraph 5.1, says the following about presidential

elections: "... a citizen of the Russian Federation who **HAS CITIZENSHIP of a FOREIGN STATE**, or a **RESIDENCE PERMIT** or other document confirming the right to **PERMANENT RESIDENCE** of a citizen of the Russian Federation on the territory of a foreign state, has no right to be elected President of the Russian Federation."

Curiously, the second point of the CEC's refusal was the following wording:

2) from 1995 to 18 August, 2006, N.V. Levashov **PERMANENTLY RESIDED** in San Francisco, California (USA), was registered with the Consulate General of the Russian Federation in San Francisco and was removed from the register on 18 August, 2006 in connection with his return to permanent residence in the Russian Federation, **BECAUSE N.V. LEVASHOV PERMANENTLY RESIDED IN THE UNITED STATES DURING THE SPECIFIED PERIOD, HE CANNOT BE RECOGNIZED AS A PERSON PERMANENTLY RESIDING IN THE Russian Federation for at least 10 years.**"

In this case, there is a clever manipulation of facts and information manipulation. The Constitution of the Russian Federation makes it very clear who does not have the right to be elected president – a person who has citizenship of another country, or a **RESIDENCE PERMIT**, or another document confirming the right to **PERMANENT RESIDENCE** of a citizen of the Russian Federation on the territory of a foreign state! In other words, the Constitution of the RUSSIAN Federation clearly defines that **A RUSSIAN CITIZEN WITH A RESIDENCE PERMIT OR OTHER DOCUMENT** confirming this right **IS RECOGNIZED AS PERMANENTLY RESIDING IN THE TERRITORY OF A FOREIGN STATE**.

Thus, according to the Constitution of the Russian Federation, it turns out that my entire life becomes the period of my residence on the territory of the Russian Federation, which is **FIVE TIMES LONGER** than the **REQUIRED PERIOD** in order to be eligible to be elected president of Russia. Despite the fact that I lived in the United States, I have never LOST my constitutional right to be elected president of Russia in full accordance with the current constitution of the Russian Federation! It turns out that the CEC, in its determination of the reason for the refusal to register me as a presidential candidate, **TWICE GROSSLY VIOLATED the CONSTITUTION** of the Russian Federation and falsified facts.

When the CEC made such a decision, on the same day on 16 December, a complaint was filed with the Supreme Court of the Russian Federation, but ... there was no one to accept it, even before 19 December, which is also a gross violation, twice my lawyer called the police squad and these violations were formalized by protocol. On 20 December, the complaint was rejected by the Supreme Court of the Russian Federation, as they were not satisfied that my lawyer filed the complaint, although he is officially my authorized representative, and the Supreme Court of the Russian Federation **WAS OBLIGED TO ACCEPT** this complaint on my behalf.

Then a complaint was filed on my behalf on the same day. With this maneuver, the Supreme Court decided to get rid of two police reports on gross violations of the Supreme Court. My hearing was scheduled for 11 a.m. on 23 December, 2011. The trial began at 11:20 a.m., and it was all over by the time one o'clock rolled around. The CEC representative in court looked very weak, if not funny with his arguments. The judge was very supportive. The prosecutor looked even weaker with her arguments. Her argument was entirely devoted to the rules of the Russian language. Moreover, with a clear misunderstanding of who or what the word "resident" refers to. Although the Constitution of the Russian Federation clearly and explicitly speaks about a person. That the presidential candidate must reside in the territory of the Russian Federation at the time of the election. The Constitution clearly states that if a Russian citizen lives outside of Russia, he cannot apply for the post of President of the Russian Federation. And the period required to obtain this right is also specified, but not before the elections themselves, but in general – at least ten years. I have already written about this.

Therefore, when the prosecutor switched to the concepts of linguistics instead of the language of the law, it only confirmed that the "well-wishers" had no legal arguments confirming their position. Not to mention the fact that the Consul General of the Russian Federation in San Francisco, at the request of the CEC, committed an official offense, for which criminal liability is provided for deliberately providing false information, together with the CEC. Since if the Consul General had made a request to the US immigration service, he would have received an unequivocal answer that Levashov N.V. **DID NOT HAVE THE STATUS OF A PERMANENT RESIDENT OF THE USA!!!** Anyway, the trial lasted no more than an hour, after which the judge went to the judge's chamber and... he was gone for almost two hours! At that time, the prosecutor left the courtroom several times, which is also a violation. Whether the judge consulted with someone or not is anyone's guess. But... she returned to the courtroom with a completely different attitude and read out the decision on refusal in a completely different voice, after which she quickly left...

I think I know what happened during those two hours, and who was watching very closely through several video cameras what was happening in the hall. But... I don't have any evidence to show. So, I won't write about it, however... what happened is enough to talk about a complete falsification of everything that is happening in the courtroom and in the CEC.

Then a cassation appeal was filed against the decision of the Supreme Court of the Russian Federation dated 23 December and three supervisory complaints. The supervisory complaint from the Interregional Association of Free Trade Unions was refused, on the basis that on 23 Decem the judge of the first instance refused to recognize the representative of the trade union as a third party in this meeting, which is completely absurd, since A. N. Tyurin is my official representative and, as such, registered with the CEC. The reason for this behavior of the judge is very transparent – trade unions in our country have great strength, and abroad too. According to the other two supervisory complaints, there is complete silence! And the cassation appeal was "considered" on 28 December, 2011. The meeting of the "court" passed very quickly, the judges were asleep, most likely, after corporate parties. They did not admit any arguments and "conferred", after 15 minutes they decided to uphold the decision of the Supreme Court of the Russian Federation of 23 December. It is clear that the decision was ready even before the trial began.

On 17 January, 2012, a complaint was sent to the European Court of Human Rights, to the Constitutional Court of the Russian Federation in St. Petersburg, and a request for interpretation of part 2 of Article 81 of the Constitution of the Russian Federation was filed on 18 January, 2012. The Strasbourg Court confirmed receipt of the documents on 18 January by fax on 19 January, 2012. But there is still no confirmation from the Constitutional Court of the Russian Federation. The Constitutional Court is very "far away", and, apparently, the post office is not working well! So, the absurdity is not over yet, the absurdity is just beginning!

And I would like to highlight one more absurdity before concluding this article. This is about 2,000,000 signatures that, at the request of the Central Election Commission, the so-called self-nominated candidate must provide. The most interesting thing in all this is that the self-nominated candidate has the right to start collecting signatures only after he officially receives the status of a candidate for President of the Russian Federation, and this was already the end of December in any case! But that's not all! After receiving the mandate of a candidate for president of the Russian Federation, the candidate's proxies must open an election account, to which voluntary donations must be received, and the work of all signature collection offices must be paid **ONLY** from this account. All agitation, leaflets, etc., must also be paid from this account and that's all. The candidate himself has the

right to contribute **NO MORE THAN TEN PERCENT of the AMOUNT** that the CEC allows the self-nominated candidate to collect in the amount of **FOUR HUNDRED MILLION RUBLES**. And all payments must be made **ONLY** through an official account in Sberbank! This is a requirement of the CEC. And here's what's going on...

Mr. Prokhorov's bravado tells reporters that he paid 500 rubles for each vote! And when a journalist asked him how much he paid for this, he very awkwardly avoided answering this question. But the "bird" has already flown out and it's too late to catch it... A simple calculation of multiplying **TWO MILLION by 500 RUBLES** gives an amount of **ONE BILLION RUBLES!** Sure... It's not a billion dollars, but... The CEC allows only **400 MILLION RUBLES** to be used for the entire election campaign, and the candidate himself can contribute only **40 MILLION** rubles to his election campaign account, and any legal entity – 7% or **28 MILLION RUBLES!**

Besides the fact that paying for "support" votes is a gross violation of the requirements of the CEC, for which Mr. Prokhorov should have been immediately removed from the presidential marathon, in principle, such an action is criminally punishable. It is clear that not only does Mr. Prokhorov do and did something similar, but only he "thought" to announce it in front of the cameras.

And that's not all! The requirements of the CEC, which were announced to me, are that these **TWO MILLION SIGNATURES** must be collected **IN FORTY REGIONS OF RUSSIA and NO MORE THAN FIFTY THOUSAND SIGNATURES FROM ONE REGION!** And this means that only fifty thousand signatures can be collected in the Moscow region – and so fifty thousand in each of the remaining thirty-eight regions of Russia! In other words, if a presidential candidate collects, for example, **FIVE HUNDRED THOUSAND SIGNATURES** in Moscow, the CEC **SHOULD COUNT ONLY FIFTY THOUSAND SIGNATURES FOR HIM!** At least, such demands were made to me in the same CEC. I find it hard to believe that even Mr. Prokhorov's purchased signatures meet these requirements of the CEC. Not to mention the fact that Mr. Prokhorov applied to the CEC as a self-nominated candidate for the post of President of Russia, after the deadline for accepting such applications expired! There is certainly no such "democracy" and "justice" in any country in the world!

And I would like to focus on one more aspect, clarifying the "democracy" in our country when choosing a president. Parties that have passed the State Duma are not required to collect signatures at all when they nominate their presidential candidates. This approach could be explained by the fact that each party in the Duma has many millions of citizens of our country in its ranks, and all members of these parties unanimously nominate a presidential candidate from their party! One could welcome such a unity of the members of the Duma parties, which was "peculiar" only to the Bolshevik party, after the capital struggle of this party for the purity of its ranks, as a result of which the party became "united", and all the unworthy or low-minded ended up with an extra hole in their heads.

But, strangely enough, of all the parties, only one managed to gather a little more than two million members in its ranks – the United Russia party! And even then, I just managed to overcome these two million. The number of the United Russia party is **2,009,937** people, and, indeed, one can only believe that they are unanimous in all decisions, otherwise they would not have the necessary two million votes-signatures to support their candidate!

The next largest Duma party is Fair Russia, which has **414,558** members, then comes the LDPR, which has **185,573** people, and finally, the last of the Duma parties in terms of numbers is the Communist Party, which consists of only **154,244** people! And the so-called extra-parliamentary parties generally have a ridiculous number: the "Patriots of Russia" have called **86,394** people into their ranks, the "Right Cause" is even less - **64,022** people, and the Yabloko party closes the party column, in which

as many as **54,911** people (data from the Ministry of Justice at the time of publication of statistics on 13/11/2011)!!! Isn't it impressive!

And in connection with these data, one question arises: on the basis of which the Duma parties **DO NOT** need to collect two million signatures?! After all, if the statistics of the Ministry of Justice reflect the real state of affairs with the number of parties, then only the United Russia party has the necessary two million members, and then if they all support one candidate. And the three remaining Duma parties lack up to two million signatures by quite "a little bit" - 1,586,442 signatures, and further, according to the list – 1,814,327, 1,845,756 signatures!!! But is it worth paying attention to such "little things"?!

But that's not all! All parliamentary parties receive considerable funds from the budget, not counting funds coming from other sources, have permanent offices in almost all regions of Russia, etc., etc. The requirements for self-nominees are completely different: polling stations for collecting signatures can be opened **ONLY** after a special account is opened at the end of December in Sberbank funds, and all these polling stations must be paid **ONLY** from this account in Sberbank, otherwise everything will be considered unacceptable. And if we consider that banks practically stop their work on 25 December and return to normal operation only on 14 January, then collecting signatures by self-appointed candidates becomes an almost impossible mission!

But the CEC has deprived people who are ready to support me of this opportunity, having fabricated the "reason" for the refusal, and this suggests that the social parasites were afraid, what if he collects two million signatures or more, and perhaps wins the elections?! And they did everything to ensure that neither I nor people simply had this opportunity. And they did everything so that neither I nor the people would have this opportunity. And then they comment that, supposedly, there is no one to choose from! I am sure that, despite all the obstacles indicated, we would have managed to collect two million signatures, and even much more.

All this suggests that the authorities are simply afraid of their own people and are very afraid that they will be out of business! And this means that "... the upper classes cannot, and the lower classes do not want to live in the old way ...", which means a profound crisis of power... But it's not evening yet, the fight continues. At least, I continue to fight lies and injustice, and I hope that many people will join this, who care about the fate of the Motherland, its future and the future of our children and grandchildren!!!
