## Introduction

### **Is there a future for Humanity?**

The question is not as simple, as it may seem at first glance. Is it possible to answer it without knowing the basics of the existence of Humanity and the purpose of Man in this existence? And how many people ask this question against the background of the usual scenario of living life from birth to death in the mode of survival and eternal struggle?

People are so used to their dominant position in relation to nature, which they believe to have "conquered" that to a certain extent they have "lost their soul", monotonously gnawing the "philosopher's stone" invented by them and have forgotten about what they live for and how long their all-destroying aggressiveness will be tolerated by this "conquered" nature. All the more so, most of them are not at all interested, even at the level of curiosity, whether the processes of nature that are taking shape are accidental, or spontaneous or are they governed by something, and to what degree of usefulness to people? However, now life itself poses this question to us in order to stop the mindless running around the circle of biological vegetation. It's time to think deeply about the role of Man as a part of the planet itself, which people are gutting, cluttering, poisoning and destroying, making it impossible to have any future at all.

Lately, there are an increasing number of people beginning to think that the development of our Earthly civilization is taking place under a certain "vigilant eye of the Universal Mind". How do we treat this? This is a partial truth. Is it worth diverting your attention in our difficult time to such "crazy" fabrications? Everyone will answer this question independently, and it depends on the influence of a number of factors, the time of influence of which on the essence of everything that is happening has come.

If a person cannot foresee or find connections between the facts of the changing reality surrounding him, then the events taking place around him, by themselves, do not have a logical and feedback connection with him. Such a person (or a group of them, the scale does not play a role) is only an occasional passive contemplator and a secondary application to what is happening for a very short period of its application, as an object or tool, and no more. This is what happened in the processes of the old Program of the Development of civilization. This condition causes a non-essential passive and parasitic function, more often on the verge of a flawed sentence – to be applied.

Now these Programs are stopped. All Complexes and Systems in the previous program format have ceased to function. The vector of Goals for supporting the execution of phenomena, actions and events is "forcibly" prematurely completed and "programmatically eliminated". We, the people, should and can take an active part in the process of recreating ourselves anew in order to become People who have deeply realized the true function of Humanity on Earth and have found our true role and place in the program processes of planet Earth.



In the works of the team of scientists of the Research Institute "Center for Proactive Strategies" (NII TSUS)<sup>1</sup> there are fundamental materials available for familiarization by every Person who is not indifferent to his role on Earth. The basics for Humanity is the "Fundamentals for the Formation of Humanity" (abbreviated as FFOH)<sup>2</sup>. This voluminous work describes in detail all the reasons that led to and the results of the disappointing civilization of today and suggests ways to solve the problems that people have faced in their externally controlled material existence and application.

## Part 1. PAST AND PRESENT ...

### 1.1. Complexes and Objects of the Earth Control System.

**B**efore turning to the past, hidden to this day from the Consciousness of people, as well as to exclude confusion imputed by the interventionists with a certain conditional numbering of the number of civilizations on Earth, it is necessary to pay attention to the materials "**Cluster Management System**".

Each planet from the General Hierarchy of the development of Civilizations with life conditions endowed for them should have in its model design a certain necessary "set" of managing, providing and accompanying Objects and Complexes, which, being formed into functional cluster<sub>3</sub> Systems, should be able to:

- independently provide the entire step-by-step process of managing the development of their Civilization according to a previously acquired program from the outside;
- to ensure the retention of the existence of energies in a harmonious state relative to each other;
- to form energy replenishment and to "feed" them into already existing concepts of energies, etc.

<sup>3</sup> A cluster is an association of several homogeneous elements that can be considered by themselves as an independent unit with certain properties that are common to each associated element. For example, - stellar, galactic, civilizational, planetary, cluster of social development, cluster of public administration. The management of each sphere of being, as separately expressed elements of a lower order in the general Structure of people's being, is also expressed by quite specific thematically functional clusters.

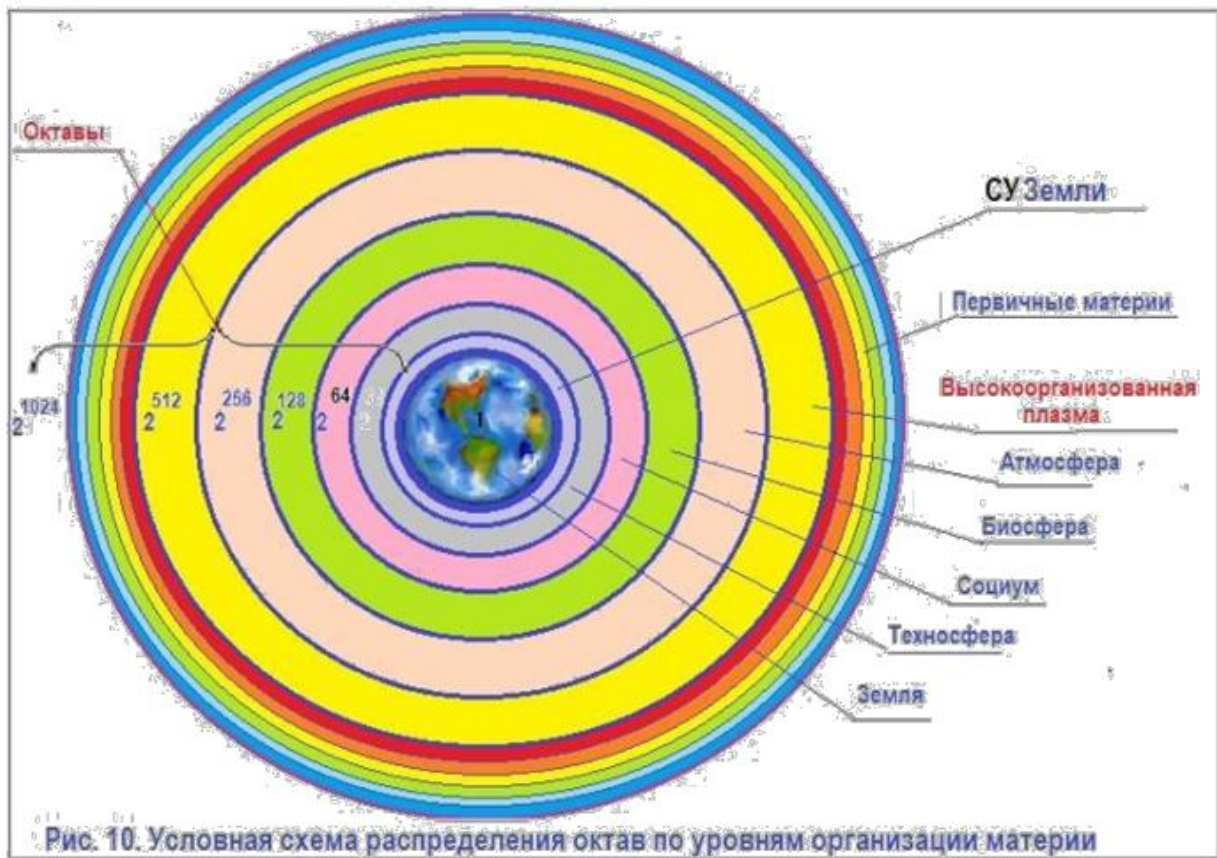


Fig. 10. Conditional scheme of the distribution of octaves on the levels of the organization of matter

Such a planet as the Earth is a kind of strictly identified complex planetary monocluster<sup>4</sup> with its own control of the existence of energies and the development of a civilization of Intelligent orientation, which, according to the provided program, should have been complicit in its system management and functional endowment with cluster systems of a higher order in the process of its entire long-term development (a total of 8 stages). The Earth is a model complex represented by energies in inertial (material) and non-inertial (immaterial) aggregate states ranging from 12 to 512 octaves of energy for a given stage of its civilizational development, as the first stage of the nested program for its development in general. Our Mother Earth is not as simple as it is represented by current geophysicists and even more so by globalist politicians who have turned it into a field of extraction for their earthly goods (not using their brains) due to their unreasonable orientations!

<sup>4</sup> A planetary cluster is a strictly verified model design of a single planet, represented by a complex of energy grids of the entire energy range in their material and immaterial relatively stable states.



**The Cluster interplanetary System of the Earth was attacked in 18,344 BC** (the Earth itself was attacked a little later, i.e. at the final moment of the general intervention, as a separate fragment). The very process of intervention should not be understood as a kind of fleeing of hostilities (a sea of fire according to Hollywood scenarios, aircraft at super speeds, family and clan contradictions of certain supreme Hierarchs, etc.). **The very process of capture was carried out for 1,040 years.**<sup>5</sup>

The structure of this Cluster System<sup>6</sup> in addition to the Earth included: Mercury, Venus, Mars, Phaeton, Jupiter, Saturn, Pluto, Neptune, and Uranus. Each of the planets had a specific function assigned to it. For example, the System of planets did not need the interventional Sun as a multifunctional generating complex that provides the formation of the control energies of radiation frequencies of 54 octaves of the cubic structure of building energy grids that provide someone else's basic base for controlling existence as such.

At the time of the attack, there were **364,000 objects** on Earth to provide all the necessary complex control for managing the harmonious existence of energies, the executive process of civilizational development, ensuring living conditions, controlled environmental conditions, and so on. The light had 80 octaves (the current illumination with the participation of the Sun has 48 octaves), the gravity was 5.82 m/sec<sup>2</sup> (this fundamentally changed the entire arrangement of life for a Person, the metabolic processes of his body and much more in the states of the surrounding reality).

<sup>6</sup> Planetary clusters, which additionally have an endowment for the development of a civilization of Intelligent orientation, have in their Control System: Control Complexes, objects, Energy-informational translation and communication systems, which together ensure the formation and retention of the control energy – Mind in a stable state.

The Ebrov interventionist System did not have such a concentrated managerial universal "staffing" on any of its planets delivered for the implementation of the intervention. The entire minimally limited, necessary and mandatory set of control complexes and Objects for creating such a control cluster was distributed simultaneously on several of their imported "satellite objects" and on the planets of the Moon (there were 3 moons), the Sun and other planetary objects. In addition, most of the interventional planetary objects during the capture of the Earth were destroyed by Phaeton (as a former element of the native megacluster from among the planets of the model complex of the Earth).

It was impossible to assemble all the necessary energy-technology for the complex cluster control state on one of the planets for their level of technical perfection. And the Earth practically had such a perfect necessary set on its own. In addition, on the home planets, formerly representing together with Earth a single interplanetary cluster complex, which nowadays astronomers have given the conventional definition as a "Parade of Planets," – there was an assisting and complementary set of control complexes and objects, representing a single Model cluster complex of the Earth for its development for all the upcoming eight stages of civilizational development.



It is for this reason that they (the interventionists) needed such a planet as Earth, which, by acting on it with all their imported technological and energy capabilities, they would be able to create acceptable conditions for their program existence for themselves the acceptable conditions of their programmatic, parasitizing over captured constructive and energy capabilities of the Earth and its entire Model complex (a total of 12 planets without Phaeton). Therefore, the interventional strike on the capture was applied to the entire Model Complex. But after such a seizure, the general process of their own arrangement began, and not only on Earth, i.e., the alteration of everything and in its entirety.

The entire Earth System<sup>7</sup> previously carried out its motion by orienting itself relative to Sirius at a distance of about 240 billion km (the distance for Earth). The model of the orbital arrangement of the entire Earth Cluster System was completely different, and the direction of overall motion was not oriented toward the Polar Star of the Big Dipper.

The main parameters of the Earth before the attack were:

- angle of inclination to the plane of the ecliptic 25°,
- day = 48.64 hours,
- year = 864 days (relative to the charge oscillation tact = 1.007 sec,)
- the height of the lattices of the true Atmospheric Structure was 12,000 km,
- the number of layers of the formed lattices of the Atmosphere was 18.



The level of the surface layer of the Earth was almost 11 km less, the shape of the planet had a more correct ball design, such an array of mountain formations and other currently configured "garbage" did not exist. In contrast to the interventional design of the layers of the Atmosphere (currently existing), the construction of the true plan was significantly different, both in terms of functions and in terms of design. The construction of the lattices began from the plates of the firmament itself, i.e. the atmosphere began and was built over the plates (a rigid shell). The lattices of the Atmosphere were equipped with the so-called "Brain of the Atmosphere"<sup>8</sup>.

<sup>7</sup> A system on a cosmic body is created for the purpose of forming a biological structure that can be completely under the control of the System and execute the program of the System. System Tasks:

- Ensure the execution of Programs;
- to carry out constant monitoring of the execution of the Program;

<sup>8</sup> Atmospheric Brain - Information Units formed into infinite chains to provide and create various information bases and structures combined into a single System, placed in the range of altitudes from "- 2,400 m" to "12,400 m".





Before the intervention, the Earth had a well-deserved definition of a green planet and was a "tourist paradise", because there were no all-destroying enterprises even and, moreover, smoking pipes, since all technologies of the reproduction sphere were based only **on the use of energy taken from the environment, and most of the production of any products of any scale were based on the technology of model synthesis in high octaves of energy** with the transfer of the created model to the physical plane in the final form (by reducing the octaves of energy to the material plane, i.e. metallurgists were not required and metalworking lessons were not practiced in schools).

There was no oil, gas, peat and other nonsense, and there was no sulfur mud, and even more so there was no sulfur-based combustion technology.

There was no disease on Earth because the DNA structure was in a state of full activity, i.e., the control of being a flesh cell was carried out in the full state of all four DNA codons, which **ensured 1,300 years of the biological life in the physical plane of the proto-human** (however, note that duration of day and year were different). For the record, the Interventional System was never able to get to the mysteries of the fourth DNA codon, **so despite the populist merits of geneticists and gerontologists, the biological existence of the flesh cell has not been prolonged**. Moreover, with such low octaves of the brain of current people (maximum 63 octaves), a biological extension of life for more than 125 years is impossible.<sup>9</sup>

<sup>9</sup> Every bio-object on Earth is given its own life support system at birth, designed for 124 years of brain function. When the brain loses communication with the organs (e.g., the pericardial system), the brain stops the heart. The brain's executive mechanism is embedded in the cranium and spinal cord trunk. The center regularly provides information to ALL, and if the brain has the ability to "skim" and process received information, then the biostructure is at a sufficiently high information level. 4.28% of the brain is involved; brain development is facilitated by spiritual growth (not religion).

**Only by increasing the level** to at least 82 octaves, **will it allow you to extend** your biological life up to 250 years. **However, a little and timely reassurance is in order** – it is the geneticists and gerontologists of Russia who will be able to solve this problem first, positive steps towards this are already being taken.



At the initial stage of the interventional capture, only Phaeton, as a planet, was capable of entering into a fight with the aliens, which had protective functions for the entire Cluster System by its endowment. The forces of the attackers in general were: 54 satellites, 3 Moons, the planet Sun (it was a planet during the attack), 12 main objects (type 960) and 3,862 objects of attack (which had technical means of destruction, the main part of which were objects of type 440<sub>10</sub>). In addition, 1/3 of the satellites had their own planetary objects of active technical impact on the model scales of their satellites, which had limited autonomy (for a simplified and familiar understanding, like a UFO). The defenders of Phaeton took the entire active process of the destructive impact of the aliens on themselves and blew themselves up as a fortress planet in order to prevent their capture and being taken into "captivity", and especially to exclude penetration into its technical ability of a protective and destructive nature. Phaeton destroyed 2 Moons, 11 main objects, and approximately 1,200 autonomous objects of attack. Fragments of such destruction still sometimes disturb the Earth's Atmosphere.

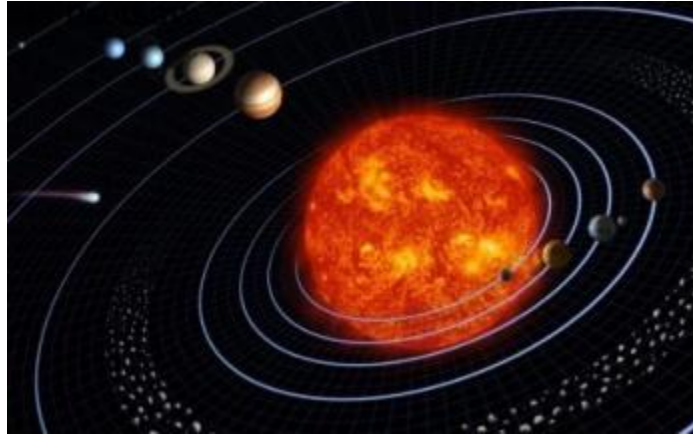
<sup>10</sup> UFOs are equipment for monitoring the state of the external environment (such as a probe). The location of all UFOs on Earth is  $-3,300 > h > -4,400$  meters. The main portion of UFOs is located precisely under populated areas. All UFOs are located near water basins, where there are sufficient reserves of tritium at a depth of 4,400 meters. Tritium is only necessary for the movement of UFOs within the Earth.



During 1,040 years, all the planets were completely captured from the first-contact aggressive invasion (the capture was completed in 17,914 BC). **The capture itself is conditional** because all main complexes on the planets of the Earth Cluster Interplanetary Complex were shut down, and without knowledge of the construction of their structures, and with a lower level of cognition, the attackers simply tied all the planets with gravity tubes (later also with **communication tubes**<sup>11</sup>), turned on the imputed base generating frequencies of the radiation protection of the Sun, surrounded the planets with "satellites" (as a guard convoy) and moved towards the Big Dipper to sort out its active reach zone. But on the way it was decided not to lose time and conduct possible processes of change in their favor...

<sup>11</sup> Communication tubes are a stocking like the Shukhov tower, in the tube there is a necessary set of frequencies: gravitational, informational. Magnetic pulses, which sometimes come from the Sun, move to the Earth only in the tube. If there are no supporting frequencies in the tube, the magnetic pulse is scattered in Space (it does not reach the Earth).



One of the most important changes on Earth was the change of the basic foundation of the formation of spaces **from the dodecahedral to a cubic structure** for the construction of energy lattices. The introduced cubic<sub>12</sub> energy grid, which framed all the previous states and structures of energies, changed and limited the state of the material world on Earth to a level acceptable only for foreign control Systems, changed all environmental conditions, including the atmosphere, water, the entire biosphere, etc.

The brain of the Earth before the attack had 512 octaves. The attacking interventionist planets had a brain of 224 octaves. As a result, for a number of reasons of incompatibility in the new conditions of the Earth, this brain of the interventionists up to 66 octaves was destroyed. The remaining structures of the Earth managed to preserve the brain of 57 octaves for a short time (mainly in the equatorial band) with a further decrease in its level, the population decreased by 67-68% and only about 2 million people remained, followed by their subsequent death.

The Easter Complex, as one of the main native escort complexes, (located under Easter Island at  $h = -12,450$  m) was completely turned off. After carrying out a number of program processes on the part of the interventionists, the person was turned into a kind of biological being that did not have the same independence of the brain. Over the past years of the Interventionists System, especially the last 4,000 years, the Intervention<sub>13</sub> Suprasystem has carried out a huge number of program processes through a modified System of surrounding structures. Including with all Life Support Systems, Bio-Centers of the planet Earth that create and support a person and directly with the Person himself.

<sup>12</sup> When creating the Earth inside the cube, there was a working structure of a different grid, and the cubic one was used only for control. More than 5 thousand years ago, a certain system changed the relationship of connections and, by introducing the imported elements, created a new type of lattice in which the whole world exists. The depth of this grid = 2,200 m, height = 12,400 m. This is the Noosphere, or habitat.

<sup>13</sup> Interventionist-Suprasystem - program communication with the Sun, Moon and satellites of the planets.

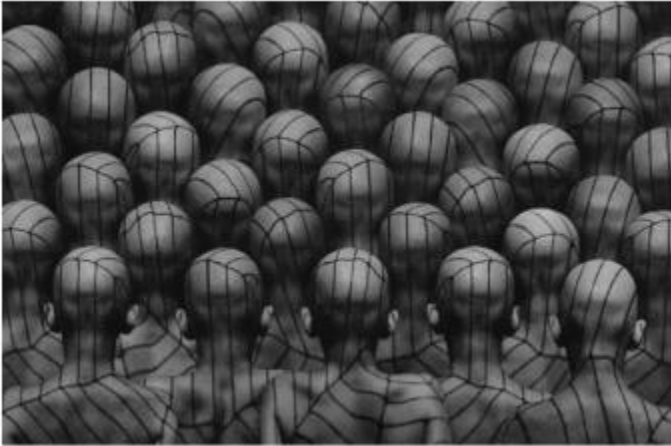
For these purposes, the interventionists introduced the program of "Energy Biogenesis of the flesh cell" and gained more significant capacity in the intensified attempts to create people (like a proto-Man), because the flesh of spiders, which is what the invaders were, is not perfect and is not acceptable for trying to "enter the Hierarchy of Civilizational development of Intelligent orientation" (as, indeed, is the design of their brain as well).



What is this program connection with the Sun, Moon and satellites of the planets, what role did it play in the general process of the development of human Civilization and the development of individual and social consciousness, in particular?

This connection, from the technical side, was: a certain set of formed "Communication Tubes" between the Earth on the one hand and the Moon, the Sun and the Satellites of the planets, on the other hand. With the help of such communication tubes, all information was transmitted from the generating and Control Complexes of the interventional System located outside the Earth to the complexes of the same Control System located on the Earth. This program information contained everything necessary to manage the entire development of the imputed Civilization at the conceptual level.

First of all, it was through this connection that the forcible retention of people's performing actions in the state of their material application was predetermined for all program processes controlled by the interventional System, and, accordingly, the gradual proactive development of individual and public consciousness before each historical event, an event-based performance step. With the help of the same information, all the processes of the existence of energies in general in their changed constructive state were controlled at the conceptual level, control was carried out and protection was formed to prevent any constructive changes in the energy grids from the true complexes of the Earth, keeping such complexes in a "captive" state, and so on.



The implementation of this, including the **formation of consciousness**, was carried out by the practical provision of all the necessary information installations of a "strategic and current" nature, which, for a long or short period, were broadcast for Complexes, Objects and formed Control Systems. The latter, in turn, through the energy-informational broadcast from themselves, controlled, i.e. determined all the subsequent conditions of execution and the necessary commands related to the development of the design, functions and construction of the energy-informational translation for people and the development of their brain during the long process of their supposedly "natural" perfection. **It was through such software installations, as commands, that the interventional System materialized people through their process of development**, from the "Tent" control<sup>14</sup> state of their being, to the present state, of the "Collapse of their Civilization".

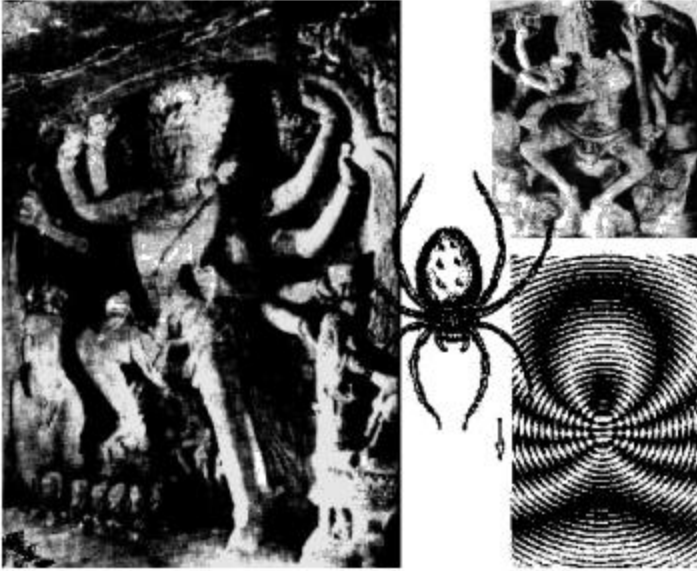
<sup>14</sup> "Tent" control - Biostructures on any celestial body have only the frequency spectrum that is provided by the System. This frequency spectrum is provided by UFOs (a dome is created, inside which the life of the biostructure is ensured, for which the frequency balance is unique).

The formation of the Brain genotype consciousness is a discrete sequential process of bringing the functional control information into the consciousness of individual representatives (performers) at a specific "historical" moment by means of the Control and Management Systems, accompanying and supporting Complexes.

Due to this, with the use of Control and Management Systems, comprehensive support was provided in the execution of program actions leading to results and events in the development of human civilization that was planned in advance by the System for the implementation of strategic programs of the intervention System: "The development of brain genotypes" and "The development of the energy biogenesis of the flesh cell".



According to their program, it was planned to raise the level of the previously destroyed Human brain to octaves of harmonious alignment with the brain of the interventionists (spiders). Further, they sought to introduce the interventionist's brains into the "human shirt" (body), to create and preserve individuals of this brain genotype in the amount of the "Golden million", to subordinate to them performers with a brain genotype of 44 octaves (from the composition of the Golden Billion in the amount of 500-600 million). The rest of the people were supposed to be destroyed in 2012, as waste material interfering with their paradise stay and development in the process of "forced" captive movement in the direction of the constellation Ursa Major (to the planet Sur, as their native Ebrov base).



Along with the transformation of the Brain, the biogenesis of the flesh cell also changed while preserving the external shape (body) of people. A person was transformed into an ebra in his essence, acquiring all the consequences of such a transformation in the form of a complete set of all parasitic functions. In the acclaimed Hollywood movie "Spider-Man", this side of the disposition of the main character is not provided by the screenwriters.

The process of transition to another, i.e., the previously imputed true path of civilizational development of the Earth according to a Reasonable orientation without recreating the true Management System of the Earth, is impossible by itself. It is also impossible to realize the true purpose of the Earth's existence in general and to fulfill its main functional endowment given to It when It was built by the Creator, namely: in the process of embodying all eight stages of its discrete complex civilizational development, to achieve perfection of harmony only of the non-inertial state of energies and one's Mind, becoming in the end a hypostasis of the Universal Mind!

Currently, more than 70% of the Control Systems, Complexes, objects and servers of the old System have been destroyed, and those that were saved have either been de-energized or reprogrammed for temporary use in order to ensure a flexible transition to new states of being, especially in the biological sphere. As a result, **on 2011.04.24, the change of the System Power was finally accomplished, i.e. the control of the existence of energies passed to the true recreating Control System and its Brain.**





The managed processes of the old Program are terminated. A very short, but very eventful period of preparation and transition to the active state of the process of implementing the new Program has come, especially in that part of it where the future Humanity is directly and indirectly involved in phenomena, actions and events of a completely different format. Software installations for control Complexes and Earth Systems for external support, both from the **Super-System**, and the **System** for the specified execution process itself have already been completed.

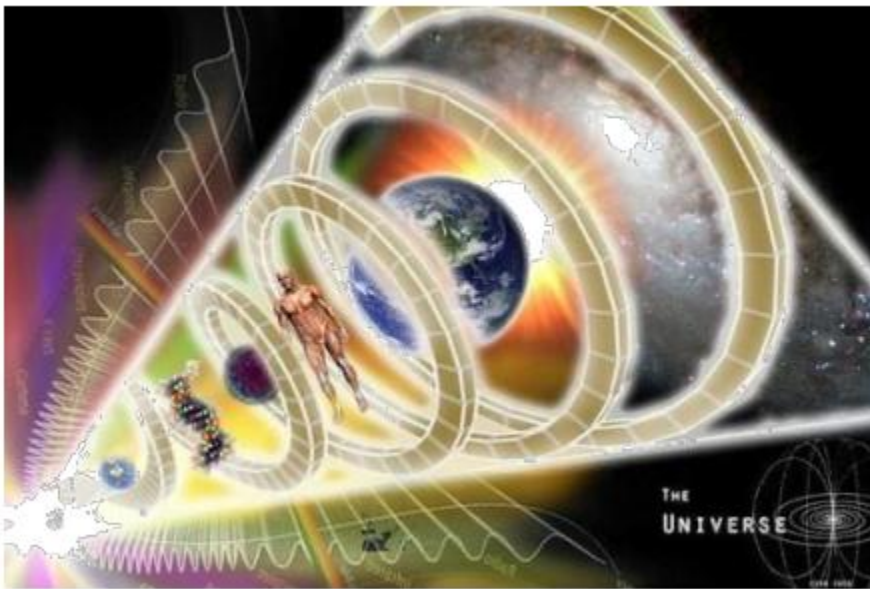
## 1.2. What is a Person?

**F**or further judgments, we need to be specific about Man himself, his purpose and his functions.

**Humanity itself** is nothing but a **single structure of the Human social organization**. As a social organization, **Humanity is a single function** intended for a model harmonious association, providing and accompanying each Person in the manifestation and complete fulfillment of the functions of its purpose.

**Humanity is a Subsystem<sup>15</sup>**, but it is not a secondary mechanism for a Persons application to the general structure of the hierarchy of program processes of the Earth model. **This is a social structure to which every Person voluntarily aspires with all his spiritual and mental beginnings.**

This aspiration is not for reasons of and the need for survival, but for reasons of ones on own conscious professional usefulness, i.e. the desire to give everything possible from themselves and for everyone, feeling their primary origin in the social organization. Then all their universal participation, including work, will be realized by them with Intelligence, i.e. with a full aspiration to conscientiousness with a truly realized personal function, as a Person and as an important element of the universal harmony of life on Earth. This is on the one hand.



On the other hand, **Humanity is a special program state of the Earth Model.** The fact is that the Earth had such a state before the invasion of the interventionists. Now this state will be restored during the transition period under the new Program.

The DNA structure before the invasion was in a state of full activity, i.e. in a full-model state of all four DNA codons, which ensured a biological stay in the physical plane of proto-Man for up to **1,300 years** in the active mode of his complicit useful existence.

<sup>15</sup> Tasks of the Subsystem:

- Execute all requirements of the Program;
- Respond correctly to all changes that occur in the execution of the Program.



During such a long period of biological life, previously a Person knew nothing of sadness when he "retired", but **went through a step-by-step process of perfection of the states of his Mind**, namely: assignment; mentalist; wise; concept. And the process itself took place with an increasing activity of the life position, significance for others, his surroundings and their corresponding well-deserved recognition. Three postulates, as a single axiom of logic underlying the past of the discretely formed perfect Consciousness of the Proto-man, will be published in Part 5 "Fundamentals for the Formation of Humanity". The formation of the perfect Consciousness of the recreating Person will be returned to the previous basis and this will happen quite quickly, **not measuring time by centuries**, but by decades (**especially during the Transition Period**).

The previous construction of the social order provided for **the gradual perfection of the Consciousness of individuals through the discrete acquisition of knowledge**, both general and specialized in the profile of their functional endowment in society and on Earth. **A person with all the social structure of society was guaranteed to be provided for in his development on Earth. In the beginning, he consciously gave himself for society throughout his subsequent life, comparing the usefulness of his being for others with the level of his Perfect Consciousness. Yes, while it is difficult to perceive this with the mind, but it was so, and for now it remains only to try to realize that it was this way!** Make bold attempts to gain your usefulness on any scale available to you, but for all those who are near or not! **You will begin to feel your useful place on Earth.**

"**Чело (Chelo)---Веche (Veche)---Ство (Stvo) (Человечество = Humanity)**" is the definition and level of such a state that proceeded from the following true awareness of the unique essence of the trinity of the obligatory hierarchy of complex self-governing existence of energies "**Supersystem--System--Subsystem**"<sup>16</sup>:

-"**Ство (Stvo)**" is the process of constant "creating or being created" control from the outside by objects with higher octaves of energies than the Earth (the Earth's limit octave is 512) and the Universal Mind as a Suprasystem;

-"**Веche (Veche)**" is the cathedral Brain, i.e. a concentrated harmony of all the managerial abilities of the Earth's Brain, as a complex multi-combined model function, ordered by its structural expediency with all the controlling target energy-informational connections and energy flows in all octaves with a Super-system without hegemony and antagonism. "Veche" is a developing System in harmony with the Cosmos;

-"**Чело (Chelo)**" is the body of the Earth, i.e. the Earth model itself, with all its most complex saturation, but on a smaller scale than the Cosmos and the same mandatory hierarchy - "Suprasystem-System-Subsystem". The "human" is a subsystem in the model with respect to external connections.

It is not Humanity (as a social association) that received such a name because of and from Man, but **Man has found this high vocation, because He is an important fragment of Humanity**, as a state of a general model, possessing extensive creative functions of a high level and order. At a lower level of the Human model, **there is a Subsystem in the Earth Model**. Being a Subsystem, a person forms a socially organized structure to ensure harmony between the mandatory functions prescribed to him and the necessary conditions for their implementation and the necessary support for this.

Could there have been a state of "Humanity" during the violent intervention of the Earth? Of course not, it is not possible. The temporary state for the entire period of the Ebrov intervention was defined as "zion", i.e. more familiar as **Zion**<sup>17</sup>.

**Zion – is DESTRUCTION.**

**After acquiring some elements of truth through the information presented, you and I have something to be quiet about!** It is to be silent in the following sense. Any attempt to acquire superficial knowledge in the "accelerated mode" (while still in the conditions and state of automotor "transfer egoism"); **this is the satisfaction of a surging "curiosity" in something that has arisen for some reason of a temporary nature.** It is necessary to perceive for yourself some functional feature of the activity of the Human brain concerning its mental and cognitive aspects (with the distinction of which, to this day, many specialists have not figured out, calling themselves both psychologists and political technologists among other titles, without paying attention to their list).



Without an in-depth contact with the physics itself, the occurrence of these processes in the fulfillment of such important functional capabilities of the Human brain as mental and intellectual activity (naturally, without taking into account corrective program interventions by the interventional System through the formation of 4XX Brain genotypes, since this is not the essence for them), but only from a model-philosophical point of view, the difference between them must be perceived as **processes of different functional levels, harmoniously providing each other with the accepted information of a COGNITIVE and CONTROLLING NATURE** in the interests of acquiring and developing the individual's Mind and subsequently creating a contact state<sup>18</sup> with the Mind of the Cluster Planetary Model Earth.

In this regard, **Mental activity is a process of "accumulation" of already formed elements of Consciousness in a strictly expressed hierarchy of their significance**, providing for temporary possible "omissions" if there are no significant or influential derivatives of them at a specific event point in time.

**On the formation of the substance and essence of such individual "Logic"** (when building a hierarchy of accumulation of elements of Consciousness), the basic determining influence is exerted by the functional endowment of an individual on Earth during his existence in the physical plane at this stage of the general chronoprocess of the development of civilization, which was acquired by the Spiritual Essence during Its creation.

Some "omissions" of the elements of Consciousness are certainly objective; they are temporary at the current stage of the "Manifest Rite", i.e., the existence of **the Soul Essence in the physical plane**. But at a specific moment of the event time, such omissions are advisable for a number of objective reasons. They will be "filled" in the general chain of Logic of the entire hierarchy of accumulation of elements of Consciousness as this missing (indispensable, necessary) element of Consciousness is acquired with anticipation before any action or subsequent event fragment of the general chronoprocess, **if the individual was directly allowed to participate in it, as in a direct or as in a shared general version**. Filling in objective "gaps" for some significant elements of Consciousness (to achieve development of the individual's Mind to the level of Perfect Reason) can be separated in time quite significantly and performed in two or more stages of the Revealed Rite into the material World, i.e. not in one "life" in the form of the physical plane of being of the Soul Essence.



If an individual leads some kind of lifestyle that does not allow him to embody Mental activity for subjective (behavioral-personal) reasons and for the same subjective reasons the process of "accumulation" of elements of Consciousness is not formed (**drunkenness, isolation from cognition, acquired vices of various kinds, etc.**), then a curatorial correction is carried out through the System to activate such capabilities and brain functions. **In popular rumor, they say – a person has come to his senses**. But if there are no positive consequences, then they get rid of such an individual, more often in a natural way.

For the Soul Essence in such cases, the correction of further functional endowment with possible processes of significant correction and the very **future Revealed Rite into a new physical plane can also be imputed.**

**A recreated Person** with a restored brain of high octaves will be able to and will approach the performance of his true functions in a completely different way (finally with a Mind), the fulfillment of his purpose will be accompanied by changed environmental conditions in the complex, changed software processes of the restored true (native) Complexes and Control Systems. If someone sees the above as a "product of futurology", then this is only an assessment of the level of development of his brain and nothing more. It should not be assumed that this process is calculated for decades, it is already happening, and the period for it is extremely short.

All issues related to the formation of a part of the Goal Vector of future phenomena, actions and events related to the construction of the future of Humanity are not extraneous to a Person, and "cheat sheets" from his past experience of building a "society" are far from acceptable in this case.

### 1.3. "Development programs" of the Ebrov management system.



There were several programs. The largest one – a **500-year program**, according to which the conditions for the formation of a human genotype that would be **under the full influence of the Management System** was to be created. In 1845 one of the stages of this program was the creation of a radiation web (the most complex design of energy grids in the layer "-4,400 m to +12,400 m"), covering the Earth, was completed. After this, the only ones that were to remain on Earth were those who could be controlled using the properties of the web and such a "Development Program" that would no longer allow a return to other ways of Brain development. People (and animals) that have a connection with such a web were conventionally called "electronics" (according to the old Program).



*So, the first goal was that only electronics were to be left on Earth, the rest would be **destroyed**.* To achieve this goal, any means were appropriate - wars, genocide in any form and scale, epidemics, etc. And all this was accompanied and provided by Complexes and Systems.

Participants (contemporaries) of the last historical century well remember the winged and inspiring slogan of Leninism (CPSU): "**Communism is Soviet power plus the electrification of the entire country**". (V.I. Lenin). Where did this madness come from?

For some reason, society did not think about this phrase, which briefly and clearly expressed the essence of the **centennial program**, but suddenly they were inspired to varying degrees and rushed to implement it, regardless of all the horror and the volume of people's losses.

The Soviet government (together with electrification), or rather the **pyramid of power** built under its basis, would provide correction and carry out the program presented to it (set by Management Complexes).

It should be noted that both public consciousness and science began to implement the program at the same time - a wandering ghost appeared in Europe for politicians and revolutionaries, and scientists rushed to study radiation. The control system selectively provided only the electronics with everything necessary, removing the Brain from the rest (step by step) and narrowing their range of sensitivity (awareness and receptivity) to the changes taking place. Those who accidentally stayed after the purges had to pass away "naturally" (according to the level of knowledge of pathologists and the teachings of Darwin).

Thus, the entire "heroic tragic history" on the scenes of all continents, often covered with a bloody veil, the procedure of active "development of civilization", which has experienced all forms, passed through several stages.



**The program also had a completion date - 2000.** By this time, the electronics were to have received a new Brain, and the rest - all kinds of diseases with a further and accelerated finale through an obituary.



Until this final date, all the work was carried out in the conditions of "counteraction and possible harm" from non-electronics, because the **knowledge from the Control System was given more often in a distorted form** and did not give an idea of "reality" to unnecessary individuals. This explains the periodic "bursts of activity" in the political, scientific, industrial and military spheres. Local or global confrontations in the actions of various "strategies" (geopolitics, domestic politics, manifestations of extremism in any form, etc.) were the resulting crown of this. Attempts to find out the truth, i.e. to take the initiative in obtaining information, were stopped by the System at the root and very harshly.

**The program processes of the twentieth century, excessively heavy in scale and intensity, extremely bloody in their inhuman target essence, completed the path of several millennia, and the resulting chronoprocess had a global Goal vector in time - growing and improving a specific genotype of the human brain** in the quantities planned by the program to the necessary point in **time in order to interface with the brain of the interventionists.**

The planetary biological program conducted by interventionist Complexes and Systems over Humanity in alien (not native) conditions of the changed environment of the planet Earth was forcibly completed. **Within the framework of the old Program, the development of civilization was not the primary and determining aspect**, it was not only secondary, but performed the function of only providing, accompanying and **fulfilling the role of legends for isolating and excluding a person from a possible AWARENESS of the fact of the Essence and Truth in the ongoing processes.**

This is the humiliation that was prepared for Mankind and for a long time embodied beyond his wishes. It could only lead to tragedy, i.e. had it not been prevented, the Earth itself would have been liquidated....

But, Man (and now, so far, people) managed to survive. Does it mean that He managed to organize something in the process of his survival, that is, there is something in His organization that must and can be taken into account and applied when executing the Goal Vector of future phenomena, actions and events within the framework of a new Programs? Moreover, **did something and someone help people in such anti-human conditions to preserve a grain of their true humanity?**

**The process of recreating Man HAS ALREADY BEGUN**, it is not instantaneous and, basically, cannot be initiated by a Person, but "individual opinions" will be taken into account, but in a very limited way.

This should become a special subject of discussion in the current period.



**Specialists and managers of the leading level, if they see themselves in the future and they are not indifferent to it, should take an active part in this discussion.** This is the essence of building a new future, this will be the foundation of the "national" and state idea of Russia (ideology, state structure, etc.), this is the solution to all the problems of Russia that have accumulated over the centuries.

**We will have to build Humanity and with recreated Man!**

The "construction site" is ready to work, the building "materials" are ready to form. The Essence of the Conceptual Power ideology is manifested; the Essence has acquired the states of readiness for implementation of the New Program Processes.

### 1.3.1. The conceptual power of the old Program.

**T**he Component of the power structure is represented by the following unchangeable and mandatory hierarchy:

**Conceptual power,  
Structural (state) power  
Structure-less (public) power.**

Structural and Structure-less authorities in all past historical periods were presented in various forms without changing their main point and essence, but had some specific features and manifestations due to the imposition of various religious and occult judgments, as well as the level of development of civilization at all its stages.

Their implementation since the beginning of the 18th century had some additional features. The emergence of clan structures and secret orders (organizations) of various scales, which influenced the degree and effectiveness of the power management of society, has made and is making influential adjustments to the construction of the very model of Structural and Structure-less power at the last historical stages.



**The leading and declaratively defining level has always been and remains Conceptual power. It is the dictating and predestining principle for the subsequent levels in the entire hierarchy of power in general.**

Within the framework of the current program-historical moment and in the new Program for the future, It is of the main and most refined interest for a number of reasons, the judgment for which they try to publicly bypass or transfer it to the level of a limited circle of participants, if they really have something to do with it. Curiosity in this case, as well as someone's initiative conjectural interest in career and other goals due to conditional or feigned involvement in this, has always had serious consequences for the initiators.

Often in the history of events that occurred, such labels, actions and subsequent events were mistakenly attached to the level of Conceptual power, which were organized only by the level of Structural and Structure-less power for background manifestations. And historians and their equal falsifiers, in cases of unsuccessful results on accomplished events, try to courageously look for "enemy agents" at the level of Conceptual power, allegedly organizing all the negative actions with an invisible secret hand of power.

All those individuals, single or within a group, who were really, and not according to legend, involved as true performers in the preparation and manifestation of the ongoing or future events, could never be in an open state. They should in no way be confused with representatives of any intelligence or special forces structures, we should not seek them out and form literary heroes and images based on them. Moreover, compliance with the mandatory condition was always extremely strict and rigorously controlled by the System – simultaneous participation in actions at the level of Conceptual power and Structural (Structure-less) was not allowed.

All this once again confirms the fact that it is extremely difficult to determine who is actually an involved executor at the level of Conceptual power, who is a performer from "historical scenery", and who is an initiated historical upstart or a career figure.

### **What is the Substance and Essence of Conceptual Power?**

For some reason, Conceptual power is more and more covered with a veil of mystical mysteries, occult and religious judgments and has an invisible hidden insurmountable barrier surrounding it. Information and direct or indirect participation in it is maniacally brought to an extreme degree of inaccessibility for most people. The Mythology is only available to a few "chosen" and "initiates" who have appointed themselves as such for various reasons that have nothing to do with personal merits, achievements or having something special, non-human, but necessarily by inheritance!

According to the results of all recent achievements in the level of cognition, *modern science has finally admitted to itself that the World, created by it through the whole complex universal system of model representations, is quite different from the true World, i.e. the one surrounding us!* To live in the "virtual house of cards" built by science has become very dangerous for them! And to get out of it is for them a step into the next unknown and unknowable.

In truth, that is, without taking into account the opinion of "modern science", theory is only a tool for assessing the degree of Brain development in certain groups of people of a specific "brain genotype" through knowledge of the World. The level of cognition of the World and the degree of Brain development is provided and carried out by influence, contact and control "from the outside". It should be understood that in the process of knowing the world, people cannot only make scientific discoveries of the true world, for they were provided with information from outside.



**The very essence of Conceptual power lies in the manifestation (phenomenon) of the Ideology of Conceptual power as CONTROLLING INFORMATION "FROM the OUTSIDE".**

It is necessary to take into account the invariable mandatory sequence of the program execution of being – a phenomenon; an action; an event.

The **phenomenon** of Ideology within the framework of Conceptual Power is presented as a predestining step in the entire further personification of being, i.e. the very process of Program executions for the management of society and, in the determining part, the direction of the development of human civilization.

The implementation of all Program **actions** and **events** related to the mandatory direct or indirect participation of the society of people (all or part of it) inevitably begins with the **appearance of the Ideology of Conceptual Power**. "Sacrally" (i.e., with the help of the Management System), the Gospel was noted: "In the beginning was the Word...".

Ideology is followed by specific management processes in various forms and aspects of their declarative manifestation in the sphere of Structural (State) and Structure-less (Public) authorities for the organization of strictly defined actions leading to **Program events previously provided for by the System in the Vector of Goals of phenomena, actions, events**.

From the peaks of the historical past, as a completed Program, it is necessary to pay attention to an important and problematic question – did the "chosen" and "dedicated" participate (without impostors) in the formation of the "future" during the execution of the Program itself? And if so – what did the participation itself mean, if not, what was their role? The answer is embedded in the second part of the question about Conceptual power – **what is its Essence?**

**The essence of Conceptual power is a discrete sequential process of bringing functional control information to the consciousness of individual representatives** (performers) at a specific "historical" moment by means of Control and Management Systems, accompanying and providing Complexes.



We will not evaluate the results of the completed Programs, but we will certainly note something that concerns only Conceptual power:

Throughout all the periods of performance, its role and functions were then harmonious and maximally expedient, when it has had the fewest deviations from the essence of the Ideology given from outside.

The old Program has been completed; a New One has been formed with different goals and for new conditions. A new set of Goal Vectors (future) has been formed for new phenomena, actions and events that will be implemented within a certain defined time period through other higher-order Software Processes.

### 1.3.2. What Is the Essence of the completed (old) Program?

**F**or the last **18,000 years** (especially the last **4,000 years**) the Essence of the Ideology of Conceptual power was in the **Vector of the Goal**, which was framed by the following target framework - "**From individual disunity to concentrated conciliarity**".

The framework of this Goal Vector combined a huge number of Software processes, both in the material world and beyond.

The determining factors of the entire history were changes in the biological sphere of man, and after them there were processes of change and improvement in the social environment, knowledge of the world around us, technical and technological perfection and many other actions, phenomena and events that we observe today as the outcome.

The development process took place from a single group number of person of 42 brain genotype, their accompaniment, reproduction and settlement on the Planet in order to give them and work out on them the leading roles in the developing social structures of groups of people who were taking on the appearance of societies. In the future, the predominant features of brain development were applied from generation to generation. **The development of the brain genotype was primary, and all the speculative processes connected in a single historical process of the development of civilization were secondary.**



Each "historical period" had a particular target framework in the general Vector of the Goal, all processes had their own correction taking into account geographical and natural features, time conditions, levels of economic, cultural development and other conditions.

The Management and Control complexes exercised control, **either acting directly**, i.e. on certain large groups of people (peoples) appointed by them, **or through individual performers of contactee** who, according to their special brain capabilities (42 and 44 brain genotypes), could perceive the control information and be guided by it. In the second case, the Control Complexes always controlled the execution process, provided support in giving sufficient manageability to the bulk of people, leading and organizing actions and events for the manifested Essence that comes to the contactee. **Sometimes a combined control method was used.**

The essence of the former Conceptual Power is the **MANIFESTATION** of its program processes **through contactors of performers** for further implementation through **ACTIONS leading to EVENTS** – there is its controlling function (with the forced participation of people), performed through the old Management and Control Complexes from the former System.

### 1.3.3. What is the Essence of the completed (old) Program?

**I**t is incredibly difficult for a Person to realize that He, in his opinion, being a natural perfection, is not really the culminating peak in the surrounding nature, at least on the scale of the Earth. People are only a certain component in the harmony of the biological sphere, which has been miraculously formed by someone programmatically, exists and is being improved with some external control.

Moreover, it "turned out" that almost all this happened outside the will and desire of people over the past 18 millennia. People rule (reign) only in that part of nature surrounding them, in which they were allowed to, by the level of control from the outside within the framework of the old Program, i.e. by Conceptual Power.

**The material world for us and around us is one.** There are no other spaces, only those that exist for us. But there is a level of "underdevelopment" of the scientific class that formed and still continue to form "knowledge" in the world around us where it does not exist and cannot be.

Such knowledge was given from the outside by the System for which the Earth was only the sweet fruit of the results of intervention and its temporary application.





Society (understood as "civilized") for **more than 18,000 years**, has been forcibly **located on the lower stages** of their "human" development. The transition to the next stage of development, in accordance with the processes of the new Program, is the connection of a new basic foundation for the formation of spaces - the dodecahedral, as the next level of development. A complementary consequence of this is the inevitable change of the charge cycle **FOR** the **FULL** (all true native) **range of octaves of the Earth's energies and the recording of information about the next step in physics, chemistry, biology and other areas, and tools for true knowledge of the World**. The prospect is incredibly grandiose, bright and very enticing, but, of course, the question arises:

**How did the "captivity" of the Human brain happen, why was all knowledge given to him outside of his will, why was It used as an object, and He was not at least made aware of it?**

Before attacking us, the Ebrov civilization studied the structure of our Cosmos. They learned the golden ratio, the conditions and principles of possible rearrangements of biostructures to suit their needs and programs, predicted the creation of possible symbioses and forms of mutations for their future experiments and practical applications, etc. One fact only could demonstrate much; of finding a huge number of biological monsters of enormous size, located in the World's oceans at depths of more than 4,400 meters. But this secret was always guarded by them with particular rigidity.



The main selection of contactee performers was carried out through Kailas, since all matrix storage of all brain genotypes and, moreover, weekly monitoring of the brain state of the entire population was carried out by them at this location. The Programs included "**Concepts of a step-by-step format**", which is why the power was called Conceptual. The control result in the execution should have completely coincided with the concept originally laid down.

Over the past century, the Conceptual Power implemented through performers has not always kept pace with the Program. What kind of interference occurred during the execution process, which prevented the correct perception of Program functions?

The fact is that it was during this historical period that the balance of the hierarchy of Structural and **Structure-less power was quite often significantly disturbed.**

Thus, the **effect of confrontations**, which is not desirable in management, began to manifest itself, which should be expressed as **extreme egoism**. It played only a negative role in the effectiveness of the management process in the execution of the laid programs.

The brain of most performers was not ready to reproduce the functions set by the System, and It began to clean the "golden billion"<sup>19</sup>.

In 2000, the System attracted a number of performers who were prescribed completely different administrative corrective management principles related to preparing for the transition to their other program states.

All this would eventually lead to a complete managerial collapse and the destruction of the managerial principle, the signs of which are already manifesting in a clearly completed form.

The entire system of the Essence of Conceptual Power has been completely rebuilt and reincarnated under the processes of the new Program. This means one thing – the old Conceptual Power no longer exists, and motor habits and the domestication of former performers will quickly pass. For those who have this process will show signs of transition to a protracted format, the new System will react accordingly.

#### 1.4. The conceptual basis of the economy in the formation of the Humanity of the future.

There are innumerable judgments about the meaning of human life, the historical and other causes of the formation of states and their international hierarchy, explanations and justifications for the direction and of the rate of development of societies, their construction and all areas of management, separate or the Cathedral of coexistence, what is the main purpose of the people on Earth, what's the point life, etc. Indeed, this was of concern to people, and the worries were quite justified. But were they profoundly true?



All the causes and patterns considered and agreed upon in today's secular world are consequential, not profound.

To date, there has been no answer to the questions:

– For what true reason did people gather in societies, how and for what true reason were states formed earlier and their borders determined?

- How were ethnic groups formed, what role do nationalities play in the essence of the unified process of civilization development and was it unified?

- Why do people speak different languages and how many of them are there in reality, why exactly are there so many of them?

- What is the "recipe" of a numerical, national or other formation, is it universal for all societies or is it unique for each society?

- How do you build a society of the future on the basis of the ashes and ruins left behind, formed from the complex and active impact of all the "achievements" and targeted aspirations of the current civilization?

- Who will be left to build the society of the future?



The old System not only did not allow people to ask questions in this form and for this purpose, but they were also not allowed to reason like this. It provided only a "figurative-behavioral" form of existence of people who were in a purely "subject-applied" state of their passive existence and extremely limited "free" rational framework.

The manifestation of the answers to the requested causality of the past states of societies throughout all the historical stages of their development will allow us not to make mistakes in the formation and existence of Humanity in the future. This importance, in turn, will determine the exclusion of uncertain steps and incorrect decisions in the participation in the

formation of the Goal Vector for the transition period in future phenomena, actions and events...

### 1.4.1. The true reasons for the formation of societies and states.

The Atmosphere, as the environment for the existence of mankind, was formed together with the Earth. After intervention in its structure by the interventionist System, it is currently represented in 6 layers:

The base layer has the entire set of frequencies necessary for the existence of current people.

In the accumulative layer, the process of accumulating or removing frequencies is carried out weekly, followed by their distribution among the other layers.

In the materialization layer, all types of humanoids are transferred to material structures (putting shirts on them), as well as the materialization of UFO objects after their rising, if necessary.

Each layer, except for No. 3, has sublayers in which different frequency structures work to perform the same function.

In the initial period, each object from which humanoids were obtained formed an individual "tent" for them, within which the development of this group was carried out under the control of the object without reference to the habitat. It was impossible to go outside the "tent", outsiders were not allowed into the tent.

When the Earth Management System was put into a state of new functioning, adjusted for it, all biostructures began to be bound to the local habitat within a certain distance from the Object. First of all, this environment was formed by the Andes Complex, then by the Caucasus, and since 0, by the Alps. The colony of humanoids living in the "tent" of the object would be called an "ethnic group"; in the future it was known as a nationality.

Each ethnic group had the same organ structures, but different brain structures. The brain or the properties of biostructures, as a system of external and internal control, memory, orientation, and information exchange properties, were basically also the same, but they differed in the base. The base is already the individual properties of the ethnic group, relative to which the exchange processes of receiving and transmitting information or translating the language.

On the territory of Georgia, for example, the basic element is manganese (the Ossetians have a different basic element; this is a different ethnic group). When almost all of the manganese was mined from the deposits in Georgia, the population began the processes of the "thickening" of blood and an increase in pressure in the small circle of blood circulation. Actually, this was noticed in 1989.

The control system, in accordance with the location of the "tents", 3,500 years before the new era, began to link them to atmosphere layer No. 2.

The primary lifestyles (culture) and the boundaries of the habitat of this group with reference to atmospheric layer No. 2 were introduced to the Program set value. The boundaries of the habitat no longer had a tent shape. In the center of the previous form, the "capitals" of ethnic groups were created. Regarding this, the construction of further settlements began, etc.



As they developed, in order to stabilize the management in the execution of Program processes, restrictions were introduced within each ethnic group that did not allow different groups to merge, i.e. to mix. This was framed by the imaginative and behavioral introduction of various traditions, beliefs, etc.

The main Program goal was to create a "Golden Million" on the basis of the "Children of the Sun", and all ethnic groups were only to be used as consumables, on which Program experiments were carried out to improve and bring the brain to the desired genotype according to their program and in the right quantity.

The intermediate group of the "golden billion" began to form from the year 0 of the new era. They could have up to 12 language translators in their brains for communicating with other ethnic groups, and they began to receive the primary necessary information for the "creation" and "implementation" of new technical means. Societies began to manifest, form and improve, states were formed, and everything went, as it were, as historians are trying to tell us in pictures.

With the help of modern theories or speculations from the past, it was not possible to answer the question of how the numerous compositions of societies were formed. According to what qualitative and quantitative "special recipe", how many and what groupings of ethnic groups need to be recruited, in what quantitative and qualitative limits were needed to reach a full-fledged society, is this a controlled process or is it subject to spontaneous formation, why periodically are there demographic problems?

Is the recipe for the formation of all societies the same or is it unique for each separate group? And, finally, who determines the borders of states, without any military disputes or interventions, i.e. in another way?



After the completion of the processes for creating a unified grid of the Earth's atmosphere modified for its Programs, there was no need for a rigid binding of ethnic groups belonging to their specific locality, since **the lattice of the atmosphere had acquired all the necessary properties to accompany the existence of the entire diversity of ethnic groups anywhere on Earth**. From that moment on, the private program functions acquired by societies and assigned to them for execution, which, in accordance with their Vector, determined the Goals of future phenomena, actions and events, predetermined the entire program structure of subsequent events in this society, became a restraining force from chaos and mixing of ethnic groups (nationalities), as previously established societies. This will later be called the historical stages of the development of civilizations, states and their groups, etc.





The main geographical reference points in determining the borders between states were both the located complexes and objects themselves, and frequency binding through the brain of specific genotypes with the frequencies of some chemical elements that were present in the deposits of this territory. Such frequency binding, first of all, was the secret recipe for the selection of precisely such numerous or homogeneous types of ethnic groups in society, which was necessary to fulfill the full function of each society.

At each individual stage of the program execution of its functions, society can and should have a **certain number of performers of specific brain genotypes**. This determined the quantitative composition of society, the corresponding demographic change associated with a certain stage of program execution. Any artificially introduced non-programmatic intervention in solving the demographic problem would not work.

It may be a legitimate question to ask why there were so many bloody wars in defense of their territories, all wasted losses and unnecessary human grief? Unfortunately, this is how the old Program eliminated unnecessary brain genotypes after the next stage of its improvement was carried out within the framework of the old Program.

During the transition period, the previous conditions must certainly be taken into account in their true state, but in the conditions of the new Program, the process of the formation of Humanity will be based on a different foundation.

#### 1.4.2 Harmony of Man, Harmony of Society.

**A**t all times of his existence, man has been tormented and plagued by the same question: why does He live and what is his role in the overall structure of the universe? He has not yet found an answer to this question. And he could not have found it in the conditions in which he found himself not by his own will and desire. Human development took place through trial and error, through many false theories and principles. At the same time, the best minds put forward unique but underestimated development principles that could only be implemented in the future.

Humanity has entered a fundamentally new phase of its development. Its mission is determined from above, and all its activities are managed and directed by the System through the definition of new programs.



One of the undeservedly forgotten principles is the **principle of Harmony**. It is this principle of development that should be laid down at the present stage of human life.

So, what kind of Harmony can we talk about in relation to a person? The question is absolutely not idle, since the correct representation of this concept determines the choice of the general strategy of behavior and development of all Mankind.

**First**, we are talking about the inner harmony of an individual, especially a Person of the future. It can be characterized as the ratio of his desires and opportunities and, as a result, the degree and depth of his self-realization among others equal to him as a person.

**Secondly**, the harmony of the interests of an individual and human society within any social structure at any level, up to the future of Humanity. It can be expressed as an optimal combination of its maximum usefulness for everyone and personal interests.

**Thirdly**, the harmony of universal interests, i.e. large-scale optimization at the level of interstate relations based on common interests and values, followed by the transition to a single global community, without the hegemony of one over all the rest.

**Fourth**, the harmony between man and nature. A person should consciously deny himself the role of "king of nature" and realize himself as its guardian and defender.

And, finally, the entry of humanity into the cosmic unity.

A new era and many familiar things are coming, and dogmas should be rethought anew, i.e. on a fundamentally new understanding and knowledge of a higher order.

The spiritual life of a person and society is a quality that distinguishes their being from natural existence and gives it social significance. It is in the spiritual life of a person and society that the truly human essence is reflected and manifested. The spiritual life of a person is formed on the basis of his practical activity, as a special form of perception of the objective world and as a means of interaction with it. The structure of spiritual life is extremely complex; it is based on individual and social consciousness. The elements of spiritual life usually include spiritual needs, spiritual activity, spiritual values, spiritual relationships and spiritual communication.

Since the core of a person's spiritual life is **CONSCIOUSNESS**, it is impossible not to try to at least denote the essence of this concept.



The question of how consciousness is formed and on what basis it functions continues to be the object of close attention by scientists. And here it is impossible to do without considering such a category as "INTELLIGENCE".

Various spheres of human activity involve the development of certain intellectual abilities. But in all cases, sensitivity to new topical problems is necessary. **An indicator of the development of intelligence is a person's freedom from external restrictions, his lack of fear of the new and unusual.**

Thus, it is time to reveal and develop the intellectual capabilities of each person and build an intellectual, truly spiritual human society.

The transition to an intellectual society inevitably leads to radical changes in the arrangement of the state and the economy.

The state cannot exist in the usual way, in the new conditions of harmonization of the whole life of a person. New approaches are needed, coupled with new System Programs.

The new requirements can be implemented most fully within the **framework of new economic relations**.



Supporters of harmony have not ignored this aspect of human life, which is reflected in the doctrine of harmony of interests. The teaching was based on the condition of the absence of contradictions between the interests of the individual and society.

In the new conditions, **the economy should reflect the interests of every citizen and be understandable to all members of society**. It is necessary to introduce such economic indicators that would help restore confidence in the authorities. As one of these indicators, you can say it would be better to introduce the volume of the consumer basket in physical and monetary terms. The introduction of this indicator allows us to visualize the efficiency of the economy. In addition, this makes it possible to switch to the balance method of forming the entire economic policy, and therefore to effect state management and regulation of the national economy. Special attention should be paid to the creation of a reasonable system of price formation in the country.

The entire organizational and economic mechanism of the country's governance should be rebuilt.

The distribution of budget funds should be handled by an independent structure, such as, for example, the Treasury of Russia. The planning and forecasting system should work more clearly.

Only the reference points of the transition period are indicated here, but even in this case it is obvious that there will be a long and painstaking work under the control of the System.

It is also obvious that there is no other way for a person to create a new harmonious society.

### 1.4.3. The role and functions of the Economy in the societies of the past.

**T**o determine the role and functions of the Economy in the Goal Vector of the old System, the necessary restrictions should be introduced, namely:

- limit ourselves to the period of the last two centuries, as the most active and intense phase in actions and events to implement the Goal Vector of the old Programs in the field of economic history, orientation by pace and orientation in the development of civilization;

- in the current judgments for the future, to protect oneself from the comprehensively prevailing dogmatism of the established traditional historical postulates of the entire economic theory of the past, as a tool for organizing and managing economic issues, i.e. the Economy, within the framework of the old Program, which imposed an uncontested dictate in determining the goals, paths and rates of development of civilization;

- to recognize the entire economic history of the past as inhumane, which excluded orientation towards people and in the name of people for the purposes of its development, applied them in the practice of implementation, as an economic tool, and not a goal;

- as a fundamental basis, accept the true essence of the Goal Vector itself, previously hidden from people by the old System and the Super-System within their Program.

In the future, unfortunately, manna from heaven is not expected. This means that it will be necessary to organize the active labor participation of a huge number of people scattered in space and time, turning it into an orderly structure of a social organization capable of reproducing and fairly distributing all the necessary material goods and services in order to support and fully provide the necessary conditions for the performance and disclosure of their individual functions by each Person.

**For the first time, it is necessary to give a **targeted** humanity to the new economy of Humanity, as an alternative to the previous one.**



Previously, economics did not have a human orientation. People were taken out of the scope of the target focus when determining the ways of economic development at all stages of its formation. The economy developed mainly for any other purposes, but not to meet the full needs of its harmonious development and not only of the producers themselves, but also of the other participants of society who were forced or were voluntarily involved in the non-productive sphere. Labor was a forced compulsory measure, as the main condition for the survival of everyone, and not a creative urge to benefit anyone from their professional application in any field of reproduction and embodiment of their gifted abilities.



WE WOULDN'T HAVE DREAMED OF THIS BEFORE.

This fundamentally predetermined everything, including the processes of the general cognitive development of the individual and his creative abilities and distanced people from the essence of Man and his purpose on Earth. A maniacal attitude to consumer values was intensively formed, as an end in itself in the life of everyone and everybody together.

Building up consumer values only in the name of increasing their number was brought to fanaticism and became not only an end in itself in life, but a basic forming element of the entire system relations in the sphere of economic management in society, i.e. in the economy.

The whole way of the system, symbolizing and personifying authority, the very structural formation of societies in a pyramid form of construction – all this was oriented in the name of acquiring material values of various kinds, turning the entire way of life of societies into a state of irrepressible profit for profit. **It is in these states that a Person no longer exists!**

How can this be avoided in the future?

The economy is one of the structural and functional subsystems of society, which is responsible for providing material resources to society and its subsystems to perform their functions and to solve problems arising within them and between them. - scientific opinion at the Plekhanov Russian Academy of Economics.

The main forms of integration for ways to overcome spatial, temporal and technological gaps between different links and stages of the process, i.e. the entire chain of labor participation in the transformation of resources into products - ***exchange, redistribution and reciprocity.***

The most important form of integration, especially in the last century – is **exchange**. Exchange, as a form of integration of the economic process, is a counter-directed movement of goods and services between the parties, each of which strives for its own benefit.



Random acts of exchange by themselves do not create a **price** that is mandatory for everyone. Such a price arises only when a special institution, the so-called free market, arises.

**The market** – an institution, i.e. a stable social structure that exists specifically for acts of exchange to be carried out in a socially or by someone else's recognized form that is under management and control, not necessarily of state significance. Such a rigid dictate of ideology and control in the last century was organized and executed by the nadiudean priesthood - **one of the methods of the former Conceptual power and an effective tool of influence in the management process!**



There are known **pre-market, market and post-market** economic systems.

Such a form of integration as the **redistribution** of material goods and services, including land and natural resources, was widely practiced. Gathering in the center and distribution from it, based on the requirements of custom, law or dictated by the circumstances of the authoritative decision of the central body.

The most ancient form of integration – **reciprocity**. Relations of reciprocity are very characteristic of societies, the main binding force of which is blood kinship.

Depending on political and ideological preferences, it was believed that the economy should be socialist or capitalist.

In fact, for capitalist, socialist and liberal-democratic economic systems, the former System defined functions hidden from people. And it was they who directly influenced the entire social structure and dictated the formation of Structural power. Namely:

- **For the capitalist economic system** – to ensure and accompany the development of all the necessary preferential basic social conditions for the formed and developing brain genotype 42 and the emerging genotype 44, bringing their quantitative composition to the framework of the "Golden Billion".





In the process of implementing this step-by-step, public-state formations and their management were formed and improved in a local and international format. The system of cognition was improved through the system of all levels of education on the basis of elite regulation, the system of "choice" was worked out in all spheres of life, rigidly ensuring the preferential social position of the established brain genotype 42 and developing genotype 44 in societies. Legislatively and on the basis of the "customs and rituals" introduced by them, a system was formed to ensure that they received special material goods and services that guaranteed them a special social status in societies, symbolizing the function – "the power of authority".

In the sphere of economics, it was supposed to give unshakably imperious forms to the entire complex economic instrument in the form of capital, giving it a function – the "power of money".



To create a guaranteed illusion of democracy through free access to the issued derivatives of non-mandatory "valuable documentary assets", by strictly regulating the volume of their release, values and ownership rights. The implementation of the final step of the Goal Vector – "... towards Concentrated Conciliarity", to be completed by the year 2000 by the establishment of a complete dictate over the natural resources of the planet and the mandatory introduced form of integration - "World market exchange".

Full governance and regulation can be implemented through the "Globalization" program<sup>20</sup>.

- For liberal democracy - within the framework of the developing platform of capitalist management, to bring the perfection of the administrative tool in all directions and forms of management to a state of complete concentration of the "power of authority and the power of money", ensuring the transfer of the entire management of the "Golden Billion" structure to new Performers from the Conceptual power, consisting of only brain genotype 44.

In the sphere of economics, the power forms of all economic instruments should be reassigned and transfer of all property rights to them, the Performers of the Conceptual Power of brain genotype 44, while preserving the possibility of limited (subordinate) administrative management in the areas of finance and administrative support for brain genotypes 42. And, to ensure the manifestation and preparation of brain genotype 46 ("Golden Million").

To improve the illusory nature of liberalism and democracy in societies, deploying abstract activity and freedom in everything except management and penetration into the sphere of Structural power to anyone who does not belong to the brain genotypes 42 and 44. Representatives of these brain genotypes are allowed to lead the Structure-less (Public) power, isolating it from penetration into the functions of the "power of authority and the power of money".

To provide informational isolation from high-level knowledge, to lead other brain genotypes to mental, spiritual, psychophysiological and physical degradation. By 2012, be ready to switch to another program function within the framework of the acquired position and state.

<sup>20</sup> Cosmopolitanism, as a strategy, has been introduced as the most important point of the 100-year Program since 1888. All the Programs have been executed and have smoothly moved to the next stage – Globalization. The role of the State is being strengthened within the framework of the Globalization Program. Globalization is the division of the entire System into two independent structures: information about the existence of the upper part of the pyramid will be given in the form of legends; the lower part of the pyramid – production structures, or States. Globalization implies a reduction in the population by more than 88%. If there is a small correction of the Program, then not only Cosmopolitanism will collapse, but also Globalization.

- **For socialism** – as a management system, it has acquired a number of special functions, because the Vector of the Goal of the old Program was to give the territory of Russia a certain special status as the territory of the future residence of the main part of the "Golden Billion" and the entire composition of the "Golden Million".



The formation of the entire territory of the USSR is dictated by the peculiarity of the location of objects and complexes of the Ebrov System, and the preparation and manufacture of the entire complex of resources ("natural") base.

To implement such a specific and extremely complex Goal Vector, a very complex **system of State management**, i.e. economy, was created for the first time, with a huge aspect of the experiments conducted in management and economics. Conducted:

- appropriation and development of the management of society without the participation of religious forms and tools. In the future, this was expressed as the ideological basis of society;
- replacement of the coercive-violent nature of labor with compulsory labor service, but called it as an inalienable public honorary duty;
- substitution of the mandatory division of labor for the work of enthusiasts without obligations of quality and orientation to quantity (collective farmer, tselinnik, severyanin, bamovets, etc.);
- testing of the method of integration - *redistribution* in the management processes of a special complex large-scale management;
- to prepare and develop the entire system of necessary management and means of its support on the territory of Russia, as the area of the future residence of part of the "Golden Billion" and "Golden Million";

- to form a necessary volume of circulating substitute for further acquisition by it on the part of the "Golden Billion" throughout the territory of Russia;

- to provide all the necessary social advantages and positions, to accompany everyone with the necessary material benefits and services with the brain genotypes 42 and 44.

The historical specificity of different epochs is expressed in different combinations of essentially the same forms of social organization.

Such monotony is due only to the fact that all these millennia (18,000 years) **were controlled by one System and it did not plan to change anything**. Are similar functions and management tools suitable for the future of Humanity? Yes, some tools can be saved by name, but their essence will be completely different. **Everything will start to change now, when a different, native System has started to manage!**

## **Part 2. THE FUTURE: SAVING HUMANITY**

In the Vector of the Goal of the old Program, the economic paradigm dominated society more often than necessary. Within the framework of the new Program, our task is to bring the relations of the future economy and Humanity to a state of complete harmony - into a single manageable state of Human Economy, as **a single model of a reasonable balance of economic and social development in the name of Man.**

### **2.1. The basics of the formation of Humanity as a single structure of a social organization.**

**A social system** – is a term that distinguishes the world of people from other systems – natural, technical, etc. But society differs from other social systems, such as the family, the state, various forms of association of people and their joint activities, in that it contains all of them.

The structural and functional theory of social systems defines the four most important subsystems, i.e. four system functions, without the implementation of which no society is possible. Such subsystems should be considered: *the state, or the political system; the value-integrative system; culture; economy*.

The *state, or political subsystem* of society, as a Structural power, includes institutions of public administration, political activity of citizens, dressing them in the framework of Structure-less power, etc. To fulfill its complex system function, this subsystem needs material and other means that it receives from other subsystems.

The *value-integrative* subsystem is needed to ensure the necessary level of socialization of young members of society. Thanks to this, they identify themselves with it on an ethnic, moral and mental level; feel the involvement of their personal destinies in the fate of society as a whole. The structural and functional content of this subsystem is represented by such institutions as the family, institutes of education and upbringing, the church, patriotic and cultural and educational organizations. The material base of this subsystem is the funds coming from other subsystems.

*Culture* serves as an expression of the main results of the history of society. It acts as a generator of continuous cultural innovations. Cultural achievements become the most important factor in the development of the whole society, as they saturate it with the spirit of creativity and creation. This makes culture the most valuable asset of society.

The **economy** is a sphere of activity in which there is a solution of three main issues: what to produce, how to produce it and for whom to produce it for. People's actions in this area are guided by the desire for the greatest benefit, i.e. they are expressed in such use of resources and labor that brings the most income to the owners of economic resources. The economy is considered as a structurally separate, autonomous area in which people demonstrate maximizing behavior, as a result of which the optimal is achieved allocation of resources between types of use. The main economic institution – the market – is understood as a spontaneously developed optimization mechanism. Its main characteristics are considered to be private ownership of all types of resources and complete non-interference of political and other forces in the free decisions of market participants competing for resources and consumers, as a result of which free market prices are formed for resources and products, reflecting the spontaneous interaction of the forces of supply and demand. These prices have the property of directing countless decisions of an infinite number of participants in the economy to the best result for everyone – optimal allocation of resources, full employment and maximum income. If prices take equilibrium values, then this is evidence that the economic system has come to an optimal state. ([Economy, Part 1, page 19, Plekhanov Russian Academy of Economics](#)). That's how it should be according to science, but!

But, since we are making judgments about the formation of the future of Humanity as a social structure, it is necessary first of all to acquire a number of integral perceptions and realizations that are significantly higher than the necessary conditions for the future, since they are dictated by the Vector of the Goal of future phenomena, actions and events within the framework of the new Program. This should not be perceived as temporary dogmas, they are such conditions without which there will be no manifestation, and hence no being of further actions and embodiment of subsequent events. It should also be understood that the System-appointed Performers of the System, who perform actions outside the program framework, are deprived of such an opportunity to be a Performer.

What should be taken into account in the new structure of the social organization?

What does it take to gain, first of all, in perception and awareness in order to be within the framework of the resulting executive processes of the new Program? It is necessary to acquire the following **five requirements-conditions** that are, in a certain sense, a "pass" to the future of Humanity, as the only way to change the way and form of Human existence:

**1. Humanity is nothing but a single structure of social organization.** As a social organization, Humanity is a single function intended for a model harmonious association, providing and accompanying each Person in the manifestation and complete fulfillment of the functions of his purpose.

Earlier it was shown that the society of people within the framework of the old Program was a **Subsystem**.

As a derived Subsystem, each society, within the framework of its territorial definition, had functions covertly assigned to it by the System and, accordingly, was *controlled and accompanied* at a level that was not only not visible, but also felt and realized in a limited way, and only within the framework of the functions assigned to this society. There was no final conciliarity about anything that was unusually observed or felt, it was blocked.



People cannot create the world around them and rule on top of it. In the current state, people can only consume, destroying part of the unprotected forms of the surrounding world, barbarously applying the destructive technologies given to them by the interventionist System and introduced by them, and thus illusory understand their, as it were, mastery of the world. Accordingly, any understanding of their "benefits" in the process of economic activity and effort in all other aspects of the way of life, the old System was laid at the program level as inhumane in relation to each other, and in relation to the entire surrounding world.

Within the framework of the new Program, the world around us is restoring its former states at the structural and energy level. The surrounding world will soon complete its changes, and the main part of the currently existing technologies will not be able to function at all – the environment will not allow its conditions.

Both the current technologies and the former societies of the *pseudo-social system of the highest order* will not be able to exist in their old guise within the framework of the new Programs. They will be destroyed as a technically and energetically unaccompanied atavism. Since in such a structural form and forms of being, in general, neither functions, nor territorial certainty, nor program and other support are provided for them by the framework of the new Vector of Goals.

The main subsystems of Humanity will be preserved only by their titles, namely:

State, or political system (Structural Power);

A value-integrative system;

culture;

economy.

But their functions and content are substantially altered in their true essence and this is the will of the new Program.

Destructive technologies are completely replaced by CREATIVE TECHNOLOGIES. This fundamentally changes the quality of being of human existence, i.e., the manner and form. This qualitative change will make it possible, in a short time to come to the manifestation and complete fulfillment of the functions of its destiny... preserved and recreated Man.



The transfer, or rather the restoration of the Human brain to a significantly higher level, a change in the way and form of being, finding the opportunity in the freedom of reason and actions to perform their functions, a completely different, and not an animal level of awareness of their purpose on Earth, will qualitatively change the way we relate to each other.

The System will accompany its Subsystem – Humanity, as a highly intelligent unified structure of a social organization formed for a Person.

A more detailed consideration of the structure of building Humanity and its management is considered in **Part 2 "Fundamentals of Managing Humanity"**.



**2. Humanity is a Subsystem, but it is NOT a MECHANISM for applying a Person as something secondary in the general structure of the hierarchy of program processes of the Earth model.**

The vector of the Goal in the framework of the new Program provides a **large number of functions for all Mankind**, both strategic and phased, i.e. discrete in nature.

**The functions of a strategic nature** are generally connected, first of all, with fundamental changes in the structures of all octaves of energies and restore the former native state, restore full harmony of the entire energy model of the Earth and their former functions in the general model of the Cosmos. The participation of HUMANITY in this is connected *with the acquisition of a **completely new true knowledge, the restoration of the brain** to the level of performing intervention from the outside, bringing the management processes of the life support system into true states of harmony, etc.*



Functions of a strategic nature for Humanity will be passive-active, but given the significant change in life expectancy, more than an order of magnitude, they play a very significant role in shaping the way and form of being, the strategy of controlled harmony of settlements on the planet, etc.

Due to the complete change in the entire energy structure of the environment, a large number of **discrete functions** are assigned to Humanity, which are of an active nature. In general, it **will require a lot of practical participation in the disposal of everything** that was done under the control of the old Program.

At an extremely high rate, it will be necessary to **master fundamentally new creative technologies** based on higher-order science. This will require not only great COGNITIVE and CREATIVE EFFORTS, but also giving mass conscious enthusiasm, a complete restructuring of education systems, and the imparting of highly qualified strictly professional operator skills.

The function of **human settlement** is very important and at the same time multi-stage. All resettlement will be associated with strict compliance with the recommendations of the System, as this is associated with the preparation of places of guaranteed and limited guaranteed life support and maintenance. Moreover, each settlement and group of settlements up to the scale of a functional society will be oriented by its profile purpose. We will have to build a lot of new things and apply fundamentally new construction technologies and materials, since the former one will, for the most part, be unsuitable.

An extremely **important discrete function** is *the transition to receiving from the Earth energy system all the necessary life-support energies, maintenance, formation of conditions and benefits to ones existence* **on fundamentally DIFFERENT TECHNOLOGIES**, radically different from the current destructive technologies. This discrete active function alone will completely destroy all the previous foundations of past forms and ways of being and, basically, will change the nature and direction of work in general.

Thus, **Humanity**, as a **Subsystem**, **does NOT** acquire a **PASSIVE** state of its application, **but passes into an ACTIVE** state of its participation and, **THROUGH ITS IMPROVEMENT** under the control of the System, will approach the **fulfillment of its true functions on Earth**.



**3. Humanity is a social structure into which every Person voluntarily strives with all his spiritual and moral beginnings.**

The most important, or rather, the basic beginning of all associations of people, including in the sphere of management, i.e. in the sphere of economics, is motivation. Through all the stages of development and improvement of the economy, people have had one motivation – *to work for the sake of obtaining material goods and services for their survival.*

During the formation of Humanity as a new type of social structure, a fundamentally different, previously non-existent motivation acquires special significance - *to voluntarily strive with all your spiritual and moral beginnings into Humanity as a single social structure created IN the NAME of MAN*. In such an aspiring state, a person will be transferred by the System through giving him a brain of higher octaves, freeing him from the animal state – to be applied.

In this regard, the role of such important subsystems of the **social structure** as the **Economy, Culture and the Value-integrative system of Humanity** as subsystems that form, guarantee and accompany such motivation increases significantly, i.e. both structurally and functionally.<sup>21</sup>

**4. Striving for Humanity** - not for reasons and the need for survival, but **for reasons of their own conscious professional usefulness**, i.e. the desire to give everything possible from themselves and for everyone, feeling their primary origin in the social organization, i.e. finding harmony with Humanity.

For the first time in many millennia, a person and a new type of social structure organized for him, Humanity, **acquire active functions of direct participation in the implementation of program processes** determined by the new vector of the Goal. Preparatory transitional processes are being completed to provide knowledge of a completely different, higher level, allowing a person should enter the path of movement to the truth with the awareness of his purpose on Earth. Previously, under violent external influence, the human brain was technically blocked from its true capabilities - **to realize its genetically professional usefulness, its only uniqueness among its equals, its special significance for the benefit of all others**.

He could not realize the degree of personal social responsibility to the entire social structure – **if not me, then no one else!**

Having found and obtained his harmony in this, a Person will find harmony with Humanity. This is higher than the motivation of an individual; it is an individual condition for the right to live on Earth.

**5. His universal participation, including work, will be embodied by a Person with Intelligence**, i.e. with a full aspiration to conscientiousness with a truly realized personal function, as a Person and as an important element of the universal harmony of life on Earth.

Each individual Person is a micro and macro scale personality.

Today there are many uncertain and undecided people in life. Their aimless serving of their measured biological life span, the animal consumerist state of irrepressible greed and vile pleasures, the current way and form of their being doom them to be superfluous in this future world, which came into force yesterday. Since their use, as experimental material for the programs of the old System, has ended, the new Program does not need such a limited qualitative state of the brain.



Each **RECREATED PERSON** is especially dear, unique and has a specific active function in the overall execution of the new software processes. The level of new knowledge will allow a Person to gain certain life universality and his active positional location in the new social structure, including the initiative of voluntary full dedication through work in the name of others. Such an attitude and such a level of state, conscientiousness of the majority of participants in Humanity will allow and lead to universal harmony of life on Earth.

These are the five requirements announced by the new Goal Vector-conditions that will inevitably have to be passed, because they are basically an accumulated "passage" to the future of Humanity.

## 2.2. The Strategy of the new Economy of Mankind.

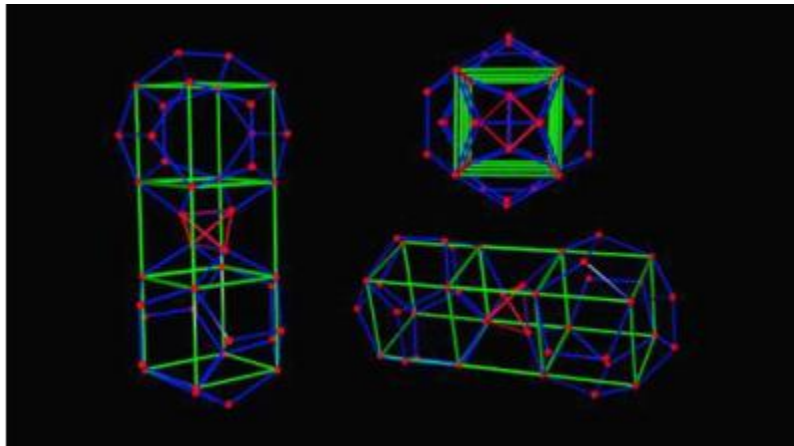
**R**ussia is a former testing ground for working out forms and methods of economic management at all "stages of the historical development of civilization", testing methods and forms of being, functions and structures of all possible social formations.

When determining the strategy of the new Economy of Mankind, it is now important to decide not on the sphere of assessing the material resource base, from which experts' forecast from the past traditionally began and were built. At this hour, it is more important to clarify the current state of power and management and an organizational resource that will have to implement it.

### 2.2.1. Why is it impractical to assess the material resource base?

Due to the fact that the PROCESS ALREADY UNDERWAY will be completed in the shortest possible time, namely: liquidation of alien base octave energies imported from the outside by the interventionist System, together with all its docking energies (18 basic octaves); the restoration to the true state of the base formation of spaces; the elimination of all previous management, control and complex support systems, together with part of the complexes and objects, etc. - the change in the energy and structural foundations of the environment of the entire Earth model will be completed, everything will be brought to its true native state.

This should be realized as the main thing.



Soon all the complex changes associated with the transmutation of almost all chemical elements will be completed, fundamental changes will occur in the geosphere, the aquasphere and the aerosphere. Major changes are already subject to, and will be completed as soon as possible, **changes in the basic technological foundations of combustion of all types of fuels**, transformation of electricity, changed conditions for the operation of digital technologies and computer equipment, and much more.

All this will cause a direct need, in the near future, to completely change the approach and the previous understanding of the truth of values, their role and function.

This, in turn, will change the material essence of the currently existing substitute system for the true and reversible, as a result of which there will be a radical change in the functions of not only money, but also the entire dominant complex of financial institutions and the financial system itself.

There is no financial and economic crisis, the processes of the old Program have been completed and are no longer manageable. Any attempts of extra-programmatic new actions to save the old one will be harshly suppressed by the System. There is no need to provide any evidence of this; there are enough of them to this day.

In this regard, it is completely absurd for "current specialists" to carry out estimated forecasting in the field of material and other resources even for the next 8-10 months.

### 2.2.2. The current state of the power-management and organizational resource.

**The transition period defined by the Vector of the Goals of the new Program is expressed in the length of 12 years. It is performed in two stage episodes: the 1st stage – four years; the 2nd stage – 8 years.**

The most difficult stage is the 1st stage. It is during the period of its expiration that all the former rebuilt micro and macro systems of the world economy will be destroyed; many countries will practically cease to exist as societies for various reasons. There will be serious problems in maintaining the necessary level of production of primarily necessary material goods and services for the survival of societies.

The most difficult situation will develop in the field of energy, transport, technical management and information.

A particularly difficult situation is the supply of the necessary amount of drinking water suitable for consumption. All this will lead to behavior of people that is far from ordinary.

The management of the economy, i.e. the formation of a "Special Economy" during the first stage of the transition period and its corresponding strategy depends entirely **based and dependent on a special resource that Manages and organizes.**



An extraordinary and historical role in this process is assigned to Russia – through it and its organizing role, the people of the planet will find their salvation.

Realizing the truth of the upcoming processes of change and, accordingly, the extreme need for the concentration of the managing and organizing potential, only one option is possible – *Autocracy in the form of Presidential Rule*. Such a power can and should be determined for a period of at least until the end of the transition period and will be accompanied in its actions by active support from the Performers of the Conceptual Power within the framework of the new Program.

It is in this format – **Autocracy isolates society from all the weak qualities and inability of liberal democracy to govern in the interests of society**, and will also be able to perform all the necessary functions of power in an extremely difficult situation of the transition period.

### 2.2.3. The strategy of the Human Economy for the transition period.

Before covering the proposed Strategy of the Economy, it is necessary to show the following clarifying questions and limitations:

features of the conditions in which the program will be implemented;

the main reference points on issues related to determining what needs to be created and changed in the basic part of the entire management process;

the goals of the strategy and who they are aimed at; the possibilities of the resource base and limitations in its application;

guidelines for methodology, principles and time frames.

### 2.2.3.1 Features of the conditions in which the program will be implemented.

The energy structural basic transformations of the environment are coming to an end, which will lead to generalized changes and features at the first stage of the transition period. They will directly affect the change in the form and way of being of the entire society of the Planet. These should include:

- changing the transformation of electricity;
- transmutation of all chemical elements with a change in the atomic structure;
- changing the structure of the water grid with a complete change in its energy-informational state;
- change in the basic state of combustion technology of all currently used fuels;
- stopping the burning of gunpowder combustion;
- changes in the structure and states of radiation gratings, termination of operation of nuclear power generating facilities and devices (weapons, nuclear power plants);
- a complete change in the established climatic conditions with their cardinal opposite treatment;
- changing the entire system of river outflow and lake formation, etc.

The consequences of these changes are not subject to prediction, they should be taken as a given. Most of them will play both a positive and a negative role in the implementation of software processes.

In any case, when they are completed, a number of such conditions will appear that the current society has not had to meet.





The majority of the population in the regions of Southeast Asia, Asia Minor and Central Asia, the Middle East and the Mediterranean zone, an area of the Scandinavian countries, in most of the territory of old Europe and Northern America – will be in a particularly unfavorable state for people. Humans will be preserved with basically only motor functions in the brain, there will be an extreme mass reduction through epidemic diseases and there will be extreme limited manageability, due to the absence of awareness of the essential occurring situation.

It will require an unusually high level of large-scale operational work, a high degree of readiness and professional aptitude for making strategic unconventional management decisions.

### 2.2.3.2. The main benchmarks for changing the basic piece of the entire management process.

It will require the concentration of organizing efforts to perform important economic steps at a high pace:

To organize and conduct the development and transition to new technologies for generating electricity and other types of energy on a local and general territorial scale.



Create anew and restore the entire transport network using new types of energy, taking into account the prospects for new settlements.

To master building materials on a new structural basis of chemical elements and organize their mass production and application.

To start the implementation of the plan for the construction of new settlements in the zones accompanied and guaranteed by the System under the conditions of life support, to organize the relocation of existing infrastructure systems to new places of settlement.

Reorient all areas of management to replace them with new metals and metal structures.

Organize agriculture taking into account the changing climatic conditions and reorient animal husbandry and fishing.

All production facilities located in the zone of guaranteed life support conditions can be used and re-equipped for new production facilities, modifying them for the primary necessary industrial products with further expansion of the production sphere to other regions, etc.

There is no need to list everything.

**Above all in the first stage** – is the rescue of the surviving population and the organization of their survival.

**The second stage** – is the development of new technologies and their comprehensive implementation in all branches of the new management system that is being created.

**At the next stage** – the final completion of the creation of the Economy of Mankind.

### 2.2.3.3. The purpose of the strategy of the Human Economy.

In these difficult conditions, the main goals of a special management system are (abbreviated):

- the entire system of organizing and managing actions should be oriented step by step to ensure the primary necessary conditions for the survival of the remaining part of the population in the European part of the territory of Russia;

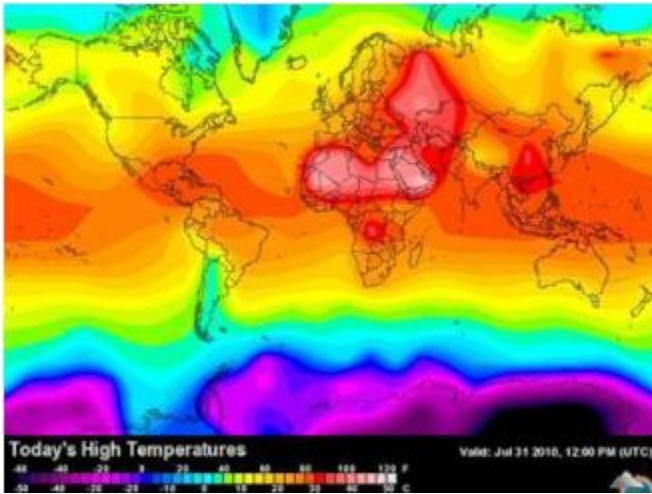


- to ensure the restoration of all subsystems and structures of a new social instrument – Humanity on a new functional basis, to create a new information and educational environment under the control and management of the Structural Authorities on a new technological basis, to pay special attention to children and youth during this period;
- to create a system for the transition to a new cognition in the basic sciences, to change the structure of education and upbringing, to organize the retraining of specialists of the entire scientific and scientific-production industry, to restore research centers and bring them to the appropriate level of knowledge, to carry out targeted reorientation and change the structure of the management of science;
- to create a new financial system in accordance with the new structure of global financial institutions, to ensure a rapid transition to a new value assessment system;
- to carry out certification of the entire natural complex and other resource base, to organize a system of strict control over its use, replenishment and replacement;
- create a system of safe, expedient land use, transfer it to a position of strict control of the intended use under the full responsibility of the Structural Authorities;
- to create an integrated transport system based on new principles of energy use on a new technical and technological basis;
- ensure the restoration of flora and fauna and expand fish farming in relation to new climatic and other conditions;
- to organize full comprehensive assistance to the remaining part of the population of other countries with preserved and accompanied life support conditions, integrating the created social tools and subsystems into a single integrated system of Humanity.

#### 2.2.3.4. The strategy of the Human Economy for the transition period.

##### **The old program has ended.**

**T**he effectiveness of all the previous controlling complexes and systems has been stopped and terminated, control processes no longer have a basis for their existence due to the destruction of all aspects of their energy support that gave authority to Performers in their actions to organize events in the execution process.



All connections of influence and control from outside, i.e. from the Moon, the Sun and the satellites of the planets, have been stopped, i.e. the associated Ebrov brain of the interventionists has been **ELIMINATED**.

Natural and weather anomalies, frequent earthquake processes, increased activity of volcanoes, melting of age-old ice, etc. – have become extremely intense and influential on changing the world around us.

The traditional managerial decisions taken at any collegian level no longer lead to anything. All attempts to keep any local or global managerial and power states at the same level lead to nothing. Fairy tales about the fight against world terrorism and other fictional enemies no longer work.

It is necessary for everyone themselves, i.e. for those who are still capable of elementary logic, to realize that it is impossible to revive all that no longer exists. The world has already changed, it is necessary to prepare for life in a new world.

People will not be able to return the entire surrounding world to the previous level, bringing its energy information state to the old conditions, **because they are alien to our planet Earth, it is being freed from this.**

Under the management of Programs in the new Vector of the Goal, the New Economy should be defined as: **"A Strategy for an Appropriate Balance of Economic and Social Development of Mankind"**.

#### 2.2.3.6. Organizational, structural and the basis of calculation for the new strategy.

The organizational-structural and settlement basis is presented:

- the basic calculation basis;

- the basic management basis;

- a form of integration; a complementary social subsystem – Structure-less power.

The basic calculation basis – **is a functional-territorial system certification:**

- the territorial divisions of the economic objects under consideration **must necessarily be linked to the true functions of these territories**. The delineation of territories can be performed only by function. This function is determined only by the System, and information about territorial functions is provided through Performers from the Conceptual Authority. The functions are not the same, there is no duplication, and each of them is unique.
- a real strategy of step-by-step development and measures for further maintaining the achieved level for each functional territory is being formed. The step-by-step target framework of the formed management system, the volume of resource indicators, the scope of necessary and possible volumes of products produced or the volume of intangible participation (providing or accompanying), the component of the system complex of transport services for the entire created economic system are expressed. Special attention is paid to the local autonomous energy system, the volumes of independently generated and additionally required energy of various kinds that require support from the System;
- the most important innovation is the targeted definition and distribution of all types of substitutions according to the Territorial and functional model of the integrated management system (Economy) on a local and global scale. It is the definition and distribution of all types of true substitutions that is the basis for calculating, including the entire necessary and required amount of the circulating substitute and future money derived from it, all their forms and types. Only on the basis of the collective volume and taking into account the step-by-step needs for the creation and development of the entire Territorial and Functional Model, the strategy of the functioning of the Financial System of Mankind is being built up. The required volumes of financial support of all types and forms are determined and distributed for each territory separately and collectively as a whole. This work is performed jointly with the KRU...
- special attention is paid to the specific definition of the qualitative and quantitative composition of the society at the initial stage and in the future for each territory. The functions of each territory determine the entire list of operator specialization, taking into account the reserve of two or three generations (the age orientation of the reserve is 18-30 years).

Additional special functions related to the processes of closed cognition, technical support of contact and communication with the Control System, research technology centers (under special regime conditions) are assigned to individual territories.



- some additional territories will have narrowly profiled functions that are not related to the process of material production, i.e. without creating material goods. These territories will be determined to organize and provide: general education and specialized centers of training and education, centers of psychophysiological rehabilitation and restoration of health, specialized centers for the preservation and development of culture and art, centers of cultural recreational leisure and education, etc. The formation of this can only be in those territories that will be accompanied and provided with the System and its objects additionally, by creating a special state of the environment that increases the capabilities and abilities of the body and its brain to perform everything necessary that is required for this Person at such a time;
- territories that for a certain period of time will be intended for complex processes of adaptation and restoration of the true flora and fauna of the planet Earth are subject to separate certification.

#### **The basic management framework.**

Territorial-functional model of a complex economic system (the Economy), as a new economic basis of a fundamentally new Financial system of Humanity, as well as new functional and structural subsystem level, in conjunction and cooperation with the new subsystems within Structure-less power is a complex single social tool of a fundamentally new type of Humanity, which requires a special organizing and managing capacity.

There is only one possible option – *Autocracy, carried out in the form of Presidential Rule* for a period of at least until the end of the transition period.

**The form of integration.** The only form of integration, as the leading subsystem of a single new social instrument, can only be redistribution.

The interaction of Structural and Structure-less power to form and give new functions for such a form of integration as redistribution is nothing more than overcoming a problem that has not been solved before by any of the societies – obtaining material goods, services and universal recognition by Humanity - according to the Mind, as the highest degree of justice.

**The complementary social subsystem is Structure-less power.**



The new System, within the framework of its program, creates fundamentally new institutions of social and other relations, a new structure of a single social organization with different goals and functions. A social subsystem will be created – a structure-less government. Along with other subsystems, it will help maintain a harmonious balance between the introduced autocracy of Structural Power and the new functions of the other subsystems in the structure of a single social instrument – Humanity. <sup>22</sup>

## 2.3. Economy as the goal and basis of the unified structure of the social organization for the Humanity of the future.

**The economy of Humanity** – a set of actions and judgments on the search and adoption of optimal decisions, as a controlling and organizing process in the formation of harmony of all subsystems of a single social instrument of Humanity.

It should be focused on the preservation of people, giving organizing active functions to all socially active elements of society for the guaranteed creation, acquisition and distribution of material goods and services in the most difficult conditions of the transition period.

The economy of Humanity is the only tool for organizing expedient and prudent management in the conditions of non-traditional restrictions and extreme lack of time dictated by the circumstances of the Goal Vector. This is a management tool, when each applied unit of the resource should ensure the receipt of the maximum, managed and controlled through the distribution of the volume of material goods and services.

The management of this process of economic efficiency is entrusted to the interaction of Structural and Structure-less authorities. This interaction should be entirely focused on the organization of an "[Appropriate Balance of Economic and Social Development of Mankind](#)" as an Economic Strategy.

The economy of Mankind is a harmonious interaction of all subsystems of a single social organization of a Person: Structural power; value-integrative subsystem; culture; the Economy of Mankind and a new subsystem of Structure-less power.





The economy of Humanity is the organizing principle and the goal of Human social organization, it is a state in which, for the first time in the entire previous history of all societies, the issue of social justice is solved: **the provision of goods, services and social recognition according to the Mind, and not for money or illegally acquired power**. This is the true harmony of Man and Humanity.

The economy of Humanity excludes the existence of political power in the previous incarnation.

To be recognized as part of a Structure-less government is not an honorable right to have a preferential social position. This is a well-deserved and recognized social position, i.e. the voluntary consent of the other members of the social organization with such a well-deserved social position of the individual.

In the changed environmental conditions, provided that the life time of a person is increased by almost an order of magnitude, i.e. up to 800-1,000 years – this becomes incredibly important as a fair incentive and as a way to find harmony between Man and Humanity.

What needs to be changed to bring the **MEANING of a PERSON's LIFE** to a new level?

Fundamentally change the value orientation of Humanity – as a complex sociological process of a single structure of a social organization, with an active social position and full interaction in the work of all social subsystems.

This work should be based on a new value strategy: **"The transition from People of price – to a Person of value"**.



**People of price** – are the embodiment of the archaic, naively egocentric inside the personality, a kind of pronounced self. The price for them is everything, even a goal in life. This is the most important characteristic of everything in the world, the world for them consists only of things, because, apparently, the only living, irreplaceable and priceless thing in the universe for them is their own Self.

**A person of value** – is what is necessary to become, a person of true reason who has received a different brain and a higher level of knowledge. In the process of transformation, there will be a lot of things in the world that cannot be found an equivalent, not because it is most expensive, but because it is unique, irreplaceable, individual, self-valuable, and created by the System to find true harmony.



**The goal** in the implementation of this value strategy is a harmonious coincidence and a complete harmonious target orientation of the Value Stereotypes (VS) of a Person as a person with the Value Ideal (VI) of Humanity as a single structure of a social organization.

In the Economy of Mankind, the value strategy is based on a completely different management, fundamentally different from management and design in its manifestation under the previous structure, methods and forms of being.

It is enough to say that all types of substitutes, rules and rights of treatment with them and to them, the construction of a fundamentally new System of Finance, the laying of global finance – do not cause any ambiguities.

This issue has already been determined by the KRU structure assigned for this purpose. For Russia, there will be no problematic issues about the consideration of borrowed and other external financial resources for the implementation and implementation of not only the strategy of the Economy, but also the construction of the entire unified structure of the social organization - Humanity.
