I'm surprised: how stupid people are,


And how insignificant is the futility of their path...

Proceeding from the fact that the world is systemic, therefore, in our analysis we should proceed from the fact that we must present the object we are analyzing in the form of some system or its important part as a subsystem and conduct analysis from the standpoint of system knowledge. Further, again from a systemic standpoint, it is necessary to consider the real situation associated with this studied (focal) object that is in the focus of our attention. And, since the world is systemic, representing something integral, any object of attention we consider should be connected with other systems and these connections between them should be reflected and taken into account, only then will we be able to understand which or which part of the system controls the rest or is necessary for the functioning of the entire system and each of its parts. Our world on Earth, as a system, consists of two parts: the natural one, which



includes the biosphere and society, and the technosphere – an artificial world that increases the capabilities of a person who has declared himself the King of Nature, but who refers to the biosphere as a conqueror, and not as part of it, giving him the opportunity to exist and develop in this world in accordance with the situation organized by people (Fig. 3.).

As is known, the entire system is controlled by the Earth Management System (EMS) (Fig. 1.). At the same time, at first, interaction was observed between all subsystems of the system, ensuring the harmonious development of all subsystems. However, over time, nature began to take revenge on subsystems – society and the nascent technosphere for violating the harmony in which it existed for millions of years, and man did not see and did not realize his responsibility and significance in this, as well as a special problem that will manifest itself fully in the future, because they develop as antagonistic systems (fig. 3.). 


Fig. 2. World management System

And the author is right that "with the beginning of a new era, new thinking began to give way. The world is beginning to be understood as a whole **NOT IN RELIGIOUS** and philosophical terms, but in political and economic terms".

Civilization, as a Suprasystem, controlled by the old system of control systems through the pyramid of power, had to keep all its subsystems under its control, which directly act on the performers, dividing them into "golden billion" and "golden million".

To do this, it must be able to regulate all flows of energy (E), matter (V) and information (I) in accordance with its program (main goals), managing systems as needed by the Suprasystem, because all systems in the Suprasystem "work" only for it. These functions are performed by system-1 and system-2 (see Fig. 2), which make changes in the flows (EVI) at the right time for it. 


Fig. 4. Pyramid of power

At the same time, the Global Predictor and the Nadiudean priesthood have holistic knowledge. The elite already have partial knowledge and strive to get to the top of the pyramid. And the people (crowd) have only fragmentary knowledge, like pieces of glass in a kaleidoscope: turn - one picture, turn again - a completely different picture...

As emphasized in the article, the integrity of the world and the understanding of its unity was given only by its religious perception and comprehension.




Fig. 5. Synthesis of a system from a working organ ИЗ/From, Изд/Ed, Модуль/Module

For example, at whatever stage of development there is a technical system, (at the level of dimensional scale – a solid, a liquid body, a powder ..., molecules, a pre-atomic state, fields and, finally, primary matter ...) a necessary condition for its fundamental viability is the presence and at least minimal operability of the four main parts of the system: the engine (D) (or energy source), transmission (transmitter or converter (T) of the type of energy), control unit (OU or (SU). or controls and a working organ (RO), from which the synthesis of the system itself always begins (Fig. 5.). At the same time, the system processes the Product (Izd) – the people of Society, obtaining the desired result (product) of appropriate quality. The quality of the products issued, became the quality of people who consumed them.

The model of the technical system shown in Fig. 5 is the law of completeness of the parts of the system. It is also valid for the system just considered (Fig. 2.). Schematically, it can be written as:

Initially, any wars are waged not only for material values, but also implicitly for the consciousness of the conquered people, so that they obey the conqueror, and this was achieved with the help of crude weapons and violence or "carrot and stick".

Individual geniuses are **NOT QUOTED** for many reasons...Their destiny is to look for new ways of developing civilization in accordance with the laws of Systems development, which will be the criteria for choosing the right path of Civilization development.

The one who prepared for this task worked for the pyramid of power and is the most dangerous enemy and criminal of society. Because he understood what he was doing... As for the money, it is enough to pay the increased pensions, still there will be enough for development and even to buy the US securities, helping the US economy, which is what the accountant Nabiulina of the Russian Federation is doing...
