

1.18. Some prerequisites for a new world order doctrine and the destruction of the "Social Violence" doctrine

Introduction

At present, **few people doubt that the world is being prepared for a "new world order"**.



Therefore, the "New Doctrine of transition to a different World Order" put forward by Boris Makov and the explanation for the transition doctrine - "DESTRUCTION of the SYSTEM OF "SOCIAL VIOLENCE" - run counter to the traditional ideas imposed through the media on society and the scientific world of social science related to the formation of the world community of the future. These program documents are a logical continuation of the materials presented in Parts 1-4 of the "Fundamentals of the Formation of Humanity" (OFCH) and subsequent works of the authors^[1].

In Parts 1-4 of the "OFCH", attention was drawn to the fact that **society as a whole and the management of all the processes of its social development**, i.e., the organized existence of people at all program stages of the general event Chronoprocess, is not a natural (random) nature, - **but a very specific and strictly controlled program process from the outside!**

The most sensational in itself is the fact of the **change of "System Power"**, as the **replacement of one Management System with another ("native")**, which is a manifestation of the general planetary and non-planetary scale.

1. Manifestations of the influence of the Earth's Management System during the "Ebrov Intervention".



In the materials **presented in Parts 1-4 "OFCH" "The Structure of Being"**, etc., considered the chronoprocess of the development of the Earth's Civilization over the past 18 thousand years, when it was subjected to the "Ebrov intervention", as a result of which the "Native" (Earth) was replaced on a planetary and off-planetary scale.) Control Systems change to another intervention, with a special Control System format. At the same time, the interventional Management System on Earth has launched a systematic program for the "Development of Brain genotypes" in the last 3,600 years, i.e. the so-called forcibly imposed functional intervention to acquire specific purposeful use of human beings.



The reverse processes have occurred in recent years, especially in the period after 2011.04.24, 2012.12.24 and 2013.01.07 on the final change of the "System Power". But if the implementation of plans of the "Ebrov interventionists" and their consequences for Mankind is considered in the above-mentioned works in sufficient detail, the manifestation of "native" Earth Control Systems (ECS) in this unfavorable period of 18 thousand years is revealed and for certain reasons rather limited. That is why I still want to expand my assumptions and judgments taking into account the ideas of Nikolai and Svetlana Levashov, which I started to present in my previous article **"Problems of Knowledge Management during the Change of "System Power" and New Energy Information Support"**.

Section 3

In the materials of the OFCH, a very important emphasis was made, which is not always paid attention to: **the "Ebrov interventionists" could not destroy the brain of the Earth (the Earth Control System – CPS)**, since it is beyond their capabilities, and it does not have the technical means. If the basic energies of the **CPS** in its true (dodecahedral) construction were based within the levels from **12 to 512 octaves** inclusive, which are both in material and non-material states. The externally imputed interventional control systems in their basic alien (cubic) energy structures worked only in the range of 15 to 128 octaves.

In addition, in the work of A. M. Khatybov "The Brain almost according to Darwin", it was noted that **"the Brain is the result of many millions of years of work on the formation of the biostructure (of a person). And of course, the brain can't be formed by itself from dust using chemical reactions.**

The Brain is a simultaneously connected state of 3 spaces - neutrino (higher), antineutron, and proton, or ion."



And in the documents of the OFCH, it was noted that the interventional Ebrov System could not independently form the very true "construction" of the human brain, but was only forced to borrow its constructive basis from the previous true Person in the process of capturing the Earth. Therefore, the general controlled state of the brain of people of that time was brought to the level of the minimum possible octaves of the energies of its material (proton) and immaterial (neutrino and antineutrino) states. It is for this reason that the interventionists launched the system program "Development of brain genotypes".

Thus, even in conditions of total intervention of the Earth its control systems could continue influencing the human brain on the levels of non-material spaces and octaves. It is important to mention that the true CPS is to be discovered in the future. And now we can only estimate their manifestations in the past and only on the basis of those literary and scientific sources that were available to us.

So, let's go back to the times of the "pre-Ebrov" intervention in the period when there was a settlement of the 4 genera of the White Race on the territory of Asia from the submerged continent of Daria.

On the map from the book of N. V. Levashov, 3 centers are identified, through which the further development of the White race genera was controlled, which had previously lived on the mainland of Daaria for several hundred thousand years in accordance with the Laws of Life in a state of harmony of being.



Earth and its CPS. And if it is difficult to find enough detailed information about Asgard Svityordsky (district of modern Uppsala) and Asgard Sogdian (district of modern Ashgabat), then Asgard of Iria is described in various sources from different angles. Among them, in relation to the topic under consideration, we will distinguish three aspects based on the materials of N. V. Levashov:

1. The city represented a **grandiose control system**, which allowed it **not to suffer** even from the last planetary catastrophe (since it was **reliably protected by the force field** from both the falling debris of Fatta's Moon, and from the giant waves that never reached this city).

2. **The city was surrounded by an invisible energy shield**, through which not only enemy armies, but even individuals could not pass, if they had dirty thoughts or bad intentions. With the onset of the Night of Svarog, this protective field gradually weakened, due to objective reasons, and, in the end, the Black Magicians managed, using a very mean way, to neutralize this energy protection, just before the assault of the city by the hordes of Dzungars, which did not allow the Higher Magi to restore this protective field in time.



1. 3. This city of gigantic stone pyramids, the city of wise men, was **the richest treasury of knowledge**, which were stored in artificial underground caves under the pyramids. Jungar hordes destroyed most of the magi, burned or destroyed priceless repositories of ancient manuscripts and books, brought from Daaria. But the most valuable were preserved in special underground vaults hidden deep underground.

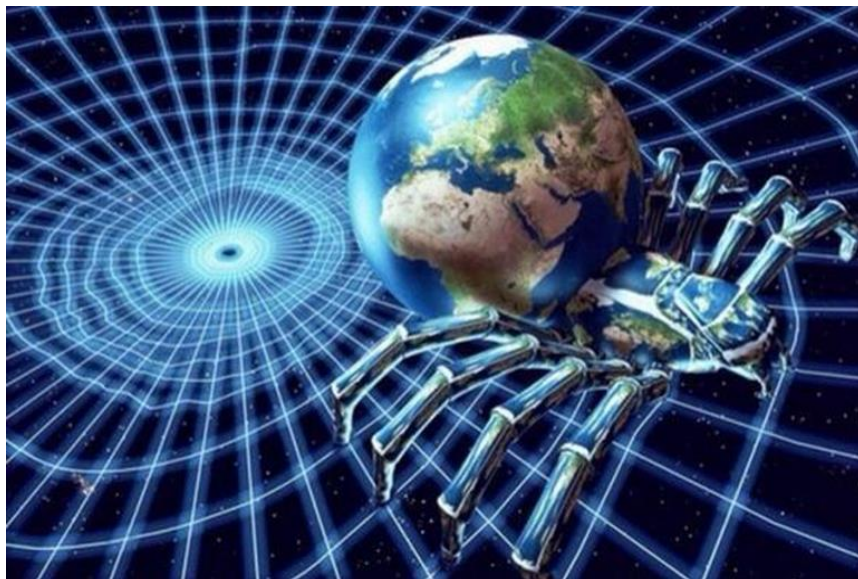


Thus, during the period of the "Ebrov intervention", **Asgard of Iria** existed, **performing the functions of management, protection (control) and preservation of ancient knowledge assigned to it, until 1530.**

And it is not by chance that the **programs** that were especially highlighted in the **materials of the authors of the OFCH** correspond to this critical time:

In 2000, the 500 - year-old program advertised by Nostradamus was completed (he was recorded by the Ebrov Control System what was allowed to be disclosed). The goal of the Program has been achieved, and it is fully completed.

Over the past 500 years, a web has been created on Earth, which is of fundamental importance for the development and existence of mankind.



The web is an electromagnetic (in terms of modern "horse" science) grid in which all life on Earth exists. Using the grid, you can give information, remove it, and change the structure of life according to the appropriate program. **Under the web, a brain is created that can "remove" and process that part of the information that is necessary for the Control System of this structure.**

Under this structure, a Pyramid of Knowledge (or rather, a **Pyramid of "Horse" Knowledge** (the formulation of A.M. Khatybov - A. Ya.) **has been created, developed and successfully exists, which has been under construction for the last 500 years. All modern science should be subordinated only to this Pyramid of Knowledge.**

As it is not difficult to notice now, all the same software **functions of management, control and "knowledge management"** systems are distinguished.

In the book "**Revelation**" by **Svetlana Levashova**, other structures and systems are also mentioned, with the help of which ancient knowledge was preserved and the controlled development of people was accomplished.

Some of them were tied to a specific special location on Earth: **Matheora (for gifted people with exceptional abilities) and her younger sister Raveda** (Ra-to know), which also taught Knowledge, only much simpler, **for all the gifted** without exception (sometimes there were also "**gray**" gifted people who were also taught Knowledge, hoping that one day their lost Bright Soul would return to them). Raveda, for example, was located in the place of the Earth where **the so-called Gates of the Interspace** once existed.



Others, like "**the Key of the Gods**", were tied **to the most worthy Keeper of the Key of the Gods (among whom were Radomir and Magdalene)**. The Key of the Gods is described as a material green crystal that had the intangible manifestations of **the Temple of Eternal Knowledge** (Daaria's legacy), which gave the Earth protection, opened souls, and taught the worthy KNOWLEDGE and UNDERSTANDING, and by it Mateora was once created. At certain long periods of time, as noted by Svetlana Levashova, it was kept geographically on the territory of modern Russia.

Other manifestations of the CPS may include various proto-objects, which, as a rule, were associated with natural places of power and often replaced each other in the same place. Numerous researchers have noted that our ancient ancestors built Vedic temples and pyramids in places of power; after their destruction due to an approaching glacier from the north, pagan temples later appeared in these places, and then Christian churches and Muslim mosques often appeared in the same places. In recent times, many researchers have paid attention to the fact that some of these objects in different parts of the earth are also spatially connected, which was confirmed by numbers and geometric proportions.

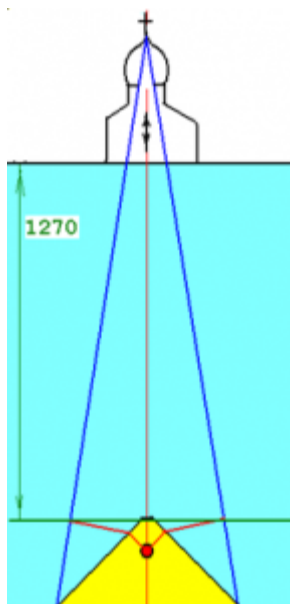


In such cases, the location of the English Stonehenge, Egyptian and South American pyramids, objects in India and Tibet were most often mentioned. In this respect, **the work of A. M. Khatybov "Kailas - the mountain of the swastika"** [2] is indicative, where, in particular, it was especially noted that each "holy place" has a corresponding provision, a form for quite specific purposes. On the other hand, no less unique protoobjects on the territory of our vast country were under an information blockade. After all, until now, our official history gives us a little more than 1000 years. But thanks to the internet, we can now have a wider range of information on this problem. In this regard, the study presented by K. K. Bystrushkin in the book "The Phenomenon of Arkaim" is very interesting [3].

In the OFCH, such manifestations of the CPS are not disclosed in sufficient detail, but there is also a corresponding emphasis on this:

"Some forced fragments of an advanced nature, which **are still an unexplained mystery for many areas of science**, took place, namely: pyramids, uncreated caves, dolmens of various shapes, some technically advanced devices, calendars, facts of accurate calculations, etc., on the basis of sufficiently high technologies that do not correspond to the level of knowledge, and not only at that time, but also today."

On the other hand, it is noted in the OFCH that by **the year 0 A.D.** the whole process of controlling people's being was prepared for transferring the general state of controlling processes to the **religious and confessional methodology of providing controlling states** in the sphere of power (the program, popularly known as "Christ" was introduced) and frequencies were introduced to provide the process of reincarnation (the spent matrix is not thrown away, but is transferred to the next shirt. Hence the symbolism of the mother with the baby). That's why since 0 A.D. masses of chapels, churches, mosques and Buddhist temples began to be built on the Earth in the so-called nodes of mutual crossing of specially created Ebrov meridian winding and parallels (nodes "Hartman, Curie, X-ray" formed), where there was a change of potentials of energy lattice of the atmosphere surrounding the object. In the works of A.M. Khatybov and the materials of the Research Institute of the TsUS some characteristics of such windings and nodes are given.



Di-structure - 8 dodecahedral-icosahedral (DI) blocks, each block has nested DI blocks (a total of 44 attachments in one DI block). The structure is constructed using the properties of the golden ratio. The state of the structure is highly organized plasma. There are no instruments on Earth that can detect it. It is an atomic structure generator. The operation of the generator is set by the Earth Control System.

t-structure - 12 blocks of tetrahedra. This is the connection of all generators into one whole. This relationship is directly related to all changes in the atomic structure.

k-structure - 1 block octahedral-icosahedral structure, has 16 identical blocks (attachments). It is built on prime numbers. The periodic table (Flerov) is built on the k - structure, but nothing flies there, there is only an oscillatory process.

Today, these frequencies are more than 7 billion.

So, we have a lattice with nested atomic structures.

Even from physics it is known that at a certain depth there are 8,640,000 "tires". They are called magnetic meridians.

At $h = -2200$ there are information buses (8,640,000), up to $h = -4400$ there are all control structures. Information is exchanged in this layer. The information goes up through the communication tubes. As a rule, there is a chapel (church, mosque) above it. Church buildings that stand "out of place" are lime trees.

In this layer, the frequencies of k-structures from octaves work 77, 88, 96, 111, 118, 121, 123, 127.^[4]

I would like to draw attention to the CPS on the territory of the former Slavic-Aryan Empire was the manifestation **before the beginning of the 15th century AD** of a special form of the system of power **in the conditions of violent actions** of the "Ebrov intervention". Namely, **the government had two branches — civil and military**, which were initially balanced, that is, one did not obey the other. These branches of government served as a counterbalance to each other, preventing one from dominating the other. In peacetime, the MUNDANE PRINCE became more important, and in wartime, the MILITARY PRINCE — KHAN. But, none of them had absolute power, could not pass on their power by inheritance to their children. Each of them was chosen for this post — civilians chose a secular prince, and professional soldiers — a military leader — KHAN. They were chosen for these positions for their merits and exploits, there were cases when the same prince was chosen, both in one branch of government and in another. But this happened quite rarely. And **such a system of power existed until Dmitry Donskoy**, who, sufficiently poisoned by the poison of the ideas of Christianity, considered absolute personal power the only way to achieve the prosperity of his Homeland. The abolition of the position of Tsyatsky, after the death of his last tsyatsky — the noble boyar Vasily Velyaminov (and the betrayal of his son, who became the head of the opposition to Dmitry Donskoy), as N. V. Levashov noted, was an irreparable mistake of Dmitry Donskoy, which bore fruit in the form of the "Great Russian Revolution" of 1917. The whole point is that the presence of the position of Tsyatsky, who owned military power, almost equal to the power of the Grand Duke, created a balance of power, not allowing either the Grand Duke, the appointed civil ruler of the province, which, in fact, was Dmitry Donskoy, or Tsyatsky, whose position was claimed by Ivan Velyaminov, which, by the way, was also an appointed position, to get absolute power — power that inevitably leads the country to disaster. The carefully concealed essence of the conflict between Dmitry Donskoy and Ivan Velyaminov (Mamai) was revealed by N. V. Levashov in the article "The Silenced History of Russia, part 2". Ivan Velyaminov's involvement in his side of obvious enemies of the Slavic-Russ led to a civil war within the province of Moscow Tartary. Russian Cossacks, who stood for the old traditions, along with the **Genoese mercenaries and knights of Western Europe**, and the squads of the Russian princes, were completely defeated by the army (Horde) of Dmitry Donskoy (Mamai), which included the army (Horde) of Ivan Velyaminov (Mamai).



Defeated in 1380 on the Kulikovo Field, Mamai was finished off by Genghisid Tokhtamysh when both armies met at the Kalki River, in the area of modern Mariupol. **Mamai went to the Crimea, where he was killed by his Genoese allies.** And although as a result of the events, Dmitry Donskoy, having received absolute power, managed to maintain complete independence from behind-the-scenes players and preserve most of the traditions adopted in the Slavic-Aryan Empire and, thereby, maintain fairly close and friendly relations with the latter, the system of power itself, which was already built on the Western model, changed.



In addition, it is appropriate to note that according to the **OFCH**, in the period between the beginning of these 500-year and 600-year programs in 1433, the program stage of development and improvement of the entire management sphere was completed, covered by its executive controlled implementation through processes in actions, in which the entire three-variant **42 genotype** of the brain (the Caucasus Control Complex) was involved, the functions of which were completely exhausted in their capabilities and the management state was transferred to a new stage of the information civilization of human development, by launching the Alpa-1 Control Complex into the active state and introducing the first variant of the new **44 genotype** of the brain.



It is important to note that the so-called **SOURCE OF LIFE** could also have a significant impact on the manifestation of the CPS. In its description and characteristics, the materials of the Slavic-Aryan Vedas (SAV) and Nikolai Levashov will be used further. According to SAV, the Source of Life affected people in different ways. As they say in the First Message, the Source of Life gave people according to their thoughts, in the Gods — he revealed the hidden powers. It should be recalled that our ancestors called Gods highly developed people who could operate space to a greater or lesser extent, depending on their personal qualities and capabilities. And only by getting within the limits of the Source of Life, a person could find out whether he is a "sleeping God", i.e. a person who has the potential inherent in nature to change space and everything in it. The **HIERARCHY OF LIGHT FORCES** placed the "**SOURCE OF LIFE**" — a crystal generator to **COMPENSATE for the EVOLUTIONARY BIAS**, in the bowels of our planet, at least 112,000 thousand years ago, on the eve of how Midgard-Earth was in the zone of action of Dark Forces. Due to the fact that the flows created by this generator were superimposed on the natural planetary ones and, thus, the proportional ratio between the flows changed, it was possible to resist the influence of Dark Forces on people. But at the same time, the planetary natural flows of primary matter are themselves distributed unevenly across the planet, so during the Night of Svarog, the **IMBALANCE** of evolutionary flows was **NOT the SAME**, in different areas of the surface of Midgard-Earth. And, accordingly, the degree of compensation for this evolutionary imbalance, by the flows of the Source of Power, was not the same.

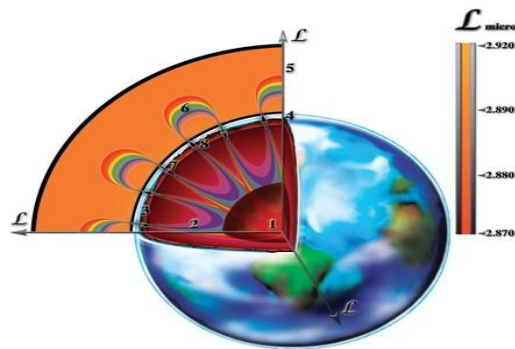
There were regions where compensation was only negligible, and in these regions the Dark Forces began to gain the upper hand over the Light Forces, **turning people into biorobots**. There were regions where the Source of Power not only neutralized the evolutionary difference, but also created favorable evolutionary conditions. Similar outlets on the surface of Midgard-the Land of the Source of Power - affected all living nature.



The highlighted paragraph is of key importance for the territory of Russia (Slavic-Aryan Empire), especially in the **region of Siberia and the Far East**. Indeed, both the SAV and materials of N.Levashov repeatedly pointed to **the yields of the Source of Life** in these areas, and even its location near Lake Baikal (Hari Sea) at least 7.5 thousand years ago. In my opinion, it is not by chance that exactly in this area is located the restored **MC "Altai"**, which has already begun to play a key role in the transformation that began after the final change of systemic power. Moreover, I'll take it upon myself to make an assumption that there were octaves of higher order than those of the Earth System Control laid down for the FUTURE in the Source of Life by the **HIERARCHY of the LIGHT POWER. And is it not due to the presence of the Source of Life on Earth that a new limit value of higher order octaves of energies, i.e. up to 1024 octaves, will be acquired!** (OFF, "Construct of Being"), as a controlled process on the part of the Almighty Governing State within the hierarchy of the Development of Civilizations of planetary models with Reasonable Orientation. After all, it is no coincidence that people of the Ancient Race, who came up to the level of the Creator, such as Ladaad from Ingard-Earth (SAV) aspired not just to get to Midgard-Earth, but to receive a kind of initiation exactly at the Source of Life. And is it not because all the attempts of the Dark Forces ("Ebrov interventionists") to find at least the places of the exits of the Source of Life were just as successful in terms of the difference in the level and range of octaves of energy, as the current attempts of their satellites, who lost the support of the previous Control Systems.

So, in the territory of modern Russia and its environs, due to the presence of Asgard of Iria, the outlets of the Source of Life, the Key of the Gods, as well as other proto-objects associated with "places of power", the manifestation of the influence of the Earth's Management System during the Ebrov intervention was carried out with less damage to the development of people than in other geographical areas.

Boris Makov's answers to readers' questions give an assessment of the events in approximately the same perspective.:



"9. Concerning the Vedas. So far, it is acceptable to say the following. In the published materials, we almost never reported that in addition to the imputed 4XX-genotypes of the brain from the "Interventional Management System of the Earth", there were additionally individuals with the 384th genotype of the brain, most of whom were stationed on the territory of Old Russia. Periodically, from the "True Earth Management System", there was a hidden information support for the everyday life of this special genotype – this is the 384 genotype. Individuals of this particular brain genotype were perceived by the Interventional System (Ebrov) as the main material for "practical application" under the Program "Development of Energy Biogenesis of the Flesh cell", on which many experimental processes were mainly tested. A separate functional and territorial allotment of the territory of Russia allowed (unlike other territories) to keep the brain of people of 384 genotypes with minimal distortions. The most "capable" part of them were the Vedas. They and through them carried out energy-informational transmission from the True Control System of the Earth in such a hidden form, which could be brought to people at different stages of development. That's the whole trick of this understanding. It was through the individuals of the 384 brain genotypes that the True Control System of the Earth preserved the elements of approximation to the truth about the "Created World". Given the level of development of the mind in relation to each stage of the event chronoprocess, such information was presented more often in an object-esoteric worldview, or in a demonic understanding, or in some particular forms of worldview, taking into account the territorial and functional endowment of the community of people, their "national" and geographical features. The Vedas were also people, the same applies to the forms of preserving information (with the help of people), and on tablets, scrolls, in the form of any artifacts, etc. – this is not the essence of the matter. But they really were, in this regard, Russia has something to be proud of" [5].

To conclude this section, one more suggestion. The Isoteracists of the past mentioned two crystals that could be used to control the world. **Aren't these the crystals meant to be:**

The Key of the Gods (Eternal Knowledge of the past) and **the Source of Life** (Octaves of future Energies)?!
