

Conciliarity of the Russian world and its role in the formation of a new world order.

All processes on earth are subject to centralized control...

In recent years, preparations have been actively underway to reshape the world system, one of the main points of which is the disappearance of borders between states. Recently, the Nobel laureate of 1973, the ideologist of the New World Order, Henry Kissinger, in the German newspaper *De Welt*, declared "*The Westphalian order is in a state of systemic crisis, non-interference in the internal affairs of other countries has been **discarded** in favor of the concept of universal **humanitarian intervention**.*"

The UN is nothing but an adaptation of the Westphalian system in the realities of the twentieth century. Further, Kissinger continues - "*and the **principles of the Westphalian World**, which were based on the sovereignty of states and considered a violation of international rights by international structures as aggression, **should become a thing of the past**.*" i.e., Kissinger says that a New World Order has come to replace the laid structure of being, in other words, an all-consuming globalization. This is what is being proposed today as a model of the future: **The change of national sovereignty and the Westphalian system to the power of corporations over the world is a network management principle.**

The old Nation-states, the ones that were built as a result of the Westphalian system of peace, are no longer needed by anyone. And the powerful of this world - first of all. And now we have transnational corporations, closed clubs, and an international bureaucracy over the remnants of the state. And inside the states there are network business structures that have grown together with the authorities, ethno-criminal mafia clans and offshore oligarchs.



Tellingly, in most of the joint photos of Putin and Kissinger on the Kremlin's website, there is certainly a fireplace between the interlocutors, without a hint of fire. Kissinger is a frequent guest in the Kremlin.

THE COLLAPSE OF NATION-STATES AND THE GLOBAL IDENTITY CRISIS.

People's self-consciousness (self-standing) hinders external control. But this obstacle is effectively eliminated. The ideology of consumerism has replaced all values, and has become the basis of a new identity of people, preparing them for entry into the global world of the New World Order.

The collapse of social norms, moral dogmas and traditions has led to a total identity crisis.



The borders of the Westphalian world are becoming increasingly narrow and inconvenient for the performers of conceptual power, who consider themselves strong enough to suppress the resistance of smaller clans. There is a steady trend of globalization of the criminal business of these clans, for example, drug trafficking or exchange operations are de facto ex-territorial. The presence of parochial criminal-governing clans only increases the costs of transnational corporatocracy. Therefore, corporate bandits are interested in their destruction and replacement.

THE MEANING OF A NATION FOR 4XX BRAIN GENOTYPES.

As indicated in the materials of the OFCH Ch .4: As part of the goal vector of the interventional control system for the development of the brain genotype of a social parasite, in 1433, the Alps 1 CC, 441 (Masonic) brain genotype was introduced. In a short time, these system performers carried out the interception of leadership from the Religious-dogmatic structure of the state and law of brain genotype 423, replacing it with secret orders and clans. *"It was at this stage that many innovations were carried out through the 441 genotypes, namely: in the field of state and law, the introduction of state defense structures and the **protection of the interests of the leading group of brain genotypes on a state basis; changes in the system of violence in the social structure.**"* A distinctive feature of this genotype is a special design of information blocks of the brain, capable of perceiving system software control for their implementation in the human world.

The signing of the Westphalian Peace Treaty between the bandit clans in October 1648 is officially considered the end of more than a century of the Reformation era, and the end of The Thirty Year' War between everyone with all of Europe. The Reformation is in fact the ancestor of modern color revolutions - against the old imperial orders and the hitherto indisputable institution of Papal power.



The cities of Osnabrück and Munster in the German state of Westphalia were chosen for the negotiations, since they were located in the middle between Sweden and France. From 1643, 150 delegations arrived in these cities, that is, **150 parties to the conflict**. Representatives of Catholics gathered in Munster, Protestants - in Osnabrück. All parties communicated with each other through intermediaries. This lasted for almost **5 years** until finally, the conditions of peace were worked out.

The new principle of national sovereignty included the principle of using the so-called national languages, which each of the rulers began to create and plant in the captured provinces, once a single Great Empire. All international issues, the so-called **"international law"** (it appeared then) - from now on will be decided by "sovereigns" (self-appointed leaders of criminal clans), **newly divided national states**.

Swiss lawyer and diplomat, Emmer Devattel wrote the famous book **"The Law of Nations"** in 1758. It was after this book that the word **"NATION"** appeared. Until that time, no one had uttered the word **"NATION"**. And oddly enough, this book is still being studied by legal and diplomatic theorists.

According to the materials of the OFCH, the Temporary state for ***the entire period of the Ebrov intervention was defined as "Zion", i.e., Sion***. The habitual worldview of mankind has been subjected to **ZIONIZATION**, that is, **the destruction of integrity and radicalization**, in the Jewish religion it is a symbol of the menorah, in the Russian tradition it is a multi-headed miracle of Judaism. It is not difficult to guess where the Vatican philosopher Niccolo Machiavelli got the principle of "Divide and rule". Of course, he was not the first genius who perceived the broadcast of the main software installation of the interventional system.

Within the framework of **Zion, Nation** - a people that has appropriated the right to carry out violence against other peoples. Within the framework of **Zion, Nation - an instrument for the domination of one culture over the rest, legalized by the state, which monopolized the right to violence**. No wonder in Latin, **Nation** sounds like (NATION) На-Цион/Nation.



The only source of power on the planet was the Lord God and God's elected representatives on the ground — the so-called monarchs, clergymen, later Masons and all others who were

constructively endowed with a direct channel of communication with God. (system executors of 42X and 441 brain genotypes)

Max Weber, in his concept, argues that **Nations** can exist where this factor is seen as a source of common values, and thereby **create feelings of solidarity towards outsiders. That is, the superiority of some over others is necessary.** That is, **the creation of a Nation is the lot of the chosen,** and the rest are considered outsiders. There is no need to convince anyone that the imaginary superiority of one people over the rest inevitably leads to extremism.

On 10 December, 2015, the next broadcast of the Panopticon program with the participation of Boris Nevzorov and Russophobic political strategist Stanislav Belkovsky, was broadcast on the Dozhd TV channel. The latter, declaring himself a Russian Nationalist, and feeling his absolute impunity at 5:45, literally stated the following: **“Jews have always been ultimately extremist, because they are the chosen people. And who else can extremism be inherent, except for the unelected people?”** Khodorkovsky's call for a revolution in Russia was proposed for discussion on the program. However, the video recording of the conversation was suddenly deleted from the social networks and YouTube by the executors of the parasitic system, concerned about the revelations of a political strategist who had become insolent from impunity.



Thus, the pathological craving for bragging, coupled with an innate sense of Racial inferiority in this talker, leads to the meaning of the **“National State, Jewish type”**, in the words of this character. Most often there is a deliberate combination of several concepts into one, so not all Jews are involved in the above-mentioned extremism, but at the same time almost all representatives of this movement have Jewish roots.

Jews understand Nationality by the term Nation. The reason for this is a sore point for Jews, the issue of blood. Any discussion on the topic of belonging to a Nation, they will always be reduced to clarifying the pedigree line. We can also observe this in the speeches of another Russophobic political strategist, Vladimir Solovyov-Shapiro.

Belkovsky emphasizes several times that, unlike Khodorkovsky, he is a Jew, and a Halakah one at that. This is determined by his mother's bloodline.

Russian scientist N.V. Levashov, in his now banned book "Russia Viewed through Distorted Mirrors", explained this characteristic pathology by the dominance of the X chromosome of the black race in the female genetics of the gray subrace (Jews), which caused the transfer of the properties and qualities of the gray subrace to the next generation. And there is no guarantee of inheritance of the properties of gray genetics on the paternal side.

Practice shows quite convincingly that **European nations were formed under the defining and overwhelming role of states** in a more general form. In the form of politics. **Outside of European states, one can only talk about nationalities and people, but not about nations.**

Thus, the conclusion suggests itself, the European Nations created by the self-proclaimed traitors of the Great Empire, following the results of the Treaty of Westphalia, in fact, were created on the basis of the biblical doctrine of God's election, radical extremist Zionism ("Deutschland über alles", "One Ukraine over all", or more precisely Zionism (Zionism).

If we speak politically correct, then in artificially created nations, in principle, there can be no such phenomena as nationalism or fascism. ONLY NAZISM, or SION-NAZISM, ZIONISM.

It was this radicalization of extremism embedded in European nations that was the hidden mechanism of their self-destruction, which Spengler warned about. Within the framework of the transition period taking place before our eyes, any violence will be suppressed by violence of a higher order, there will be no winners in the confrontation, both opposing sides will continue the conflict until complete self-destruction.

WHAT DOES IT HAVE TO DO WITH US? OR THE NATIONAL TRAGEDY OF THE RUSSIAN PEOPLE IN THE XVII CENTURY.

Orthodox historians stubbornly associate the XVII century of Russian history with the era of the European Reformation. Stubbornly ignoring the obvious parallels with the **Counter-Reformation**. *"The system of measures aimed at suppressing and eradicating ideas of reformation and movements: the creation of the Supreme Inquisition Tribunal, the introduction of strict censorship, the intervention of the Papacy in state affairs and the involvement of monarchs in the fight against Protestantism — is known in history as the **Counter-Reformation**"*

Book burnings, the cruelest suppression of uprisings, punitive companies against their own population, the mass alleged self-immolation of heretics, accompanied again by the mass seizure and burning of books, the struggle for the purity of scripture with any dissent to absolute destruction, the unification of dogmas and rituals up to the dictate of architectural

solutions. And of course, the total shaming and slandering of everything connected with heretics, schismatics, reducing the essence of their knowledge and faith to insignificant ritual details. All these are **equally integral features of the rule of the Pope and concurrently Grand Inquisitor Paul IV, Gian Pietro Carafa, and Patriarch Nikon.**



In addition to the abolition of the Zemsky Sobor, something similar happened in Russia in the 17th century. It is not known for certain what state the Russian Orthodoxy of Sergius of Radonezh was in after the destruction of Asgard of Iria in 1530, the Great Troubles of 1610-13, and the accession of the Romanov dynasty. But it is logical to assume that due to the negative influence of the spatial heterogeneity of the Night of Svarog, and the decreasing life support from the Native Control System, **as well as in the case of the Faith of the Cathars, Russian Orthodoxy gradually lost understanding knowledge carriers and degraded.** But it is naive to believe that the Byzantine priesthood could have preserved **Orthodox Christianity in any better condition, after the devastating crusades, and in the subsequent conditions of the 200-year Ottoman Yoke.** Nevertheless, Nikon, with the support of the Romanovs, organized the exodus of the Roman priests from Constantinople, conquered by the Ottomans in 1453, to Muscovy.

According to the research of the Russian scientist, Honorary Academician of the USSR Academy of Sciences, N.A. Morozov, set out in 8 volumes of the monograph "Christ", **it is logical to assume that Orthodox Christianity of the Byzantine sense was in fact only a restoration of the façade, by that time completely discredited, of the Greek pagan cult of Dionysius,** into which, according to the research of Lev Prozorov and Diy Vladimir, Prince Vladimir the Baptist baptized Kievan Rus with fire and sword. If this version is correct, it turns out that **Nikon was really engaged in the reform of Christianity itself, but at the same time, together with Tsar Alexei Mikhailovich, carried out the total destruction of Russian Orthodoxy and National Self-government.**



According to Wikipedia, **Tsar Alexei Romanov revered Patriarch Nikon, trusted him to manage the affairs of the state**, and during the wars with the Polish-Lithuanian Commonwealth (1654-1667) and his long absence **left the patriarch de facto at the head of the government**. By the **order of the Tsar, the royal title "Great Sovereign" was added to the patriarch's title "Great Lord"**.

In the preface of B.P. Kutuzov's book *"Church "Reform" of the XVII century as an ideological diversion and national catastrophe"*, you can read: **"In the middle of the XVII century, there was a substitution, a forgery of the Russian national idea. The concept of Moscow - the Third Rome (Moscow is the guardian of the purity of the Orthodox faith) was interpreted not in an eschatological, but in a purely political sense. The idea of creating a Great Greco-Russian Eastern Empire, headed by the Russian Tsar, was the reason for the hasty unification of Russian and Greek church practice, which was later called the Nikon reform."** And once again we see how **the idea of God's chosenness led to radical extremism** directed against one's own people.

A.I. Solzhenitsyn is credited with saying that if there had been no XVII century, maybe there would not have been 1917.

However, of all the European powers, **only Russia in that era continued to be an empire**, i.e., a country united by a common imperial plan. **She did not even try to create some kind of nation-states.**

WHAT IS NATIONALITY?

Our time is constantly guilty of manipulating words and terms, the meaning of which the person pronouncing and manipulating does not understand, since he considers education to be what was presented to him by falsifiers of the educational process, imagining themselves to be teachers, professors, etc. All these subjects believe that nationalism is a product of the existence of a nation, but despite the similar semantics of these concepts, the answer is ambiguous.



For a person unfamiliar with the intricacies of the thoughts of political pathologists, everything is simple at first glance:

Nation = Nazism, Nationality = Nationalism. It would seem much easier?

However, the patriarch of Russian Nationalism Ivan Ilyin, whom President Vladimir Putin himself does not disdain to quote today, has never used the term nationality at all.

The famous God-seeker, N. Berdyaev, in the book "The Fate of Russia" wrote: ***"All attempts to rationally define nationality led to failures. The nature of nationality is indeterminate by any rationally perceptible signs. Neither race, nor territory, nor language, nor religion are signs that determine nationality, although they all play one role or another in determining it. Nationality is a complex historical formation, it is formed as a result of a complex mixture of races and tribes, many redistributions of lands with which it connects its fate during the spiritual and cultural process that creates its unique spiritual peak. And as a result of all historical and psychological research, an indecomposable and elusive residue remains, in which lies the whole secret of national identity. Nationality is mysterious, mystical, irrational, like any individual being."***

Formally, Nationality is a legal fixation of ethnicity in the form of an entry in a passport and other documents. It may not coincide with the real self-identification (ethnic self-awareness) of both an individual person and an entire ethnic group.

In today's world, the term "nationality" is not used at all. In Ukraine and Russia, there is no **"nationality" column in the passport**. In passports, they write Citizenship in English, Citoyenneté in French, Staatsbürgerschaft in German, which means **citizenship** (townspeople). Before the revolution of 1917, **Citizenship** of the Russian Empire was registered.

Nationality is a biological-legal misunderstanding in the passport that has nothing to do with the soul, invented by bookworms instead of NATIONALITY. An atavism of the Soviet era, when system performers needed to justify the now-failed experiment to remove the "Soviet people", without using the word, Nation. Nationality can be viewed as a hostile information block in the neural structures of the brain, which interferes with critical thinking in the search for truth.

THE TRAGEDY OF THE RUSSIAN PEOPLE IN THE POST-LIBERAL MULTI-NATIONALISM OF THE RUSSIAN FEDERATION. OR HOW BORDERS ARE COLLAPSING.

According to OFCH. Part 3: *"The historical indigenous peoples of Russia need the **pure truth**, no matter how bitter it may be, because only it **will recreate the state of unity of the nation, faith and the all-conquering power of Russia.**"*



The American Constitution of the Russian Federation

Neither the State nor Turkey interfere with Us as our Constitution is our most important enemy.

Many do not believe that in the multinational state of the Russian Federation, all power belongs in fact and by law to a multinational people, since biblical times, chosen by God to disperse

among other nations, with a program of seizing power and finances, and enslaving these nations. The myth of the Tower of Babel precedes the dismemberment of a single humanity into many nations, thereby preparing all mankind for enslavement. So it was with the Great Tartary, so it was with the USSR, and the same was planned for the Russian Federation.

But to check this fact, it is enough to read the text of this document on the right page.

There are no other multinational peoples in nature. There may be a multi-ethnic nation, as a political entity that unites different biological ethnic groups. But in order for a nation to become multinational, it must be introduced into many nations.

Russia was declared a multinational state as a result of the illegal adoption of the constitution of 1993, written on the blood of defenders and the wreckage of the Supreme Soviet shot by tanks, by American consultants from a multinational people. The multinational oligarch-bureaucratic state is doomed to all-consuming corruption and inevitable collapse.

The Russophobic meaning of a MULTINATIONAL state is the parasitism of an alien minority over a national majority in accordance with the principles of Nicolo Machiavelli on the establishment of alien tyranny in the occupied colonies. The Friendship of Peoples in the USSR functioned in the form of International Parasitism, when small nations enjoyed the fruits of the labor of the state-forming people. Which in turn was divided into three parts and deprived of independence.

In the OFCH, this phenomenon is called NATIONAL-DEMOGRAPHIC FASCISM.

The illegitimate Constitution of 1993, adopted in a rigged referendum, was laid like a bomb in the foundation of the Russian Federation, for the dismemberment of the Nation-state, according to the patterns of the dismemberment of the Great Tartary through the Westphalian Peace Treaty. Many people remember the customs offices that suddenly appeared, and checkpoints on the internal roads of the country, Chechnya and other autonomous regions, composed their own constitutions and heroic national stories. But according to OFCH, this process was interrupted at the system level.



Among the many anti-Russian theses, one can be singled out, which is used by all the enemies of the Russian people without exception. They use it because it is the most destructive for us. This is the thesis that "Russia is a multinational country." What makes it destructive is not the very recognition of the fact that many peoples live in Russia, but the false conclusion that is drawn from it - about the equivalence of the peoples of Russia. In an incomprehensible way, the 120 million Russian people who created Russia became only "one of the peoples inhabiting it."

However, this is not all: the thesis about "multinationalism" does not even mean "equality" of the Russian Giant with the Lilliputian peoples.

In the state created by our ancestors, the Russian people turned out to be, in fact, disenfranchised compared to other nations. Having received political status in the form of their own republics and autonomies, they have the opportunity to pursue a policy of their own national development in these territories. The Russian people have no such opportunity.

The status of a "multinational country" does not allow for a National Development Policy towards the Russian people at the All-Russian level. But it is unacceptable and criminal to hold it officially at any other level than the state one. After all, this would mean denying the Russian people the right to the whole of Russia. It turns out that we seem to be at home, but nothing belongs to us.

The Russian people do not have an official political status either – that is, their very existence is not actually recognized.

The Russian people today are divided by the national borders of three states.

The political elites of these three states, with the beginning of the Ukrainian war, **obviously showed a desire to prevent the "Russification" of Novorossiya and the Russian Federation. Russian people are recognized as a divided people, they receive a legal status as a subject of politics in the Russian Federation itself and the penetration of the Russian idea into the domestic political discourse "more than allowed" and, thereby, turning it into a political reality.**

The Russian Brigade Commander Alexey Mozgovoy and Pavel Dremov appealed to the Russian leadership on 19 May, 2015, asking for support for the "Russian Project", thereby raising the question of the need to designate the Russian People as an independent object of the internal policy of Novorossiya and Russia. After 4 days, the legendary commander, the hero of the Russian Spring, was eliminated by a professional special purpose team. Dremov was killed 6 months later.



ESSENCE OF NATURAL NATURE – RUSSIAN WORLD

The Westphalian World is hundreds of treaties and documents. This is the documentary point of the collapse of Great Tartary. Moreover, this is the end of the reign of the Rurik dynasty. In Moscow Tartary, this is the well-known "time of troubles" and the reign of the Romanov dynasty in the Kremlin of the Nobility and the Vatican. Both in Europe and in Russia, this systematic transition to a new political formation was accompanied by the replacement of religion. Catholicism was practically replaced by Lutheranism and Calvinism, and the Russian Orthodoxy of Sergius of Radonezh was replaced by Greek Orthodox Christianity. The choice of religion for

each territory was determined from the ability of the new "teaching" to mimic the existing Faith, as well as the purpose of the territory. Unlike European Union Nations created by nation-states, **the Russian Nation formed the state, the Zemstvo Councils elected to reign and had the right to depose the monarch.** During the period of the Great Troubles of 1610-1613, the Zemsky Sobor was the supreme authority (both legislative and executive), deciding on issues of domestic and foreign policy, adopting the Council Code. **With the coming to power of the Romanovs, the Zemsky Sobor as a mechanism of structureless power quickly lost its importance, and in 1684 it was liquidated.**

Previously, a person was asked: "Who? Which **Family?**", he answered: "**Ours,**" and called his family name, that is, the surname of his father, grandfather, great-grandfather... There was no NATIONALITY column on the forms of the first census of the Soviet Union in the 20s. There was the word **PEOPLE**. The modern word "nation" was borrowed from the German language, and it originates from the Latin nation (tribe, people), which, in turn, comes from natus (born).

That's why for a Slav or Aria, any white person was OURS, native. **OUR KIND are the PEOPLE.** There was only one difference: **OURS and the GERMANS.** Germans are not Germans. Our ancestors called Germans those who are "**not WE,**" that is, foreigners. By the way, the word **eNEMY** has been preserved in English. So did the glorious descendants of the Celts, Picts and Scots also have their own Germans? Mikhail Zadornov puts forward the theory that the Germans are those outcasts of the white race who have lost touch with the Genus (have become numb), that is, in the realities of OFCH, have dropped out of the broadcast of the life support of the controlling native system.

The Rus people represent the Triune Racial Core of the Russian Nation.

To understand this fact, we quote from N.V. Levashov's article "The Last Night of Svarog"

"Correct words awaken genetic memory, false words or distorted ones leave this memory sleeping forever. When asked who a person is, the correct answer is Rus, and his language is Russian. And then everything falls into place.

Someone can say - both in the forehead and in the forehead. Is it worth "building a garden" because of this?! It's worth it... and for several reasons. First, to discover your genetic memory. I suggest that any genetically Russian person pronounce the word I am RUS and listen to himself. A Russian may not feel an internal vibration the first time, but when pronouncing the word, I am Russian, there will be no vibration, there will be only emptiness in the sensations.

Each word creates a certain qualitative resonance with the body and essence of the speaker. One word can awaken sleeping genetics, another, even very close, but having a completely different purpose – will leave these genetics to "sleep" further."

It is also worth noting that belonging to a Nation is determined not by blood, as provocateurs like to say, but by spirit. N.V. Levashov quite correctly said that Russian is an adjective.

But this is an adjective to the Russian Nation; a person may not be a Russian by blood, but if he carries the Russian spirit, speaks Russian, shares Russian culture, then he belongs to the Russian Nation. This is precisely the meaning of the adjective Russian. Raciologists call such people the racial periphery, no better or worse than the racial core, but simply different. Within the framework of dual logic, many mistakenly perceived this adjective as an insult in contrast to Rus. But not every Russian by blood is Russian in spirit, and not every Russian in spirit can be a purebred Russian. **Rus and Russian are not a contradiction, they are complementary concepts.**

In the philosophy of Ivan Ilyin, the **Nation**, being the bearer of sovereignty and an independent subject of history, is a **community of free people, a personal community**. And the proud grandson of the Slavs, and Finn, and now wild
Tungus, and a friend of the Kalmyk steppes
(Pushkin).*

And all of them, without knowing it themselves, mysteriously joined the gifts of Russian Orthodoxy, intimately embedded in the Russian national act. Russian nationalism spread the hidden rays of Orthodoxy throughout Russia. But from this it is already clear that national and ecclesiastical are not the same thing."

Ivan Ilyin was the first to comprehend and formulate 12 volumes on how to revive the image of Russia in the future and dedicated his life to writing specific practical steps for his descendants, that is, us. Using the language of Pushkin. But instead of the terms CPS and program management, he used religion, separating it from the concept of church. Perhaps not understanding, but realizing the role of the mechanism of energy-information accompanying the state of conciliarity.

Within the framework of the civilization of constituent violence, the Nation-States were built on the basis of the formation of the image of the enemy, as the Russian political scientist A.N. Savelyev told in the book "The Image of the Enemy"
