Transformation is the first pattern

*There are some misconceptions
that cannot be refuted.
It is necessary to inform the deluded mind
of such knowledge that it will enlighten.
Then the delusions themselves will disappear.*

There are no tasks in the world due to lack of money. All stand for a lack of ideas. The reason for this scarcity is that the mind is constrained by immutable, alphabetical, eternal and obvious truths. It cannot go beyond the boundaries they delineate, while the new is always beyond the boundaries of the known. What is within is, at best, an upgrade of old truths, but never new. However, it is today that **SOME** need to be **REMINDED** and many need to be told – from where and from what "box" the (is)toric was pulled out and the dust shaken off by those who are attempting to apply it and think of themselves as strategists for building the so-called "new world", not realizing that all their attempts are in vain.

Today's relations between the Russian Federation and the European Union resemble those of the USSR and Europe in the prewar and war years. As in 1941, Europe is again dissatisfied with everything connected with the Russian Federation, just as it was dissatisfied with the USSR before. And then it turns out that even earlier, **SHE WAS** also dissatisfied with Czarist Russia, and even earlier dissatisfied with Russia.

Modern world politics has discarded the principle of political correctness and opened a Pandora's box, using the "*deeds of bygone days*" as accusations against Russia, as if Europe does not have **ITS OWN SINS** on a global scale. If you remember them, then maybe the senseless harassment of each other with heavy reproaches of the long and recent past will stop?

It is useful to remember: - 1. The deterioration of EU relations with Russia occurs periodically. What is the reason? 2. The deterioration of relations always occurs with a united Europe on the basis of a common ideology. On what basis does the unification occur? 3. Does every creation of a united Europe end with an attack on Russia? Why? 4. Every armed attack of a united Europe on Russia involves Germany? Why Germany? 5. In every attack by Europe on Russia its ally is England. Why is England always **OUTSIDE OF UNITED** continental Europe? 6. What psychological-political mechanism, almost a natural law, causes the countries of Europe to unite and start attacking neighboring states?

Answers to these questions are necessary: - to prevent the next confrontation of a united Europe with Russia, to understand its psychological and political mechanisms, not to give the current aggravation of relations with the EU the significance of a catastrophic and unprecedented event - this is **NOT THE FIRST** time this has happened. Everything lies in the fact that the hardening of the foreign policy of the united Europe is caused by the **factor of lack of living space**, which is transformed into the **IMPROVEMENT** of the **IDEOLOGY** of military aggression. Russia is historically "guilty" before Europe that it does **NOT** have a **SHORTAGE** of "**living space**", and the ideology of its existence is adequate to the natural and climatic conditions of life. But there is also an internal problem, which lies in the "TABOO ON IDEOLOGY" in modern Russia after the collapse of the USSR, which made the country helpless in discussions with EU ideologists, which is reflected in the realities of today's practical, brutal information war. The tradition of avoiding the formulation of one's own ideology was laid down back in Soviet times, when the "instructions" on the methodology of historical research contained strict instructions: **"the main determining factor and the basis of all historical development are NOT IDEAS, not certain views of people, but the conditions of material life of society, social production"** Therefore, political ideas, ideology –precisely, they were completely removed from the analysis of modern political processes, which are completely and precisely determined by the **STRUGGLE** of **IDEOLOGIES** expressed today in an open information war.

RUSSIA DOES NOT have an ideology capable of reflecting the ideological aggression of its opponents, because in the late 80s and early 90s, the authors of the Constitution of the Russian Federation legally prohibited the formulation of the ideology of Russia in Article 13 of the Constitution of the RF: "Article 13. 1. Ideological diversity is recognized in the Russian Federation. 2. No ideology can be established as state or mandatory". But it is possible to create and present the ideology of Russia **WITHOUT PRESENTING** it as state, so as not to conflict with the Constitution. But to do this, you need to understand that in order to put something necessary in your head, you first need to **FREE UP SPACE**, throwing out everything unnecessary from it. No one could do this, and as a result of the "ideological diversity", not only an absurd, but also a dangerous situation was created: there is a struggle inside the country between direct representatives of the ideology of Russia's opponents and supporters of its sovereignty.

Throughout history, Europe's main claims to Russia have been ideological: sometimes they concerned religion, then the form of government, then values, then the goals of the Russian state. It is ideology that is primary in relation to "the conditions of the material life of society, social production." Only ideology answers the three most important political questions: **what is the meaning of politics, what are its goals and what values does it stand for?** Today, both citizens of modern Russia and representatives of the EU, whose ideology is built by the United States, or more precisely, by the Anglo–Saxons (a specific brain genotype), are waiting for an answer to these questions. Ideology – forms a person's consciousness, formulating the meaning of his life, life goals and life values. European countries have been united **MORE THAN ONCE** in their history, and conflicts with neighboring countries have always followed the facts of its unification, turning into wars in order to seize their "living space".



This is, in fact, a natural, cyclical phenomenon that always occurs when Europe has hit a dead end in its development. Nikolai Alexandrovich Morozov¹ wrote about this at the time. How was it, and what theoretical model makes it possible to understand it? Europe was once again united in 962 under the name of the **Holy Roman Empire** to control the political and spiritual life of various regions, tribes and slaves. Roman emperors (or Popes) claimed supreme power in the Christian world and over the world in general. The instruments of the Vatican's influence were ideology, **ideological expansion and forcible coercion of the peoples of the world to accept the faith called Catholicism**. The Holy Roman Empire became the **MAIN CREATOR** of problems for Europe. The main problem was the division

(schism²) in 1054 of the Church into the Roman Catholic Church in the West with the center in Rome and the Orthodox Church in the East with the center in Constantinople. For Russia, the split had an important political significance: the Holy Roman Empire sought to prevent the Russian Church from becoming a patriarch, so that its rulers **COULD NOT** receive the title of emperor. The title of emperor can be counted on only if there is a patriarch, and the patriarchate could only be where the apostles preached. At that time there **WAS NO** information about the stay of the Apostle Andrew the First-Called in Kiev. The ideologist of the crusades of the united Catholic Europe to the North of Europe and to Russia was, in particular, **Pope Gregory IX**. The ideology of Catholicism was promoted as a faith that meets the requirements of the time, as opposed to the so-called paganism and Orthodoxy. It was argued that only Catholicism was capable of: destroying paganism; ensuring that the contract is sacred; forcing people to live according to the laws; making work necessary for the salvation of the soul; ensuring that property becomes sacred, etc. But the main thing is to work out the management of the masses of people within the framework of the Program "Development of brain genotypes and Energy Biogenesis of the flesh of the body"³, through specifically created genotypes of people, within the framework of their purpose – to manage.

The publication was published for five years, accompanied by accusations of religious propaganda and ended on the 7th volume. The remaining volumes were destroyed.

² Schism in Christianity, church schism, **schism** (other - Greek σχίσμα — "splitting", "splitting") is a division in the Christian church organization caused by theological, canonical, mass and multiple aggregates.

³ **Each separate typology of the deformation of the Mind Structure is the so-called Brain Genotype**. The acquisition of a contact information state (Consciousness) is provided through the Construction of the MIND. Imputation of Brain genotypes is the process of giving performing actions with a low, i.e., blocked level of Consciousness of people like a cyber appendage for imputation and implementation of their plans.

The significance of the confrontation between Russia and Europe shows how the task of destroying brain genotypes was practically solved, which for one reason or another did **NOT FIT** into the overall plan of creating specific brain genotypes with imputed characteristics for a specific time. For example, the fate of the disappeared Slavic peoples, whose homeland was the whole of Central and Eastern Europe. The Catholic ideology was followed by the brutal assimilation of the Slavic peoples. We can cite the fate of the Polabian Slavs⁴, who disappeared forever from the map of Europe, from world history. The Polabian Slavs were doomed, **AFTER ADOPTION** of Catholicism by Poland, being squeezed by Germany from the west, Poland from the east and Bohemia from the south. They refused to convert to Catholicism and were ruthlessly destroyed by the Germans. Now on their lands, on the political map of Europe, the Federal Republic of Germany appears, and no one living in modern German cities knows that once these cities had Slavic names. For the forceful expansion of Catholic ideology, the **Livonian Order** was created (1237): a Catholic and military-political organization of the knights of the Teutonic Order. The founder of this organization was **Bishop Albert**, a conqueror with imperial ambitions.



Solving these problems in 1238, the Danes, Swedes and the Order began **MILITARY OPERATIONS** to capture Pskov and Novgorod by the Roman Catholic Church. In July 1240, Swedish military leaders Jarl Birger and Ulf Fasi attempted to invade the Novgorod lands under the pretext of exterminating pagans. The crusade of the Teutonic Order to Russia ended in defeat for them in the "Ice Battle" in 1242. However, this cycle continued in the Livonian War of 1558, in which the allied forces were opposed by an army led by Ivan the Terrible. Nevertheless, during the Livonian War in the middle of the XVI century, the Order suffered a number of defeats at the hands of **Russian TROOPS**, after which it in 1561 it ceased to exist.

As a result of Russia's victory in the confrontation with the United Catholic Europe, Russia was proclaimed an Empire on 22 October (2 November), 1721. Russian Tsar Peter the Great assumed the title of Emperor of All-Russia and Father of the Fatherland. But as a result of the Crusades, the Orthodox in the majority of their population survived only in Russia, Serbia, Montenegro, Macedonia, Bulgaria. Poland, Slovakia, the Czech Republic, Croatia, and Slovenia became Catholic.

⁴ **Polabians, Polabian Slavs**, is a historiographical term adopted to designate a large group of Western Slavic tribes that inhabited the vast territory from the mouth of the Laba (Elba) River and its tributary the Sala (Zale) River in the West, to the V�dra (Oder) River in the East, from the Ore Mountains in the South and to the Baltic Sea in the North, from approximately the end of the 5th century AD to the middle of the 13th century. Thus, the lands of the Polabian Slavs covered the east, north and northwest of modern Germany (FRG), which is not less than a third of its territory.

There are a significant number of Catholics in Ukraine and Belarus. In Bosnia and Herzegovina, **HALF** of the **LOCAL SLAVS** are Muslims, and the rest are both Orthodox and Catholics. Novgorod and Pskov have been preserved.

The Holy Roman Empire lasted until 1806 and was liquidated during the Napoleonic Wars, when the last Emperor Franz II of Habsburg abdicated. Processes incredible for the times of Pope Gregory IX and other ideologists of the Roman Catholic Church have begun. The religious power collapsed, which could not withstand the collision with new realities. New realities provoked revolutions in the Netherlands, England and France. Now revolutionary France **HAS BECOME A LEADER** in creating and solving ideological problems. Since the adoption of the *"Declaration of Human and Civil Rights"*, Catholicism HAS LOST THE STATUS of the state religion. *The Constitution separated the Church of France from Rome and subordinated it to the "enlightened" state.* All church possessions were nationalized, all monasteries were dissolved. All their property was **CONFISCATED AND SOLD**. Clergy who refused to swear allegiance to the Constitution were deprived of their civil rights and expelled from the country: about 40 thousand priests were forced to leave France in convoys that were escorted to ports.



Skipping the details, I must say that when **Pope Pius VII** wanted to put the crown on Napoleon's head, he tore it out of the pope's hands and put it on himself. Napoleon exports his ecclesiastical views to other European states. But the essence of his achievements and the main export of the French army lies in the *"Code of Napoleon"* of 1804. He himself said that *"my true glory is not that I won 40 battles: one Waterloo crossed them all out. What will live forever is my civil code."*

Napoleonic wars exported the ideology: *equality of citizens before the law; inviolability of the person; freedom of conscience, etc.* All the countries of Europe defeated by Napoleon, one after the other, **ADOPTED THEIR CONSTITUTIONS** on the basis of his Civil Code. The Napoleonic wars were **MORE IDEOLOGICAL** than invasive. Again ideology, but incompatible with the Orthodox ideology of Russia.

Only two countries in Europe did not accept the Napoleonic Code: **Russia and England**. There are many economic, diplomatic reasons for Napoleon's attack on Russia, but the main ones, again, were the absolutely **NEW IDEOLOGICAL REQUIREMENTS** of the united Napoleonic Europe to Russia: **to accept the Code and reform society and the state**. Napoleon's words were: **"In five years I shall be ruler of the whole world. Russia alone remains - I will crush it..."**.

The fact that Russia, as during the Livonian Wars, was not dealing with one country - France, but with the **IDEOLOGICAL UNITY** of all the countries of Europe around Napoleon, says the facts:

A) Napoleon's army, which invaded Russia, was composed of more than 50% of the soldiers of the 16 nationalities of Europe: divisions, regiments, battalions, and squadrons from France, Austria, Hungary, Prussia, Poland, the Grand Duchy of Lithuania, Holland, Spain, Italy, Saxony, Bavaria, the Small German Duchies, Berg and Cleve, Westphalia, Württemberg, Hesse-Darmstadt, the Kingdom of Naples.

B) Napoleon was able to muster between 400,000 and 450,000 soldiers for the campaign against Russia.

C) By 1811, the French Empire, or United Europe, numbered 172 million. The population of the Russian Empire in 1811 was just over 40 million people.

Although in historical scholarship it is not customary to consider the attack of Napoleon's army on Russia as an ideological war, but in fact it is. Without a unifying army ideology, no one was able to seize the territories, resources and communications of the enemy.

The ideology of the EU under Napoleon became constitutional: the church was separated from the state, monarchical regimes were transformed into republican ones, constitutions were introduced everywhere, and courts were created, before which everyone became equal. Russia's ideology remained the same: the church remained part of the state, the monarchical system was preserved, constitutions were **NOT CREATED**, and the courts remained estates.

The next cycle of Unification of Europe and its claims to Russia began after the victory of the Great October Socialist Revolution in 1917. By this time, the Russian Orthodox Church had repeated the fate of the French Catholic Church: it was separated from the state, the monarch was also overthrown and killed, the Constitution of the USSR was adopted, elected courts were created, and much more. It would seem that Europe should be happy. But... now Hitler's Germany had **BECOME** the **EUROPEAN LEADER** in creating problems and solving them. On 24 February, 1920, in the Hofbrohaus beer hall, Hitler announced **his "25 points" program**, which canceled all the conquests of the previous historical period of Europe. Everything that Napoleon had created was canceled, just as he had canceled everything that the Roman Catholic Church had achieved by 1804.

The ideas of the Pope and Napoleon were replaced by: the **DENIAL** of the **MODERN WORLD** under the sign of the denial of capitalist modernity; the accusation of modern culture and liberal intelligentsia in the departure from eternal values; appealed to the frustrated⁵ middle classes affected by the crisis; obsession with the idea of an international conspiracy; envy of "nations of five meals a day"; understanding of the people as a monolithic unity expressing the collective will; hatred of "rotten parliamentary democracies", etc. But the program openly stated **AGGRESSIVE DEMANDS** to seize someone else's "living space", mandatory "belonging to the nation", the transfer of all power in the country only to "citizens", concern only for the lives of "German citizens", the suspension of migration to Germany. The issue of the destruction of non-labor income, bank interest, nationalization of joint-stock companies, confiscation of wartime profits, prohibition of land speculation, the death penalty for crimes against the German people, the creation of a system of affordable public education, the people's army, etc., was extremely acute.: *"After centuries of whining about protecting the poor and the humiliated, the time has come for us to decide to defend the strong against the inferior. This will be one of the main tasks of German state activity for all time — to prevent by all means at our disposal the FURTHER INCREASE of the Slavic race. Natural instincts command all living beings not only to conquer their enemies, but also to destroy them."* This inspired many Germans, humiliated by the defeat in the World War, unemployed and starving. German science fundamentally worked to substantiate the "**25 points**", creating a racial theory, a philosophy of leadership, a project for organizing a new order in Europe, the formation of a popular community, the essence of power, etc. One of the ideologists of National Socialism - Guido von List insisted on *"the brutal destruction of all enemies in order to enter the elected into their lands and gaining thus, well-being!"*.

Based on the "**25 points**" by the end of 1941, the General Plan of the **Ost (German: Generalplan Ost)**, a program for consolidating the Third Reich in Eastern Europe, was developed and put into effect in Group III of the Main Directorate of Imperial Security. He planned to forcibly evict up to 75-85 percent of the population from the territory of Poland and the occupied regions of the USSR and place them in Western Siberia, the North Caucasus and South America. This plan of colonization and Germanization of the eastern territories was developed on the basis of racial doctrine and the concept of "living space" under the auspices of Reichsfuhrer SS Heinrich Himmler. In many European countries, a significant part of the elite of Hitler's "25 points" received support as an effective method of solving problems of unemployment, nutrition, order, justice for citizens selected by race. Nowadays, Nazism, as an ideological doctrine, is officially prohibited at the international legal level, and the propaganda of this doctrine is criminally punishable in all highly developed countries of the world.

⁵ The term "**frustration**" is used to refer to an unpleasant mental state that arises from the inability to get something much desired. This is the feeling of a dead end in life due to the fact that an insurmountable (or seemingly so) obstacle turned out to be on the way to the goal.

And then the union of numerous supporters of National Socialism, forgotten due to considerations of political correctness, began in Europe: organizations of supporters of National Socialism were created in all European countries. Except the USSR. Only the USSR and the Seventh Congress of the Comintern in 1935 condemned fascism, decided to create an Anti-Fascist Popular Front, proclaimed the struggle for peace, rejected the idea of war as inevitable, etc. Nevertheless, on 22 June, 1941, the "Principle of Drang nach Osten" was put into effect, as Hitler described it in his 1925 book *"Mein Kampf."* In the Hitlerite troops, orders were read before the offensives, such as the order of 2 May, 1941, the commander of the 4th Tank Group, Erich Hepner, in connection with the upcoming hostilities in the East: "...*The war against Russia is the most **ESSENTIAL PART** of the **STRUGGLE** for the existence of the German people. This long-standing struggle of the **Germans against the Slavs**, the protection of European culture from the Muscovite-Asian invasion, the rebuff to Bolshevism. This struggle should **pursue the goal of turning today's Russia into ruins, and therefore it should be conducted with unheard-of cruelty...***".

Well-known facts: the whole united Europe fought against the USSR. The USSR was the **IDEOLOGICAL OPPONENT** of the whole of Europe in the first place, and the owner of the "living space" and natural resources, in the second place. In the Great Patriotic War of 1941-1945, the USSR, with an initial strength of 190 million people, fought not with 80 million Germans of that time, but with almost the whole of Europe, whose number (with the exception of England allied to us and partisan Serbia not surrendering to the Germans) was about 400 million people. The war with the USSR was declared **NOT BY** Germany alone, but by **THE WHOLE UNITED EUROPE**": Italy, Hungary, Romania, Slovakia, Croatia, Finland. All except England. In fact, about two and a half million volunteers, representatives of countries such as the Netherlands, Denmark, Norway, Belgium, Austria, Latvia, Lithuania, Estonia, Sweden, Finland, France, Switzerland, Spain, Luxembourg, took part in the "crusade" against the USSR. *All of them took the Oath of volunteers upon joining the service: "I swear to you, Adolf Hitler, as a leader, to be loyal and brave. I vow to obey you and your appointed superior until death. And God help me."*



Holland was at war. Such facts as the formation of the Volunteer Legion "Netherlands" speak about the anti-Russian hysteria in Europe. The basis is the Nordvest regiment, volunteers - members of the assault detachments of the Dutch National Socialist parties.

The organization is recruiting stations, which were visited by privates and officers of the former Dutch army. The motivation is the desire of the Dutch to fight with the "damned Bolshevik hordes". The result - by July 1941, 5 battalions were **FULLY MANNED**. In the area of Fineva Luga, it was the Dutch who captured more than 3,500 prisoners, including the traitor General A.A. Vlasov.

Belgium fought. In August 1942, the "Flanders" legion occupied a section of the front in the defense zone of the 2nd SS Brigade, gaining its place in the ring of the blockade that squeezed Leningrad. Along with the Flemings, Dutch and Norwegian volunteers fought in this brigade. In February 1942, the Flemish Legion operated together with units of the 250th Spanish Infantry Division in the area of the Chudovo -Novgorod highway. In early April 1942, the legionnaires fought in the area of the "Volkhov Cauldron" to the east of the settlement of Lyubtsy, interacting with the Spaniards from the "Blue Division". In his speech, Legion commander Fitzhum thanked the Flemish volunteers *"for their contribution to the struggle for the common cause of the German people – the conquest of living space (lebensraum)."*

Spain was at war. Spanish Foreign Minister Serrano Sunier said that Spain is ready to help Hitler with volunteers. Organization - dozens of recruitment points have been opened, to which thousands of those who **WANT** to **FIGHT** the hated Bolsheviks have rushed. As a result, there were 40 times more applicants than necessary: on 2 July, 1941, recruitment centers were forced to curtail their activities. The volunteer "Blue Division" was formed: the total number of the division was 18,693 people (641 officers, 2,272 non-commissioned officers and 15,780 lower ranks). On 31 July, 1941, Spanish volunteers swore allegiance to Hitler, and the "Blue Division" took its place in the ring of the siege of Leningrad, occupying a 29-kilometer section of the front.

France fought, which **DID NOT RESIST** the German army. "Soldiers from the defeated army said the same thing: there was no real fighting, there was no real resistance. From the very first blows of the Germans, the withdrawal of our troops began, everywhere, from top to bottom. The headquarters dug in deep in the rear, with which it is impossible to establish communication, they did not give orders, the officers abandoned their subordinates, and those, due to lack of ammunition, immediately retreated." But nevertheless, in order to help Hitler in France during September-October 1941, a completely combat-ready 638th Infantry regiment was formed from volunteers. In October, the regiment was sent to Smolensk, and then to Moscow, to the Borodino field. The 33rd SS Grenadier Brigade (later a division) gained the greatest "glory" from the French volunteers "Charlemagne." The French fought at Stalingrad, on the Kursk Bulge, in the battles for Poland and East Prussia.. If 20 thousand people died in the ranks of the Resistance in France, then about 50 thousand Frenchmen died in the ranks of the "German" army on the battlefields of the USSR. It was the French who fought to the last, defending the Reich Chancellery and the Reichstag.

Hungary was at war. Almost one and a half million Hungarians fought against the USSR. They proved themselves to be the most brutal and ruthless Nazi military formations.

The Hungarians played a decisive role in August 1941 in the encirclement and liquidation of the Uman "boiler," where the troops of the 6th and 12th armies of the Southwestern Front and the Southern Front of the Red Army - at least 20 divisions - were killed. 100 thousand Soviet prisoners of war were placed in a concentration camp near the city of Uman, informally named "Uman pit". In the battlefields and in the camp, the **HUNGARIANS SHOT** Jewish prisoners of war, commissars, wounded and weakened. Even Joseph Goebbels wrote on 18 May, 1942 about punitive actions taking place in the Bryansk forests: *"Hungarian formations are fighting south of this region. They need to occupy and pacify one village after another. When Hungarians declare that they have pacified one village, it usually means that there is not a single resident left there."* The Hungarian occupiers recalled how they dealt with women and children, and thanked God for being able to participate in the destruction of the "Slavic and Jewish infection." The total losses of Hungary on the Eastern Front during the war amounted to 809 thousand people and, in addition, 513 thousand. 766 prisoners.

Belgium fought. In July 1941, the 373rd Walloon Battalion was formed, transferred to the 97th Infantry Division of the 17th Army of the Wehrmacht.

Austria was at war. Two mountain rifle divisions of Alpine riflemen were formed, which were part of twelve mountain rifle divisions: Bosnian Muslims, Albanians, Norwegians.

Croatia fought. The 369th Infantry Regiment of the Wehrmacht and the Croatian Legion as part of the Italian troops were formed from volunteers.

Bulgaria fought. They did not fight directly with the USSR, but they put forward 12 divisions against the Yugoslav and Greek partisans, and thereby made it possible for the Germans to transfer their units from the Balkans to the Eastern Front.

Sweden fought. 2,000 people signed up to volunteer in Finland. Of these, approximately 850 people participated in the fighting near Hanko, as part of the Swedish volunteer battalion.

Norway was at war. The "Norwegian" Volunteer Legion was created. After taking the oath to Hitler it was sent near Leningrad. By the end of June 1941, 294 Norwegians were already serving in the SS "Nordland" regime

Latvia was at war. *Waffen-SS* units were formed (15th and 19th divisions), which were included in the 6th SS corps, which, in turn, was included in the 18th army (Army Group "North"). From 150 thousand soldiers and officers of the Legion more than 40 thousand were killed and almost 50 thousand were taken prisoner by the Soviets. ***The 1st Latvian battalion participated in the last battles, defending Berlin and the Reichstag.***

Denmark fought. The Danish "Volunteer Corps" was formed. By the end of June 1941 there were 216 Danes in the SS "Viking" division.

In all, **1.8 million** volunteers came to Hitler's army from all over Europe; **59 divisions, 23 brigades and several national regiments and legions were formed from them.** Many had their own national names: "Walonian", "Galicia", "Bohemia and Moravia", "Viking", "Denemark", "Hembes", "Langemark", "Nordland", "Netherlands", "Charlemagne", etc.

The blockade of Leningrad can be considered a **PAN-EUROPEAN CRIME**. In addition to the Norwegians, the Dutch legion "Netherlands", and a Belgian battalion operated near Volkhov.

Spanish volunteers from the "Blue Division" fought here, **Finnish and Swedish troops** besieged Leningrad from the north, **Italian sailors** were preparing for battles on Ladoga. The Dutch showed unheard-of cruelty near Leningrad towards the civilian population. According to eyewitnesses, anyone suspected of having links with the partisans was mercilessly killed on the spot by the legionnaires.

The whole of Europe served the war effort of Hitler's army: 8,000 Dutch drivers delivered ammunition for Hitler's troops. About 300 of them died in Stalingrad. Technical assistance to the Nazi army was provided by 4,500 Dutchmen. Up to 80,000 Dutch served in the German construction battalion. Holland supplied the most volunteers for the Reich. About 10 thousand Dutch people died in the battles.

All European countries helped Germany eliminate the constantly increasing shortage of its labor force due to the conscription of Germans into the army. 875.9 thousand workers were delivered from France to German factories, half a million from Belgium and Holland, 300 thousand from Norway, 70 thousand from Denmark. The army that invaded the territory of the USSR was provided with weapons and food by the **WHOLE** of **EUROPE**. The weapons that Germany captured in the defeated countries were enough to form 200 divisions. For comparison: the USSR had 170 divisions in the western districts. To provide them with weapons, the USSR needed several five-year plans. ***In France***, after its defeat, the Germans **IMMEDIATELY** received up to 5,000 tanks and armored personnel carriers, 3,000 aircraft, 5,000 locomotives. The French not only **HANDED** over all their tanks to the Germans, but also produced a huge amount of military equipment for them — from cars to optical rangefinders. In the summer of 1941, **EVERY FOURTH TANK** in the German army was Czech or French. The most powerful tank of the Wehrmacht during the attack on the USSR was the French B2. Half of the super-heavy guns that shelled Leningrad and Sevastopol were produced in France and the Czech Republic. By the beginning of the war with the USSR, 1.6 million people were employed in the French "defense industry", which worked for the Wehrmacht. According to incomplete German data, until January 1944, they supplied Germany with about 4,000 aircraft, about 10,000 aircraft engines, and 52,000 trucks. The entire locomotive industry and 95 percent of the machine tool industry worked only for Germany.

Belgium transferred half of its rolling stock to Germany for economic and war needs, etc.

The **Czech Republic** had 40% of the world arms market in those years. On 31 March, 1944, the Fuhrer received weapons and equipment worth almost 13 billion 866 million marks from the workshops of 857 factories in the Czech Republic. Only at the expense of Czechoslovakia, the German Air Force increased by 72%, receiving 1,582 aircraft. By June 1941, the German units were almost a third **EQUIPPED** with **CZECH WEAPONS**. The Czechs collected 25% of all tanks, 26 percent of trucks and 40 percent of small arms of the German army. Only one company, Skoda, produced more weapons than the entire pre-war Britain. From its factories, the Reich received over 6,600 tanks and self-propelled guns, more than one and a half million rifles and pistols, about 4,000 guns and mortars.

In 1944, the Czech Republic shipped 300,000 rifles, 3,000 different machine guns, 625,000 artillery shells, 100 self-propelled artillery pieces, tank cannons, Me-109 aircraft, aircraft engines, etc., to Germany every month. As a result, Hitler, at the expense of Czechoslovakia alone, was able to arm and equip 50 divisions. In addition, fascist Germany received a gold reserve (80 tons) of this country, as well as the people who worked meekly for the criminal Nazi regime all the years of the war.

Belgium and Holland supplied the Germans with coal, cast iron, iron, manganese, zinc, etc. The Poles built airplanes, in Auschwitz they produced explosives, synthetic gasoline and rubber for the "German" army, the Swedes mined ore and supplied the Germans with components for military equipment (for example, bearings), the Norwegians supplied the Nazis with seafood, the Danes — oil...

What was promised to all participants of the attack on the USSR? For example, Hitler had plans to colonize the USSR. So, 30,000 Dutch people were preparing to move to Ukraine. The first began arriving in 1942. How did it end? The Reichstag and the Reich Chancellery were defended by units of the SS division "Nordland" (citizens of Holland and Norway), they were joined by the French Fenet battalion from the Charlemagne division, the Latvian battalion of the 15th SS Grenadier Division. As early as the mid-1930s, the question of the organization of Europe after the war was raised in Germany. The ideologues of the NSDAP had formulated the position of the great space as a subject of international law, on the principle of a people's organization, united by one race of peoples. Hitler's **"25 points"** plan did **NOT SUCCEED**. But the plans for an attack by a united Europe on Russia remained the same: **1)** the primary striking force of aggression **BEFORE** there was an **IDEOLOGY** uniting Europe (then Catholicism, then the Napoleonic Code, then Hitler's "25 points"; **2)** behind the ideology there was a **theory of "exceptionalism" of European peoples;** **3)** then came the claims for living space and resources of "inferior peoples"; **4)** then the peoples who accepted an alien ideology, disappeared from European history and from its geographical map.

This is a sequence of "arising and unfolding" of the so-called (is)toric events and all of the above was exactly like that. But why is there such a clear chronology in what happened, coherence and validity in our understanding, when learning this information? Literary historians will continue to grind it in different ways. The truths that seem to us are justified by the depth of our knowledge of the world – not absolute truths, but only the truths of our world. For a deeper knowledge of the world with a different understanding of the laws of development of what is happening - they are not true and may even be absurd. It is necessary to treat the

realization and understanding of the above **NOT FROM** the **STANDPOINT** of the orthodox materialistic worldview, but from the standpoint of the already accomplished transition to the stage of knowledge of the truth - materialistic idealism. Such an approach in cognition allows us to show the true, but the most terrible thing for the current state of awareness is the material use of people outside their will and awareness of the very fact of their programmatic use in the past, as such. With such a process of insurmountable violence against people, the programs and plans of **EXTERNAL MANAGEMENT** were focused on their specific target milestones associated with achieving a certain controlled level of **DEVELOPMENT** of **BRAIN GENOTYPES**, a limited contingent of individuals. Since the life of people, in all its substance and essence as such, is a consistent result of the influence of controlling information, which, in turn, is a target contact controlling process with the substance of the state of Mind (including in today's time), it means that the stages of information development are the **STAGES** of the **DEVELOPMENT** of people's lives, with all the corresponding true embodiments of their being. The true reasons for the embodied expression of specific **STAGES** of the **DEVELOPMENT** of **CIVILIZATION** are only the ***stages of the development of brain genotypes***, as an externally controlled process implemented through Complexes and Objects. There was a strictly externally verified program of ***development of quite specific brain genotypes*** in 12 stages (it was presented as 12 generic tribes) for almost 18000 years. It was carefully concealed that humans also have a Mind, and it is represented by a specific Construct (!) which the Ebrov System⁶ tried to "deform" in various ways. Each separate deformation typology of the Mind Construct is a so-called Genotype of the Brain. The whole history, as a program of brain genotypes development, is the Main Law of History, not anything else. And ignorance of this is what leads to the kind of reasoning I have given in this article. The signs and facts, in simple terms, are stated correctly. They are carefully gathered and presented to readers in a strict sequence of what is going on. But this is the illusion with which the interventionist system has covered itself, implementing and embodying what is planned within a certain vector of purpose. Look at the part of the table ***"Creation and development of Brain genotypes"*** and much will become clear in the above described. I will give the whole table in the third article **(31-369)**, which is planned to be written on this very topic, which, in my opinion, clarifies all today's events unfolding in a strict sequence and certainty, which no one can change.
